Recognition of Durham County Receiving the Robert Wood Johnson Foundation's 2014 Culture of Health Prize

Chairman Page recognized Gayle Harris, Public Health Director, to discuss the award. Ms Harris noted that the award was reflective of the work done in the community. She gave a brief summary of how the Foundation made a visit to Durham and saw amazing things happening in the community.

There were over 250 applications, and Durham County was selected as one of six communities in the United States to receive the award.

Chairman Page joined a team from Public Health in New Jersey to officially accept the award of \$25,000 to further the work of the Partnership for a Healthy Durham. Durham County has also received national press coverage and web presence for its contribution to creating a culture of health.

The Board and audience viewed a professionally made video as a part of the award that highlighted Durham's successes.

Vice Chair Howerton requested Assistant County Manager Deborah Craig-Ray to follow up with the NC Association of County Commissioners to see if the video could be shown during the upcoming conference.

The Board commended Ms. Harris on her leadership; and they commended her staff for an outstanding job.

Chairman Page commented that he hoped everyone would embrace the initiative, and it would require elected leaders to be involved.

<u>Public Hearing to Consider Allocating Economic Development Investment Funds to Argos Therapeutics</u>

Ms. Marqueta Welton, Deputy County Manager, introduced the item. The Board was requested to consider allocating \$925,000.00 in economic development funds to Argos Therapeutics, (Argos), a private biopharmaceutical company headquartered in Durham. Argos is engaged in the research, development and commercialization of fully personalized immunotherapies for the treatment of cancer and infectious diseases based on its ArcelisTM technology platform. The company traces its roots to Duke University where company founders developed a unique RNA-based technology.

The Board initially approved an incentive in the amount of \$600,000.00 on February 10, 2014 for the company's proposed plans to invest \$47.25M in the construction of a new 116,000sf headquarters, research & development and manufacturing center. The company was considering the Durham site along with sites in four other North Carolina counties as well as sites in Florida and Quebec Canada. Argos has increased its planned capital investment by \$10.25M and now intends to invest approximately \$57.5M in the project.

As incentives are a key consideration in the company's decision of where it will locate the center, the Board was asked to increase the County's offer to \$925,000.00 to bring the project and new jobs to Durham. The project would bring a 120,000sf state of the art facility and 236 new jobs to the community by 2018 and allow Durham to retain 100 existing jobs. New jobs would include scientific and technical manufacturing jobs, as well as administrative, research and development jobs. The project would create construction jobs, as well as contract jobs for services such as security and maintenance.

Commissioner Foster asked for clarification on the job increase and what the County would be getting for the increased incentive. Ms. Welton clarified that the company had added 10 jobs since the last conversation with the Board. The Board was asked to increase the incentive due to the competition.

Ms. Welton stated that the company had selected a vacant site in the Research Triangle Park.

Chairman Page opened the public hearing.

Mr. Ted Conner, Vice President of the Greater Durham Chamber of Commerce, spoke in favor of Argos. He added that Durham would become the epicenter serving patients with renal cancer. He noted that Durham Technical Community College had added two new programs to help Durham residents prepare for the jobs that would be available at Argos.

Chairman Page closed the public hearing.

Commissioner Jacobs expressed her support for the incentive and was happy that Durham Technical Community College was a partner in helping prepare Durham residents for the jobs.

Commissioner Reckhow stressed that it was a great opportunity if "we prepared our citizens for the jobs." She spoke about the BRITE program at NCCU being a partner as well. Chairman Page concurred with Commissioner Reckhow's comments and expressed his support.

Vice Chair Howerton invited Mr. Randal Goller, Director of Facilities with Argos to speak. Mr. Goller thanked Durham for the support and commented on the excellent talent that had come out of the community within the past six years.

Commissioner Reckhow moved, seconded by Vice Chair Howerton to approve the incentive as recommended.

The motion carried unanimously.
