•Service hours are continuous. For schedules that require a lunch break, a one (1) hour lunch break is to be provided by the security company relief staff. Relief staff should be of the same officer type as scheduled. Standard post schedules over 40 hours per week to be covered by several Officers, as best determined by security company. Standard Post Schedules are never to be left unattended without clear justification and communication.

**Durham County has 10-11Holidays each year and Security Services are not required on these days, unless otherwise requested (Additional Security Service Request). This results in a S0 week/year.

***Exterior patrol locations. Security Contractor to determine patrol route and frequency.

****Schedule allows for a one (1) hour non-paid lunch break.
