Commissioner Reckhow shared the Triangle Transit 2014-15 Durham County Bus and Rail Investment Progress Report which outlined enhancements to bus service that had been made over the past year. The report indicated revenues and expenditures as well as next steps. She indicated the report was available on the Triangle Transit website and would also be available on the County's website.

Commissioner Jacobs announced that citizens were invited to the 10th annual City-County Martin Luther King Jr. Celebration on Wednesday, January 14th at noon First Presbyterian Church, 305 E Main Street.

5. Ceremonial Items

Proclamation – Mentoring Month

Chairman Page read the following proclamation:

WHEREAS, in 2002, the Harvard School of Public Health and MENTOR: the National Mentoring Partnership created National Mentoring Month; and

WHEREAS, the goals of National Mentoring Month are to raise awareness of mentoring, recruit individuals to mentor, and encourage organizations to engage and integrate quality in mentoring into their efforts; and

WHEREAS, a mentor is a caring, consistent presence who devotes time to a young person to help that young person discover personal strength and achieve their potential through a structured and trusting relationship; and

WHEREAS, quality mentoring encourages positive choices, promotes self-esteem, supports academic achievement and introduces young people to new ideas; and

WHEREAS, mentoring programs have shown to be effective in combating school violence and discipline problems, substance abuse, incarceration and truancy; and

WHEREAS, youth development experts agree that mentoring is critical to the social, emotional and cognitive development of youth, helping them navigate the path to adulthood more successfully; and

WHEREAS, mentors help young people set career goals and use their personal contacts to help young people meet industry professionals and find jobs.

NOW, THEREFORE, I, Michael D. Page, on behalf of the Board of County Commissioners, do hereby proclaim January 2015 in Durham County as

"MENTORING MONTH"

and call upon residents, public officials, business and community leaders, and educators to observe this month with ceremonies, activities and programs in order to recognize the men and women who serve as staff and volunteers at quality mentoring programs and who help our young people find inner strength and reach their full potential; acknowledge that mentoring is beneficial because it encourages educational achievement, reduces juvenile delinquency, improves life outcomes, and strengthens communities; promote the creation and expansion of quality mentoring programs across the country to equip young people with the tools needed to lead healthy and productive lives; and support initiatives to close the "mentoring gap."

7. Legislative Agenda

2015 Durham County Legislative Agenda

Ms. Deborah Craig-Ray, Assistant County Manager announced that she brought back the agenda with adjustments made as a result of comments made at the Worksession to the item regarding allowing medical providers in school based health centers to provide care within their scope of practice.

Items were added from the Durham Crime Cabinet regarding no further cuts in spending to the North Carolina Judiciary; seeking increased funding for Justice Reinvestment Act Initiatives at the Local Level; and raising the age of Juvenile Jurisdiction to 18.

An item was added as a request from the NC Senior Tar Heel Legislative priority regarding Home and Community Care Block Grant (HCCBG) funding so that the growing senior population could be allowed to age at home.

Other items were submitted by the Sheriff's Office to shorten the time of selling unclaimed livestock; increase the penalty for firearm related offenses; and brake light requirements.

Commissioner Jacobs inquired if the Association did not come out and support the Medicaid expansion, should the Board come out with legislative item independently. Ms. Craig-Ray responded that she

wasn't sure if the Association would support, but the Board could always take further action for support. Vice Chair Howerton added that there was a lot of conversation in the Association regarding the item.

Commissioner Reckhow asked whether the Board should add an item urging the Delegation to fully fund the economic development incentives program. Ms. Craig-Ray agreed to add the item to the agenda.

Commissioner Reckhow moved, seconded by Vice Chair Howerton to approve the Legislative Agenda as amended.

The motion carried unanimously.

Chairman Page reminded the Board of the Legislative Breakfast with the Durham Delegation on January 23.

Ms. Craig-Ray reminded the Board that she also prepared three Congressional items to go forward regarding immigration reform, funding of TANF, and transportation funding. The items would go to Association to be voted on and sent forward to NACo along with items from the other 99 counties.

Commissioner Reckhow suggested that the item regarding transportation might be strengthened by finding a bill to reference and support related to transportation of road and bridge funding. It should be a comprehensive balanced approach.

Commissioner Reckhow moved, seconded by Commissioner Jacobs that the Congressional Agenda be approved and moved forward.

The motion carried unanimously.
