The Board is requested to approve to recognize \$61,596 in revenue from two sources:

Governor's Crime Commission Grant: \$56,246 to provide gang prevention services in Durham County and Seattle City Auditor's Office contract: \$5,350 to provide consultation to a youth violence/gang prevention program in Seattle.

The grants are to provide gang intervention services to 170 youth between the ages of 10-17 during FY 2014-15 in Durham County. The contract with the Seattle City Auditor's Office is billable based upon consultant work performed for the City of Seattle's Youth Violence Prevention Initiative in the areas of developing an integrated client case management tracking and reporting system, and assisting with development of Memorandums of Understanding between

two participating agencies by Project BUILD's Director, Michelle Young.

The budget for these funds is attached.

ALIGNMENT WITH STRATEGIC PLAN: The grant funding and contract align with Goal One (Community and Family Prosperity and Enrichment) and Goal Three (Safe and Secure Community) by providing educational and social support for middle school youth who are at high risk of dropping out of school and involvement in criminal activity and gangs.

Request to Extend Lebanon Fire Insurance Rating District and Response District

Agenda Text:

The Board is requested to approve an extension of the Lebanon fire insurance rating district and response district.

The City of Durham Fire Department currently provides fire protection services in the Durham County East and West fire protection districts. These two fire insurance and response districts were created on February 27, 2006, when the Lebanon Volunteer Fire Department relocated to the Russell Road fire station. Since then, the Office of the State Fire Marshal has ruled that the City of Durham Fire Department cannot provide the district with certified protection, and has caused the property owners within the two districts to become an ISO Class 10 - Unrated Fire Protection District, which means no fire protection. The City of Durham Fire Department will still respond as the closest unit dispatch. This change will allow the citizens within the area to receive the insurance rating of an ISO Class 6 and a reduced insurance cost.

ALIGNMENT WITH STRATEGIC PLAN: Goal 3: Safe and Secure Community - Enhance capacity to respond to emergencies. Property owners, in the former Durham County East and West Fire Protection Districts of Durham County, will receive the fire services and insurance rating of Lebanon Volunteer Fire Department.

Budget Ordinance Amendment No. 15BCC000045 - Transition of Full-Time Parkwood Firefighters to Durham County Employees

Agenda Text:

The Board is requested to approve Budget Ordinance Amendment No. 15BCC000045 for the creation of 15 full-time Durham County fire suppression positions, to transition 15 full-time employees currently employed by Parkwood Volunteer Fire Department, as of March 16, 2015. An estimated cost of \$268,000 for salary and benefits will be transferred from the Parkwood Fire District Fund to fund these salaries.

In a letter dated October 29, 2014, the President of the Board of Directors at Parkwood Volunteer Fire Department requested the County of Durham absorb Parkwood's employees, assets of the corporation, and all fire operations for the Parkwood Service District by June 30, 2015. If authorized by the Board of County Commissioners the public will see no change in service on July 1, 2015, as a result of this change.

The Board is requested to approve the creation of 2 Assistant Chief positions, 6 Fire Captain positions, 6 Fire Driver positions, and 1 Firefighter position, to transition 15 full-time employees currently employed by Parkwood Volunteer Fire Department, as of March 16, 2015, and the transfer of \$268,000 from the Parkwood Fire District Fund to the County General Funds for salary and benefits of the 15 full-time employees.

Durham County, NC is in the early stages of implementing its new business model, Managing for Results. This approach uses best management practices in a systematic way so that the County can plan for what it wants to achieve, budget for the results it wants, manage to ensure it is achieving those results, and evaluate and learn to determine how it can make improvements for better outcomes.

In Fall 2014, under the direction of County Manager Wendell Davis and in consultation with more than 100 key County employees, Durham County developed a model and four-year timeline for Managing for Results. Martha Marshall will serve as a consultant to assist with completion of the FY14-15 practices, as listed in the MFR timeline.

Budget Ordinance Amendment No.15BCC000042 Appropriating \$197,205 of Debt Service Fund Balance and Transferring Those Funds to the General Fund (Engineering Department) and Approval of Professional Services for the Update to the Durham County Space Needs Analysis and Facility Master Plan

Agenda Text:

The Board is requested authorize Budget Ordinance Amendment to No15BCC000042 appropriating \$197,205.00 of Service Debt Fund fund balance and transferring those funds into the General Fund (Engineering Department), and to authorize the County Manager to enter into a contract with O'Brien/Atkins and Associates, P.A. (OBA) for professional services to provide an update to the Durham County Space Needs Analysis and Facility Master Plan in the amount of \$186,655.00 plus a reimbursable amount of \$10,550.00 thus totaling a not to exceed budget of \$197,205.00 (See Attachment 1, Pages 1-6)

The request for qualifications (RFQ) process for hiring an architect for the Durham County Space Needs Analysis and Facility Master Plan was completed in early 1999 with O'Brien/Atkins and Associates, P.A. being selected as the most qualified firm for the project. On March 22, 1999, the BOCC approved the execution of a contract with OBA in the amount of \$148,750.00 for the Durham County Space Needs Analysis and Facility Master Plan. The previous contract has expired and resulted in a Space Needs Analysis and Facility Master Plan that was completed in March 2000 and amended in March 2003. The Plan served Durham County in two ways: 1) As a basic guide to elected officials and administrators in all decisions relating to the need for and the provision of building space. 2) As a comprehensive Facility Master Plan that could be updated to meet changing conditions. The structure of the Facility Master Plan was previously organized based on three components:

- An evaluation of the existing facility configuration
- A space needs forecast

• A building program/action plan

The existing Master Plan requires updating in order to address the current and projected operational requirements of the County. Many of the services provided by the County coincide directly to resident population composition and distribution. Other factors including legislatively mandated services, changes in technology, economic development and etc. also have a direct impact on County space needs. This update will provide Durham County a 10 and 20 year look ahead at space needs requirements for service delivery, parking, storage, vehicle storage and etc. This plan will piggyback on the Youth Home Study, the previous programming efforts for the Detention Center and currently for the Judicial Building Renovation and the Long Range Space Planning and Analysis for Durham County's EMS Facilities. This process will also allow Durham County to make informed decisions about the future use of DSS Main Street and other County owned facilities. The departments to be included in this effort and a comprehensive list of the scope of work has been outlined in the proposal (See Attachment 1, Pages 2-6).

In review of the M/WBE participation, O'Brien/Atkins will be utilizing The Harris Collaborative on the project proposing 10.44% M/WBE participation on this project. The Harris Collaborative is an African American/Women-owned business.

It is recommended that the County proceed with all work described in the proposal dated December 10, 2014 for \$197,205.00. Funding for the Update to the Space Needs Analysis and Facility Master Plan is available in the Debt Service Fund from available fund balance.

ICMA has established the Local Government Management Fellowship Program to connect individuals interested in a career in local government management with host local government(s) for a period of one year. The local government(s) gives the Fellow relevant work experience and ICMA facilitates professional development opportunities for the Fellow and provides a network for all Fellows to connect and learn from each other.

The County of Durham and the City of Durham are working together to give an ICMA Fellow the opportunity to work in city and county government on a number of projects during the year. The position is a County position but will be paid on a 50/50 basis from both the County and the City. <u>15-274</u> Manhole Inspection Services Contract, RFP15-002

Agenda Text:

The Board is requested to authorize the County Manager to enter into a standard service contract in the amount of \$78,750.00 with Hydrostructures, PA for Manhole Inspection Services for the Triangle Wastewater Treatment Plant sewer collection system. Approximately 2,250 sewer manholes within the county's collection system will be inspected, assessed, photographed and labeled. This information is used to determine how to prioritize sewers for rehabilitation. The initial term of the contract is from March 31, 2015 through June 30, 2016; with the option to renew by the County for four (4) successive one (1) year periods, under the same terms and conditions.

On November 7, 2014, Durham County issued a Request for Proposal (RFP The RFP was mailed to interested vendors, advertised in local 15-002). newspapers, and published on the Durham County website. Eight (8) proposals were received on December 11, 2014. The proposal review team determined that the Hydrostructures, PA proposal offered the best value and met the In review of the M/WBE participation for this project, proposal requirements. African American participation participation goals for were Hydrostructures, PA will has entered into an agreement with Bree & Associates, an African American owned business, to subcontract 7.20 percent of the work.

Agenda Text:

The Board is requested to approve the Department of Social Services request to recognize additional revenue subsequent to adoption of the FY2014-2015 Budget. The revenue represents funding changes in:

Duke Energy Progress - Energy Neighbor Fund: The Energy Neighbor Fund is an assistance program for low-income customers in a heating or cooling related crisis. One hundred percent of funds collected from customers and employees go directly to customers in need. Allocations are made only to counties that have Duke Energy residential customers. The department recognizes \$749 which is the difference between the current budget and the allocation. Attached is a copy of the funding authorization.

Child Care:

1. Counties initially receive a projected child care subsidy allocation amount for the next State Fiscal Year in their annual budget estimates in February. DCDEE later issues a funding authorization to each county for funds allocated. The county may find that the allocation figure on the funding authorization is different from the projected amount issued in February. The Department has received a child care funding authorization for Non Smart Start Direct Services (provider payments) and the allocation is \$14,938,837.

The Department recognizes \$845,021 which is the difference between the adopted budget and the allocation for direct services. Funds will be expended in compliance with all state laws, rules, policies and procedures. Attached is a copy of the funding authorization.

2. The Department has received a child care funding authorization for Title IV-E Non Smart Start Direct Services (provider payments) and the allocation is \$55,452. The department recognizes \$55,452. Attached is a copy of the funding authorizations. Funds will be expended in compliance with all state laws, rules, policies and procedures. Attached is a copy of the funding authorization.

The total direct services allocation is \$14,994,289.

Family Reunification - The primary goal of family reunifications services are to support families in eliminating the conditions which led to the child's removal and to build protective factors that enable the parent(s) to safely parent the child in their own home. The department recognizes \$4,746 which is the difference between the current budget and the allocation. Attached is a copy of the funding authorization.

The Board is requested to authorize the transfer of \$101,000.00 in program funding to Made in Durham to support its youth initiative program.

Made in Durham is a public-private partnership committed to ensuring all Durham youth and young adults complete a postsecondary credential and begin a rewarding career by the age of 25. Partners are committed to helping youth and young adults, ages 14-24 navigate through education and into work - an education-to-career system.

Working with community partners, Made in Durham intends to create a system where every young person:

- Completes a high school degree or equivalency
- Engages in work experiences that will prepare them for a career
- Enters postsecondary education and completes a credential
- Secures living-wage work

On May 21, 2014, Made in Durham requested support of its program during a joint meeting of the Durham City Council, Durham Public Schools Board of Education and the Board of County Commissioners. On February 2, 2015, Made in Durham provided an update to the BOCC on activities and progress since its May 21st presentation. The BOCC appropriated \$101,000.00 in funding for this program when it approved the FY14-15 budget.

The Board is requested to consider authorizing the County Manager to execute the PPP Agreement related to the redevelopment of Whitted School. presented to the Board a PPP Agreement for Whitted School, to be executed by the County, the Durham Public Schools Board of Education and Integral Development LLC (the "PPP Agreement"). The PPP Agreement sets out the broad framework of the agreements among the key parties to the redevelopment of Whitted School, including the following: formation of legal entity and expected control of that entity over time; funding sources for construction, process of and control over construction; allocation of space and operating responsibility between the Public Pre School and the senior affordable housing; use of state historic tax credit funds should that law be reinstated; funding for operation of Public Pre-School; use of the gymnasium; requirement for use of local contractors whenever possible; community engagement. The actual, definitive legal arrangements involved will be drafted based on the principles agreed to in the PPP Agreement, subject to the final terms of the construction agreement and requirements of the tax credit investor, which will affect the terms of the partnership agreement and payment of development fees, among others.

The Board of Commissioner reviewed the agreement during its March 2, 2015 Worksession.
