MEETING NOTESFROM THE 5/21/15 PRE-BID MEETING HELD AT DURHAM COUNTY ADMIN BUILDING. 4TH FLOOR

ATTENDEES

- Hilda reviewed the procedure for bidding, noting that proposals are due at 2 pm on June 11 at the Durham County Office. She also noted item #20 that lists all forms which must be completed and returned with the bid.
- Craig outlined the scope of work.
- During the bid process, all questions are to go through Durham County Purchasing so the answers get distributed to all bid plan holders.
- During the construction process, all questions are to go through Craig Morgan, Project Manager with CJT.
- Brenda and Hilda outlined a basic schedule. After the bids are received on June 11, Durham Purchasing will compile the bid list. CJT will approve the final bid list and certify the bid tabulation. Then Durham County will work to get a contract put together. This will not need to go through the Board of County Commissioners. It is expected that construction could begin mid summer.

Responses to questions that arose at the meeting:

- Access to the site is only off Picket Road (at the existing gravel area and at the existing gate) or the temporary entry off Erwin Road. (CJT is obtaining the temporary access permit from NC DOT). There is no access from the residential areas to the north or east.

- Tree removal is not intended at the site, but there will be some small trees that may need to be removed for access. Trees under 2" may be removed as needed. If the contractor feels that larger trees are in the way, he needs to call Brendan and Wendi and they will jointly make a determination on whether the tree should be removed or the installation item re-located slightly. Any tree removal shall involve the tree being sawed off at the ground, and the roots remaining in place.
- Rock removal is not intended or anticipated. Borings have not been done at the bridge sites. If there is rock in the way, the contractor shall consult with Brendan and Craig to determine if the installation can be slightly shifted.
- Concrete footings it is anticipated that any concrete needed on site would be bag-mix in place.
- Existing condition mapping is a mix of survey and gis. The project areas have been surveyed including topo, stream and buffer locations, large trees. Information for the remainder of the site is from Durham GIS.
- Jane, Brenda, Wendi and Adam toured site. Wendi painted the ground in the approximate bridge locations. Wendi flagged the gate location on Pickett Road. Wendi also flagged the area on Erwin Road where access into the woods will occur off the temporary driveway access. It should be noted that local users of the park have been removing flagging and it will not necessarily be in place during the bid process.
