Opening of Regular Session:

Chairman Page opened the meeting and stated the Board was requested to adjourn to Closed Session to consider the qualifications, competence, performance, character, fitness, conditions of appointment, or conditions of initial employment of an individual public officer or employee or prospective public officer or employee, pursuant to G.S. § 143-318.11(a)(6).

Vice Chair Howerton moved, seconded by Commissioner Jacobs to adjourn to Closed Session.

7:00 pm Regular Session

Chairman Page announced that the Board met in Closed Session and would reconvene in Closed Session following the Regular Session meeting.

Chairman Page noted there were no agenda adjustments.

She also mentioned the "Stepping up Initiative" that was going on nationwide regarding mental health in the jail. Lastly, Commissioner Jacobs encouraged all citizens to sign up for the Community Reads program through www.spirithouse-nc.org. She stated the book being read was "Urban Alchemy Restoring Joy in America Cities."
- 6. Vice Chair Howerton announced that there were over 3,000 commissioners from across the country at the NACo Annual Conference held in Charlotte, NC. She noted that mental health was a serious conversation amongst all commissioners and stated that she would pass other items to Wendell Davis, County Manager so that he can review those initiatives and possibly consider undertaking a few for the County.

Items Pulled From Consent Agenda:

15-531 Six Parking Lots Restorations located at the Agricultural Building, Criminal Justice Resource Center, and The Milton Rd. EMS #6. County Animal Shelter, East Main Street & Liberty Street

Commissioner Reckhow stated there were two issues with the bidding process. She mentioned she read the background materials and questioned why there was only one bid. Shawn Swiatocha, Assistant Director of General Services responded there was only one response received from the advertisement. Motiryo Keambiroiro, Director of General Services stated the bid was advertised with Purchasing, local newspapers and select companies. Ms. Keambiroiro continued that a total of 13 companies received the information with only one proposal being offered.

<u>Directive: Commissioner Reckhow asked staff to revisit the bidding procedures and look at the issue of only one firm being pulled in on the job.</u>

Commissioner Reckhow also stated there was a proviso that was missing from the item present. She referenced the following:

"COMPLIANCE WITH LAWS: Contractor represents that it is in compliance with all Federal, State and local laws, regulations or orders, as amended or supplemented. The implementation of this Contract shall be carried out in strict compliance with all Federal, State, or local laws."

Commissioner Reckhow moved, seconded by Vice Chair Howerton to move forward with the contract with the addition of the compliance clause.

The motion carried unanimously

Commissioner Foster asked Wendell Davis, County Manager if in his professional opinion that it would come back to the Board that only one person came forward with a bid on the project. He also asked if the County Manager would ensure the County was in compliance with the contract laws with regards to the bidding process. County Manager Davis responded that he would revisit the issue with the Finance department.

Commissioner Jacobs asked if there was any minority participation with the contract. Ms. Keambiroiro responded there was no minority participation in the contract. Commissioner Jacobs inquired about the

length of time the contract was advertised for. Ms. Keambiroiro responded there was a minimum of 30 days. Commissioner Jacobs asked was the advertisement extended. Ms. Keambiroiro responded the bid could have been rejected but that was not the recommendation. She added majority of the construction contracts were advertised for 30 days for representatives to propose on the bids. Commissioner Jacobs also encouraged the County Manager and staff to review the process.

Reconvene to Closed Session:

The Board reconvened to Closed Session.

Reconvene to Open Session:

Chairman Page announced that the Board met in Closed Session to evaluate the performance of the following appoint and elected officials – the County Attorney, County Clerk, Tax Administrator, and Register of Deeds. The following motions were made as a result of Closed Session:

Commissioner Reckhow moved, seconded by Vice Chair Howerton to give all of the above named officials a 3% increase effective July 1, 2015.

The motion carried unanimously.
