

The STARR Program 2016 Admission Criteria and Schedule

Thank you for your support of the Substance Treatment And Recidivism Reduction (STARR) program. The Criminal Justice Resource Center (CJRC) in conjunction with the Durham County Office of the Sheriff will continue the STARR tradition of providing Substance Use Disorder treatment services to the criminal offender in the Durham County Detention Facility.

The STARR program accepts court-mandated and volunteer men and women inmates into treatment for four weeks (STARR). Upon completion of STARR, an additional four-week program (STARR GRAD) is available. STARR appreciates your commitment to the program and the STARR and GRAD participants.

- ★ STARR has one orientation on the start date of each month. Once the STARR orientation has begun, admission for the month is closed and no one else will be permitted to enter. All court orders and volunteer applications must be received by STARR by the end of the day on the Friday prior to the orientation start date. The back of this page contains the 2016 schedule of the STARR admission and graduation dates.
- ★ Admission to STARR is limited to a maximum of forty (40) participants.
- ★ The STARR Program cannot accept clients who do not fluently speak and understand conversational English.
- ★ Admission to STARR and GRAD will be prioritized based on release dates and need for treatment regardless of court order or volunteer status. Clients who are serving an active sentence and are court ordered to complete STARR prior to release will receive priority screening for admission. The names of volunteers and court ordered clients who are not admitted due to class size limitations will be placed on a waiting list to attend future STARR & GRAD classes.
- ★ Persons with serious/violent charges or bonds over \$50,000 will require a court order that will allow them the opportunity to be considered for STARR and GRAD. Please fax a copy of any court orders directly to STARR @ (919) 560-0819. The fax copy will secure their place in STARR while waiting for the official court order to arrive at the jail. We recommend that any court orders stipulate STARR and STARR GRAD to avoid additional orders being needed upon completion of STARR. A pretrial court order only allows the inmate the opportunity to attend STARR and STARR GRAD. No Felony CRV Inmates will be admitted per Sheriff's Department Policy.
- ★ The GRAD class accepts a maximum of fifteen (15) male and female participants. Admission to GRAD is determined based on successful completion of STARR, release dates, as well as the client's participation and behavior while in STARR regardless of any court order.
