Recognition of Retiring Chief Deputy C. Wes Crabtree

Sheriff Worth Hill presented Chief Deputy Crabtree with a special framed poem called "The Badge". Sheriff Hill read the poem as follows:

WHEREAS, he earned honors as the 2005 Bahama Ruritan of the Year and the 2006 North Carolina Law Enforcement Officer of the Year; and

WHEREAS, during his remarkable career, Chief Crabtree provided strong leadership and innovation in law enforcement as a decorated member of organization:

<u>Proclamation of September as Alcohol and Drug Addiction Recovery Month in Durham County</u>

PROCLAMATION

WHEREAS, treatment and long-term recovery from substance use disorders can offer a renewed outlook on life for those who are addicted and their family members; and

WHEREAS, substance use disorders impact 22.6 million people aged 12 or older in the United States (or 9.2 percent of the population), which is more than the number of people living with coronary heart disease, cancer, or Alzheimer's Disease combined; and

WHEREAS, people who receive treatment for substance use disorders can lead more productive and fulfilling lives, personally and professionally; and

WHEREAS, studies have consistently found that individualized treatment is essential for people to be successful in their path of recovery; and

WHEREAS, real stories of long-term recovery can inspire others to ask for help and improve their own lives, the lives of their families, and the entire community; and

WHEREAS, it is critical that we educate our community members that substance use disorders are treatable yet serious healthcare problems, and by treating them like other chronic diseases, we can improve the quality of life for the entire community; and

WHEREAS, working together to help achieve this goal are the U.S. Department of Health and Human Services, the Substance Abuse and Mental Health Services Administration, the White House Office of National Drug Control Policy, The Durham Center, and the Partnership for a Healthy Durham:

NOW, THEREFORE, BE IT RESOLVED that I, Ellen W. Reckhow, Chairman of the Durham County Board of Commissioners, do hereby proclaim the month of September 2008 as

ALCOHOL AND DRUG ADDICTION RECOVERY MONTH

Public Hearing on the Concept of Animal Tethering

Michael Turner, Director of General Services, recapped that at the Board of County Commissioners' August 4, 2008 Worksession, Amanda Arrington, Chairman of the Durham County Animal Control Advisory Committee (ACAC), recommended revisions to the current Animal Control Ordinance concerning animal tethering restrictions.

Ms. Arrington stated that the ACAC recommends the following changes to the ordinance: a definition for animal tethering, minimum fencing requirements, tethering exceptions and attended tethering that does not cause unjustified pain and suffering to animals. The final draft of the proposed amendment will be subject to review and revision by the County Attorney's Office.

Vice-Chairman Page thanked Ms. Arrington and the ACAC for their hard work. He opened the public hearing that was properly advertised. Due to the large number of speakers, Vice-Chairman Page asked that citizens limit their comments to two minutes. He noted that citizens have the option to yield his/her time to another speaker.

Vice-Chairman Page thanked the speakers for their comments. He closed the public hearing and referred the matter back to the Board.

Commissioner Heron suggested that citizen comments be submitted to the ACAC for consideration; the ACAC would then present final amendments to the Board in late September or early October.

In response to a question posed by Vice-Chairman Page, County Manager Mike Ruffin explained that the proposed ordinance changes are scheduled to be discussed at the September 2 Worksession. If the Board chooses to move forward with the amendment, then the Board may do so at any time after its review.

Commissioner Cousin concurred with Commissioner Heron's suggestion.

Ms. Arrington stated that the ACAC amended the Ordinance per Commissioner Cheek's suggestions at the August 4 Worksession. The ACAC would make its final recommendations to the Board at the September 2 Worksession.

Vice-Chairman Page inquired about the revised language in the Ordinance.

County Manager Ruffin stated that subsequent to the September 2 discussion, the Board may opt to vote on the proposed amendment at either the October 8 or October 22 Regular Session.

County Attorney Chuck Kitchen clarified for Commissioner Heron that the ACAC will present its recommendation to the Board on September 2. Once the Board reviews the recommendation, it may then decide what course of action to take.

County Manager Ruffin informed Commissioner Heron that citizens comments from tonight's meeting may be accessed via the archived video on the County's website. He stated that he would email links to the video to Chairman Reckhow and Commissioner Cheek.

<u>Public Hearing on Coordinated Transportation: FY 2008-2009 Rural Operating Assistance Program (ROAP) Grant—Application Approval</u>

Johnny Ford, Transportation Access Coordinator stated that the Cooperative Extension Service is requesting Board approval of the Rural Operating Assistance Program (ROAP) grant to be submitted to the North Carolina Department of Transportation (NCDOT). The ROAP grant consolidates the Elderly and Disabled Transportation Assistance Program (EDTAP), Rural General Public Program (RGP) and the Work First/Employment Program into a single application package. EDTAP provides for assistance in the transportation of the elderly and disabled. Work First/Employment Program is intended to provide operating assistance for transitional Work First. The Rural General Public funds will be used to supplement existing routes that currently serve the county.

In June 2008, letters were sent to over 30 human service and non-profit agencies requesting input into the application. A Public Hearing Notice was published in <u>The Herald-Sun</u> in July 2008. Letters were translated into Spanish and sent to the Latino and other limited English proficiency communities.

The application proposes \$95,653 of governmental revenue to be allocated to Support Coordinated Transportation for Durham County Elderly and Disabled residents, through the Elderly and Disabled Transportation Assistance Program (EDTAP), and \$11,065 for Work First Transitional/Employment. These funds require no local match. The \$95,245 represents an increase of \$408 from last year's allocation.

The \$43,508 allocated for Rural General Public Transportation (RGP) requires a 10% local match. The majority of the local match is recouped through fares and the remaining match has been budgeted. These programs help support the transportation needs of citizens residing in the County. The program is administered by Cooperative Extension Coordinated Transportation.

The NCDOT annually allocates funds for EDTAP, RGP, and Work First. Durham County will receive \$150,226 for FY 2008-2009.

EDTAP Funds shall be used to provide services for the noted agencies:

Council of Senior Citizens
Dept. of Social Services (Adult)
Durham Exchange Club Industries
Retired and Senior Volunteer Program
Services for the Blind
Durham Parks and Recreation
The ARC of Durham

Additionally Durham County is applying for the maximum amount of supplemental ROAP funding from NCDOT.

EDTAP \$56,162
Work First \$8,851
RGP \$22,818

The \$22,818 for Rural General Public Transportation (RGP) requires a 10% local match. The majority of the local match is recouped through fares, and the remaining match has been budgeted. These funds will be used for expanded service.

Durham County is applying for a total of \$87,831 in supplemental ROAP funds for FY 2008-2009.

Commissioner Heron inquired about travel costs for Durham County vs. Orange County.

Mr. Ford responded that he cannot provide a cost comparison; however, Durham County operates in urban and rural areas while Orange County only operates in rural areas. He noted that previous number errors have been corrected.
