# 16-886 Recognition of Budget and Management Services for Receiving the GFOA Distinguished Budget Presentation Award for the FY 2015-16 Budget

He continued to say that the submitted budget documents satisfied nationally recognized guidelines for an effective presentation.

## 16-937 Proclaim March 20, 2016 as "42nd Durham Crop Hunger Walk Day"

Chairman Page read the following proclamation:

#### **DURHAM CROP HUNGER WALK DAY | 2016**

**WHEREAS**, at the end of World War II many people wanted to share our country's abundance with European war victims; and CROP's first purpose was to gather wheat and other crops from U.S. farms for shipment to Europe; and

**WHEREAS**, today, the Durham CROP Hunger Walk is an important part of community life, bringing together people of different faiths, diverse cultures, and all age groups to provide local and international hunger aid; and

**WHEREAS**, in the last 41 years, Durham CROP Hunger Walks have raised over \$3.97M to help and bring hope to hungry people in need around the world and in the U.S.; and

WHEREAS, each year, Durham CROP Hunger Walk helps local agencies such as Meals on Wheels, Urban Ministries, Housing for New Hope, Double Bucks for SNAP, Threshold Clubhouse, Food Bank of Central and Eastern North Carolina, Families Moving Forward, PYO, St. Andrew's Society and church food pantries who provide food to neighbors in need; and

WHEREAS, the Durham CROP Hunger Walk raised \$154,540 last year; and

**WHEREAS**, the Durham CROP Hunger Walk is working to raise enough money to be able to support two additional local agencies this year; and

**WHEREAS**, the Durham CROP Hunger Walk is the oldest fund-raising walk in NC, and will hold its 42nd Annual CROP Hunger Walk on Sunday, March 20th; and

**WHEREAS**, the Durham CROP Hunger Walk helps the community to become aware of and concerned about hunger and its causes; and

**WHEREAS**, the Durham CROP Hunger Walk is the 3rd largest CROP Walk in the nation, out of more 1300 walks, demonstrating the tremendous compassion and altruism of Durham's citizens; and

WHEREAS, Durham CROP Hunger Walk will raise funds to help stop hunger both locally and globally.

#### **Public Hearings**

#### 16-914 Public Hearing - Historic Properties Local Review Criteria Consolidation and Update

Lisa Miller, Senior Planner provided a brief summary to the Board. She stated that there were 80 historic landmarks; none of which were in County historic districts. Ms. Miller continued to say that the action taken by the Board would apply to the two designated County historic landmarks and any future County landmark designations.

Commissioner Jacobs inquired about the (2) two Kent properties. Ms. Miller responded the (2) two Kent properties were the Tilley Farm and Hardscrabble, both located in North Durham. Commissioner Jacobs asked if they already had landmark status. Ms. Miller confirmed. Commissioner Jacobs inquired about the number of properties that fell under the County and which properties were potentially in the County. Ms. Miller stated it was a number of years since the last update of the County structures. Commissioner Jacobs asked if the information was available on the website. Ms. Miller responded it was not available on the website; it was only available by request in the department. Commissioner Jacobs inquired about the guidelines on demolitions. Ms. Miller responded demolitions were currently a topic of conversation.

Commissioner Reckhow stated in terms of public information, the report would be a useful. She continued to say that a link should be placed on the County website. Ms. Miller responded a link was located on the City's website and could also be placed on the County's site as well.

Chairman Page opened the public hearing. No one was signed up to speak. Chairman Page closed the public hearing.

Chairman Page asked the pleasure of the Board.

Commissioner Jacobs clarified for the public that there would be a (6) six month grace period on the enforcement of the fines.

Commissioner Reckhow thanked Ms. Silver and Eloise Johnson for their hard work in advocating for the ordinance. She stated this effort showed the power of the citizens in Durham County identifying the problem, creating solutions and promoting the issue to get the attention of County leaders. Commissioner Reckhow stated she hoped staff would create an education program as well as take advantage of the support offered by the State.
