Proclamation - Durham Literacy Center

Chairman Page read the following proclamation:

DURHAM LITERACY CENTER | 2016

WHEREAS, The Durham Literacy Center, of Durham, North Carolina, was founded 30 years ago by concerned residents of Durham who believed strongly that the ability to communicate verbally, and to read and write were basic human rights; and

WHEREAS, The Durham Literacy Center was established to provide basic English literacy services to Durham adults, immigrants and out-of-school youth who desired to improve their literacy skills; and

WHEREAS, The Durham Literacy Center, since 1985, has served over 16,000 Durham residents and trained over 2,500 volunteer tutors; and

WHEREAS, The Durham Literacy Center through a universal call for social justice and understanding between people of different cultures and nationalities has stressed that we care for our neighbors; and

WHEREAS, The Durham Literacy Center exemplifies the American dream in that citizens can bring positive change and solve problems communally when we work together; and

WHEREAS, The Durham Literacy Center, helps adults and out-of-school youth to gain the reading and writing skills, English language skills, computer skills, educational credentials and job readiness skills that are needed to achieve economic security, stable housing, food security, adequate healthcare, and general well-being; and

WHEREAS, The Durham Literacy Center has been an integral part of this community for three decades, resulting in millions of dollars of increased income, increased tax revenue, a more productive community; and

WHEREAS, Durham Literacy Center will continue to serve as a leader in literacy in North Carolina for years to come.

NOW, THEREFORE I, Michael D. Page, Chairman of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby proclaim September 29, 2016 as

Commissioner Reckhow stated the County received \$660,000.00 to fund four (4) conservation easements on four (4) farms. She added this funding would leverage the local contributions. Commissioner Reckhow thanked Jane Korest, Open Space/Real Estate Manager for her continued work. She also noted that with the four (4) easements, that would total 2,342 acres of preserved farmland in Durham County.

Commissioner Jacobs stated it was important for the public to know that there was a certain amount of funding for open space. She continued to say because money was available from the County for the match, the grants were approved. Commissioner Jacobs acknowledged Ms. Korest and her staff for their hard work and for also making the land protection available for farmers and their families.

Commissioner Reckhow stated she was in agreement with the Policy 7.1.5d change. She added that she would be interested in referring the current policy and the proposed language to the Environmental Affairs Board (EAB) for input. Ms. Woods responded that she was the Staff Liaison for the EAB and she would be happy to make that suggestion to the Chair.

Vice Chair Howerton inquired about the result from the study conducted on Policy 2.5.3a – Study of Industrial Land. Ms. Woods stated there were a number of criteria established in the report for determining the marketability for industrial land. She added it was found a small amount of land designated for industrial use met all the criteria but was not considered. Ms. Woods stated that she would be willing to provide a copy of the report to the Board.

Commissioner Jacobs stated the report showed the number of re-zonings and amendments and also the work completed showed where all the growth was occurring in Durham. She asked about the comments from the Planning Commission and questioned whether a closer look at Storm Water Management should occur and suggested this item be placed on a future Joint City-County Planning Committee meeting agenda. Commissioner Jacobs also mentioned that there was not a lot of participation from County departments in the "Comp Plan" highlights. She mentioned to County Manager Davis that she would like to see EAR reports with more reflection from the County.

Chairman Page opened the public hearing. No one was signed up to speak. Chairman Page closed the public hearing and entertained a motion from the Board.

Commissioner Reckhow moved, seconded by Commissioner Jacobs to approve the 2015 Evaluation and Assessment Report of the Durham Comprehensive Plan with the exception of Policy 7.1.5d – Green Building Program.
