Agenda Adjustments

Chair Jacobs announced there were no adjustments to the agenda.

Announcements

Chair Jacobs read the following announcements:

- 2) Durham County real and personal property tax bills for fiscal year 2017-2018 have been mailed to Durham County property owners. Taxes are due September 1, 2017 and must be paid by January 5, 2018 to avoid interest and additional collection costs. Citizens who own real estate in the unincorporated areas of Durham will also find their solid waste decal stickers affixed to the bill.

This year's bill includes information for citizens wanting to establish scheduled payments to ensure that taxes are paid in full before the delinquent date of January 5, 2018. Minutes

Commissioner Reckhow moved, seconded by Commissioner Howerton to approve the August 7, 2017 Worksession minutes.

The motion carried unanimously.

Commissioner Reckhow noted that there were several directives that still needed to be addressed from previous meetings.

Ceremonial Items

Proclamation - "National Recovery Month September 2017"

Chair Jacobs read the following proclamation:

NATIONAL RECOVERY MONTH | SEPTEMBER 2017

WHEREAS, behavioral health is now recognized as an essential part of one's overall health and wellbeing; and

WHEREAS, the costs of not encouraging mental health and substance use recovery is significant for individuals, families, neighborhoods and the community at large; and

WHEREAS, people in recovery strive to achieve healthy lifestyles, stable homes, meaningful daily activities, stronger neighborhoods and contribute in positive ways to the larger community; and

WHEREAS, the American Society for Addiction Medicine (ASAM) reports that drug overdose is now the leading cause of accidental death in the US, with 52,404 lethal drug overdoses in 2015. Opioid addiction is driving this epidemic, with 20,101 overdose deaths related to prescription pain relievers, and 12,990 overdose deaths related to heroin. Four in five new heroin users report that they started out misusing prescription painkillers; and

WHEREAS, SAMHSA reports that in 2015 43.8 million adults experienced mental illness and only 14.6% received mental health treatment; and another 22.7 million adults were in need of substance use treatment while only 10% received treatment. That, given these statistics, we must strive to reduce the stigma, shame and embarrassment associated with brain disorders and help individuals, families and the larger community learn to view them as we would any other medical condition; and

WHEREAS, to help more people achieve and sustain long-term recovery, the U.S. Department of Health and Human Services (HHS), the Substance Abuse and Mental Health Services Administration (SAMHSA), the White House Office of National Drug Control Policy (ONDCP) and the Recovery Community Of Durham (RCOD) invite all residents of Durham County, North Carolina to participate in National Recovery Month; and

NOW, THEREFORE, I, Wendy Jacobs, Chair of the Durham Board of County Commissioners, and on behalf of the Durham Board of County Commissioners, do hereby proclaim the month of September 2017 as

NATIONAL RECOVERY MONTH

and call upon the people of Durham County to observe this month with appropriate programs, activities, and ceremonies to support this year's recovery theme:

Randy Tucker, Board Member of Recovery Community of Durham, shared his recovery story and explained the purpose of the agency.

Robert Thomas, Chairman of Recovery Community of Durham, thanked the Board for its consistent support and invited the community to the free celebration on September 30, 2017 from 2pm-6pm at Durham Central Park. He stated there would be recovery speakers, musical acts, information on healthy eating and children activities available for everyone to enjoy.

Chair Jacobs thanked Mr. Tucker for sharing his story and Mr. Thomas for sponsoring the event.

Commissioner Howerton asked if information would be shared at the upcoming meeting about the "Opioid in a Box." Chair Jacobs responded that a conversation took place with Gayle Harris, General Manager, to plan a summit. Commissioner Howerton asked to be included in the conversation.

Proclamation - Together for Resilient Youth's Plan for Zero Initiative

Vice Chair Hill read the following proclamation:

TOGETHER FOR RESILIENT YOUTH'S PLAN FOR ZERO INITIATIVE | 2017

WHEREAS, 28% of high school students reported feelings of depression in the past year (feeling so sad or hopeless almost every day for 2 weeks or more in a row that they stopped doing usual activities).

WHEREAS, 14% of high school students made a plan to attempt suicide

WHEREAS, 65% of high school students have seen other students being bullied

WHEREAS, 16% of high school students have carried a weapon (gun, knife, club) to school in the past 30 days

WHEREAS, 25% of high school students had one or more drinks of alcohol in the past month

WHEREAS, 9% of high school students smoked cigarettes in the past month

WHEREAS, 24% of high school students used electronic vapor product use

WHEREAS, 22% of high school students smoked Marijuana in the Past Month

WHEREAS, 15% of high school students have taken a prescription drug without a prescription in the past month

WHEREAS, 41% high school students (41%) use the computer for entertainment for more than 3 hours on an average school day.

NOW, THEREFORE, BE IT RESOLVED I, Wendy Jacobs, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby recognize August 28, 2017 as

<u>Durham County Information Services and Technology named "2017 Digital Counties Survey Winner"</u>

Chair Jacobs recognized the Information Services and Technology (IS&T) department for being the recipient of the 15th Annual Digital Counties Survey Award given by the National Association of Counties (NACo). She added this was the second time Durham County was recognized in the 250,000-499,999 population category as a leading digital county that encouraged government innovation and collaboration. Chair Jacobs expressed how proud she was of the department and their project.

Greg Marrow, Director of IS&T, thanked the Board for acknowledging the award. He stated the County had a great team of Information Technology employees that responded well to the many requests from all departments. Mr. Marrow also highlighted a few upcoming projects that involved collaborating with the City of Durham.

Gayle Harris, General Manager, responded there was a loss of state funds which would result in a reduction of trainings. She added there was still a significant budget available where funds could be used as needed.
