#### Introductory matters

Chairman Brian called the meeting to order and led the Pledge of Allegiance. The Board approved the meeting agenda on a motion made by Ms. Griffin, seconded by Secretary Baxton, and passing 3-0.

The Board reviewed minutes from its last meeting on September 19, 2017. Ms. Griffin moved to approve the minutes. Secretary Baxton seconded the motion, which passed 3-0.

#### Director's report

Mr. Bowens provided an update on voting activity during one-stop early voting, including graphical presentations of voter demographics. Mr. Bowens also updated the Board on expanded training opportunities offered to election officials to ensure comprehensive training of precinct Chief Judges.

#### Old business: Memorandum of Understanding with Durham County administration

Mr. Bowens reported that this document was in the hands of Human Resources Director Kathy Everett-Perry and County Attorney Lowell Siler. Senior Assistant County Attorney Willie Darby indicated that he would speak with Mr. Siler on the status of the Memorandum of Understanding.

#### New business

#### Review of absentee ballots

The Board reviewed 20 returned absentee ballot applications that had been submitted in time for this meeting. Secretary Baxton moved to approve all applications. The motion was seconded by Ms. Griffin and passed 3-0. Mr. Bowens noted that staff would continue procedures initiated at the last absentee board meetings to prepare for Election Day counts. The Board voted to continue approving these preparatory steps on a motion by Ms. Griffin, seconded by Secretary Baxton, and passing 3-0.

#### Election judge substitutions

Mr. Bowens provided the Board with a list of needed substitutions of chief judge and election judge positions. Mr. Bowens noted that these substitutions would only be in effect for the upcoming October municipal election. Board members inquired whether these substitutions were based on party recommendations. Mr. Bowens affirmed. Ms. Griffin moved to approve the list. The motion was seconded by Secretary Baxton and passed 3-0.

#### Public comment and questions; general discussion

Mr. Bowens responded to a question from audience member Susan Pochapsky regarding preparatory steps associated with absentee voting counts.

#### Closed session

Ms. Griffin moved for the Board to go into closed session for authorized purposes pursuant to GEN. STAT. 143-318.11(a)(3) relating to potential litigation and 143-318.11 (a)(1) and (a)(6) to discuss personnel matters. Secretary Baxton seconded that motion, which passed 3-0. The Board began its closed session at approximately 5:16 p.m.

Upon returning to open session at 5:40 p.m., Chairman Brian reported that the Board had instructed staff on certain matters and took no action requiring announcement in open session.





### **GRAND TOTAL OS TURNOUT AS OF 10/2/2017: 5,007**








#### Summary:

In accordance with N.C. Gen. Stat. §163-230.1(c)(1), beginning on third Tuesday prior to the election, the Board of Elections must review absentee ballot applications received as of the date of the scheduled meeting. The Board will be required to determine whether or not the ballots are "Approved" or "Disapproved." The Board will be asked to sign an absentee poll book inclusive of all of the applications approved for the meeting. Staff also requests that the Board allow scanning and ballot duplication under N.C. Gen. Stat. §163-234(2).

#### **RESOLUTION TO ADOPT TIME FOR COUNTING OF ABSENTEE BALLOTS NOVEMBER 7, 2017 ELECTION**

On October 3, 2017, the Durham County Board of Elections met in Durham, North Carolina, at its office and adopted the following resolution:

**WHEREAS** the county board of elections is authorized upon adoption of a resolution to begin counting of absentee ballots between the hours of 2:00 p.m. and 5:00 p.m. on Election Day;

**WHEREAS** such resolution also may provide for an additional meeting following the day of the election and prior to the day of canvass to count absentee ballots received pursuant to N.C. Gen. Stat. §163-231(b)(2);

**WHEREAS** the times for these meetings will be at 2:00 p.m. on Tuesday, November 7<sup>th</sup> and Friday, November 16<sup>th</sup> for the purpose of counting absentee ballots;

**WHEREAS** the location of these meetings shall be at the offices of the Durham County Board of Elections, 201 N. Roxboro St., Durham;

**WHEREAS** the board shall not announce the results of the count before 7:30 p.m. on Election Day;

WHEREAS these meetings are open to all who may want to attend; and,

**WHEREAS** the adoption of this resolution is in compliance with North Carolina General Statutes §§ 163-234(2) and (10) and will be published in a newspaper of general circulation in the county within the statutory time frame.

**NOW, THEREFORE, BE IT RESOLVED** that the Durham County Board of Elections hereby unanimously approves the time for Counting of Absentee Ballots as set forth above.
