Chair Jacobs announced there were no adjustments to the agenda.

#### **Announcements**

Chair Jacobs read the following announcements:

- 1)Mark your calendars and register for Durham's Annual *Big Sweep* clean up event on Saturday, October 7, 2017. Volunteer registration is now open at <a href="www.durhambigsweep.org">www.durhambigsweep.org</a> and everyone is encouraged help clean up Durham. "The trash collected during Durham Big Sweep will be properly disposed of and no longer will pose an environmental or health threat."
- 2)GoTriangle invites you to participate in an informational meeting to learn about updates to the Durham-Orange Light Rail Transit Project, Tuesday September 26, 2017. Drop in anytime between 4:00-7:00 pm at Hayti Heritage Center, 804 Old Fayetteville Street to get an update on this 17.7-mile project that will provide over 26,000 trips per day to residents and commuters taking advantage of employment, healthcare, and education opportunities in Durham and Chapel Hill. *Please note that no formal presentation is scheduled*.
- 3)Early Voting for the October 2017 municipal primary and election began this past Thursday and continues until 1:00 p.m. on Saturday, October 7th. The upcoming Election Day is Tuesday, October 10th. For more information, including early voting sites and schedules, visit www.dconc.gov/elect.

4)The NC Department of Transportation will hold a public meeting on Thursday September 28 from 5 - 7 PM at Mount Sylvan United Methodist Church at 5731 N. Roxboro Road regarding proposed improvements at the intersection of N. Roxboro Road with Latta Road and Infinity Road.

Commissioner Reckhow stated the improvements included more than stop lights and encouraged those that travel the route to attend the public meeting.

5)One Month, One Book, One Community. Durham Reads Together strengthens the community through a bi-annual celebration of reading. By reading the same book, and attending programs around the theme, Durham's community is inspired to discuss important issues including race, family, identity, religion, faith, education, art, and culture. This year's book is the United States Constitution. Pick up a free copy of the Constitution at your library through the end of October, while supplies last. Tammy Baggett, Library Director, explained the purpose and meaning behind the selection of the U.S. Constitution. #### **Minutes**

Chair Jacobs inquired about the status of numerous directives from the Budget Worksession meetings. Claudia Hager, General Manager responded now that the minutes were officially approved, staff could complete a cross reference to make sure no directives were over-looked.

Commissioner Reckhow commented on the format of the budget book, asking that the constructive feedback be used during the next budget. She specifically referred to the strategic plan and nonprofit areas. Ms. Hager stated staff was looking at ways to show online interaction so that citizens would be more aware of the overall process.

Commissioner Carter thanked staff for the work done on the Budget Worksession minutes, adding the information refreshed her memory of the topics discussed.

Commissioner Carter moved, seconded by Commissioner Howerton to approve the May 25, 2017, May 30, 2017 and June 13, 2017 Budget Worksession minutes and the September 11, 2017 Regular Session minutes.

The motion carried unanimously.

#### **Proclamation - Rail Safety Week**

#### **RAIL SAFETY WEEK | 2017**

WHEREAS, the County of Durham is a supporter of highway-rail grade crossing and pedestrian safety programs; and

WHEREAS, collisions between trains and motor vehicles or pedestrians could be prevented by increased public awareness of the dangers at crossings and around railroad property and of the appropriate safety laws; and

WHEREAS, North Carolina Operation Lifesaver is the foremost public information and education program dedicated to preventing highway-rail grade crossing crashes and pedestrian/railroad trespass incidents; and

WHEREAS, during the week of September 24 through 30, 2017, and throughout the year, all citizens are encouraged to observe added caution as motorists or pedestrians near tracks or trains; and

WHEREAS, this important observance should lead to greater safety awareness and a reduction in highway-rail grade crossing crashes and pedestrian/railroad incidents.
