## **Public Hearings**

#### **Public Hearing to Review the Draft Sewer System Development Fee Analysis**

Jaye Gibson, General Manager stated the Board was requested to conduct a public hearing to receive comments on the draft Sewer System Development Fees Analysis performed by WR Martin. He provided background information on the copy and asked Dennie Martin with WR Martin to share additional information.

Mr. Martin explained the purpose of the Sewer System Development Fees (SDF) Analysis for Durham and the importance of the SDF complying with North Carolina House Bill 436 (HB 436). He stated the SDF would replace the existing capital recovery fees and fees collected would be used for the repair and rehabilitation of existing sewer assets.

Mr. Gibson provided clarification that an increase was proposed in the Managers Recommended Budget due to undercharging of the Sewer System Fees.

Chair Jacobs opened the public hearing. No one was signed up to speak; the public hearing was closed. Chair Jacobs thanked Mr. Gibson and Mr. Martin for the update.
