## Durham County Board of Health Smoking Rule adopted by County Ordinance

- In an effort to protect the public from secondhand smoke, the Durham County Board of Health Smoking Rule was adopted and went into effect on August 1, 2012.
- Most recently, the Smoking Rule was amended to include e-cigarettes, effective January 1, 2016 and to include public places effective July 1, 2018.

## SB20: Good Samaritan/Naloxone Access Law (April 9, 2013)



- Removed civil liabilities from doctors who prescribe and bystanders who administer naloxone, to save the life of a victim.
- Allows community based organizations to dispense Naloxone, under the guidance of a medical provider.



Dear Chief Davis,

On behalf of the Board of Health, we want to take this opportunity to thank you for coming to our September board meeting to share your philosophy for improving crimerelated conditions in the Durham Community. All of us were delighted to hear about your plans to resurrect community policing and your interests in engaging other entities in a multi-facet approach to solving problems and placing resources in the prevention end of the spectrum rather than just in the reactive enforcement end. These strategies will improve relationships between law enforcement and the community and reduce crime rates overtime.

Our Board is committed to working to increase the average number of years that people in Durham County live. To that end, thank you for your strong support for the implementation of the Cure Violence Model in McDougald Terrace. Your willingness to assure that community policing in that community does not compromise the program is greatly appreciated. Your request for and participation in a telephone conversation with representatives from National Cure Violence, your request for law enforcement contacts in communities that have successful programs, and the use of the materials on the website demonstrate your desire to work with us to reduce loss of life due to gun violence.

Opioid overdoses all too often, also, result in premature deaths. The Board strongly supports your desire to have your officers carry naloxone in order to prevent the premature loss of lives due to opioid overdoses. This legislatively supported, evidence-based strategy is saving lives all across the country, as you have experienced in Atlanta. Sheriff Mike Andrews is working with staff to develop a plan for the use of naloxone by detention officers in the Detention Facility. He is also supportive of deputies in the community carrying naloxone but would like to start the program at the same time as a program is started by the Durham Police Department. Both our medical director, Dr. Arlene Sena, and the medical director for Alliance Behavioral Healthcare, Dr. Tedra Anderson-Brown, are anxious to work with you to compile: 1) compelling evidence for the need for law enforcement to adopt this strategy for the benefit of our community; 2) reports of the lifesaving results associated with this medication; and 3) information about associated risk, if any, for the City of Durham. Rosalyn McClain will contact your office to schedule a meeting to begin this work.



### Chief Davis,

The Durham County Department of Public Health (DCoDPH) will implement a safe syringe program (SSP) based on the guidance and program requirements from the NC Division of Public Health (NCDPH). DCoDPH will provide a fixed-site (the DCoDPH Pharmacy) and mobile-site locations (through health education/Bull City United outreach) for comprehensive SSP services in the community, which includes harm reduction and access to HIV and hepatitis C screening and care. SSP services will be provided free of charge and will operate under the health philosophy of harm reduction.

NCDPH has developed a Safer Syringe Initiative, which is a project to increase access to clean needles, hypodermic syringes and other injection supplies, facilitate the safe disposal of used needles and syringes, provide information about harm reduction and preventative health and connect people who inject drugs with treatment and medical and social services, as requested.

One requirement from the NCDPH is to officially notify the Durham Police Department and the Sheriff's Office of the program launch and to provide a copy of safety and security procedures. Please see the attached policies. We encourage you to notify all of your staff about this program.

Please also distribute a copy of the "safe syringe program card" so that all officers are aware that individuals and staff participating in this program should be carrying this card which provides limited immunity from prosecution. We also want to ensure that community members who come into the building to utilize the safe syringe program feel safe to do so without fear of being targeted by law enforcement upon entry or exit of our building.

For the knowledge of your staff, we are creating participant IDs based on the following information:

### SSP packets will include:

- · 10 sterile 1.0mL syringes with fixed needles
- Alcohol swabs
- Tourniquet
- Condoms
- Sharps Container
- Additional injection supplies
- · Printed material for harm reduction and ancillary services

SSP packets will be provided in a confidential manner, in order to be protective of individual safety, security, and privacy. Individuals will be strongly encouraged to dispose of their used needles and syringes in the sharps containers and/or bring them to the DCoDPH Pharmacy C Laboratory for safe and proper disposal. Intranasal naloxone, HIV and hepatitis C testing, mental health and substance abuse counseling will be offered to all individuals requesting St services.



### **School Health Program**

- Enlisted the assistance of Dr. Wanda Boone and Catherine "Kay" Sandford, MSPH, to help develop an educational campaign to raise awareness of the misuse of prescription medications, including opiates.
  - The campaign will provide education and prevention tools for DPS students in grades 5-12.
  - Education for students in grades 1-4 will focus on medication safety and what to do in emergent situations.
- Dr. Wanda Boone, the Executive Director of TRY (Together for Resilient Youth) and a member of several national and local and national committees, met with the planning team to offer information and advice on current TRY activities already in place in the schools, and offered to collaborate and provide educational materials for distribution throughout the schools.
- Catherine "Kay" Sanford, MSPH is North Carolina's former Injury Epidemiologist (retired 2007). Ms. Sanford is a co-founder of Project Lazarus, a mentor and teacher for the NC Harm Reduction Coalition and was influential in the passage of NC's Controlled Substances Reporting System and the Good Samaritan law (2013).
- She is guiding the planning for developmentally appropriate education and the incorporation of social determinants to adapt to the various ages and populations who will be offered the education.
- The School Health Program is proud to partner with two of Durham's strongest advocates for the prevention of prescription, including opiates, misuse and abuse.

### Durham County Leadership Forum on Substance Abuse



January 24, 2018

Dear Community Partners,

In Durham County in 2016, cocaine (17), heroin (11), prescription opioids (9) and other synthetic narcotics (6) contributed to unintentional medication and drug overdose deaths. According to the N.C. State Center for Health Statistics, these counts are not mutually exclusive in that deaths that involved multiple drugs can be counted multiple times. However, it is clear that illicit drug use remains a problem in Durham.

During the same time period, an average of 38 outpatient opioid pills per person in Durham was dispensed. Based on Durham's estimated 2016 population (306,212), approximately 11,636,06 outpatient opioid pills were dispensed. Regular use of opioid pain relievers - even when used as prescribed by a doctor - can produce dependence, and when misused or abused, can lead to fatal overdose. In North Carolina, as in our nation, the use of prescription pain killers has reached epidemic proportions. Closely related is the alarming increase in the use of heroin. It is time for local elected officials to assume a leadership role in reversing these trends.

On behalf of the Durham County Board of Commissioners, I would like to invite you to participate in a County Leadership Forum on Substance Abuse. Community-wide education regarding illicit drug use and the proper use and risks of prescription drugs is essential to lowering misuse and accidental overdose, as is having ready access to reliable treatment and recovery supports. By convening all the local elected officials from our county, as well as representatives from key organizations, we can learn the full effect of the medication and drug abuse on our county's residents, find out what resources are available to help our families, and develop collaborative strategies for effective education, prevention, and treatment that can and will make a difference here in Durham County.

The Durham County Leadership Forum on Substance Abuse will be held on February 27<sup>th</sup> from 8:30 a.m. to 12:00 p.m. at the Durham County Human Services Building, 414 East Main Street. Dear Elected Officials and Community Partners,

The Durham County Board of Health is pleased that the Durham County Board of Commissioners and the N.C. Association of County Commissioners have partnered to bring together elected officials and other community leaders to develop a plan to address the issue of substance misuse including opioid and illicit drug abuse in our community.

Recent data provided by the NC Injury and Violence Prevention Branch showed in 2016, the following information for substances contributing to unintentional medication and drug overdose deaths in Durham County: cocaine –17; heroin–11; commonly prescribed opioid medications – 9; and other synthetic narcotics -6. Keep in mind, these counts are not mutually exclusive. I cite these numbers to remind us that illicit drug use also remains a problem in Durham County.

In a Joint Report from National Association of Counties and the National League of Cities, A Prescription for Action, it is stated that "communities of color continue to feel the detrimental effects of the criminalization of addiction, which today is being replaced by a new focus on harm reduction and improved public health. Moving forward, we must give ongoing attention and action to the racial dispartites relevant to addiction and its treatment." To that end, it is imperative that you as a leader in this community, join us on February 27th from 8:15 a.m. to 12:00 p.m. in the Durham County Human Services Building to help develop a plan that can save and rebuild lives in the Durham county.

Congratulations! We are pleased to notify you that a committee selected your community to participate in North Carolina Local Governments and the Opioid Crisis: A Collective Impact Approach to Making Policy and Changing Lives, an intensive two-year collaborative learning model provided by the UNC School of Government in partnership with Blue Cross NC. We received 39 applications for the program, which represented nearly half the counties in North Carolina. We were overwhelmed by the number of applications and inspired by the important work happening in communities across the state, including yours.

The UNC School of Government and Blue Cross NC will provide the following to each participating community: five regional forums at which teams will form goals, set plans for implementation, collaborate across fields and jurisdictions, and learn from experts on opioid-related issues; School of Government support throughout the process; \$10,000 to assist with the costs of hiring a community project manager, and \$10,000 in implementation funding for the project

Each community selected will contribute a committed team—representing multiple departments, jurisdictions, and/or organizations -that will invest the time, energy, and work needed to achieve team goals; and travel funds for some team members to attend the five program forums.
