The Durham County Juvenile Crime Prevention Council (JCPC) has studied the risk factors and needs of Juvenile Court involved youth in this county and hereby publishes this Request for Proposals. The JCPC anticipates funds from the NC Department of Public Safety (DPS) in the amount stated above to fund the program types specified below. Such programs will serve delinquent and at-risk youth for the State fiscal year 2019-2020 beginning on, or after, July 1, 2019. The use of these funds in this county requires a local match in the amount specified above. For fiscal year 2019-2020, programs submitting proposals should consider the new "Raise the Age Law" effective 12/01/2019 that increases the age of juvenile to include 16-17 year old youth.

Based on identified needed programs the JCPC will consider proposals for the following needed program types:

Proposed program services should target the following concerns as reported in the Risk Factors and Needs Assessment for the 164 youth who were referred to juvenile court with 487 complaints.

- 56% or 92 youth identified as needing substance abuse assessment and/or treatment
- 77% or 126 youth had moderate to serious school behavior problems
- 31% or 51 youth identified as gang member or associates with gang
- 41% or 67 youth at intake reported to need more Mental Health Assessment.
- 60% or 98 youth at intake reported to come from families with marginal or inadequate supervision skills
- 60% or 98 youth at intake reported to come from families with criminal history or family member under court supervision or gang involvement

Applicants are being sought that are able to address the legislatively mandated items below

1. Program services compatible with research that is shown to be effective with juvenile offenders.
2. Program services are outcome-based.
3. The program has an evaluation component.
4. Program services detect gang participation and divert individuals

Only local public agencies, 501(c) (3) non-profit corporations and local housing authorities will be considered for funding.

Once the application is submitted online, print the entire application and submit per instructions below. Private non-profits are also required to submit the following forms online or your application will be considered incomplete: **1) No Over Due Tax form (available at the above link), 2) Notarized DPS Conflict of Interest Statement (available at the above link), 3) the agencies Conflict of Interest Policy; and 4) Proof of 501(c) (3) status.**
