Proclamation – Colorectal Cancer Month

Vice Chair Hill read the following proclamation:

COLORECTAL CANCER AWARENESS MONTH | 2019

WHEREAS,	March is Colorectal Cancer Awareness Month; and	
WHEREAS,	Colorectal Cancer is the second leading cause of cancer death among men and women collectively in the United States; and	
WHEREAS,	one in 20 people will be diagnosed in their lifetime; and	
WHEREAS,	the incidence of colorectal cancer for people younger than 50 years of age is increasing; and	
WHEREAS,	sixty per cent of deaths caused by colorectal cancer can be prevented with screening; and	

- WHEREAS, routine screenings for colon cancer enable early detection and treatment; and
- **WHEREAS,** the American Cancer Society recommends that regular screenings for colorectal cancer begin at 45 years of age; and
- **WHEREAS,** people with one or more family members who have had colon or rectal cancer are at increased risk for diagnosis; and

WHEREAS, Colorectal Cancer Awareness Month is a good time to encourage people of all backgrounds and ages to be aware of the signs and symptoms of this type of cancer.

NOW, THEREFORE, I, Wendy Jacobs, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby proclaim March 1-31, 2019 as

"COLORECTAL CANCER AWARENESS MONTH"

in Durham County. We pause in recognition of those who have completed their battle with the disease along with family members and advocates who continue to educate others about colorectal cancer and the research that will hopefully reveal a cure for this devastating condition in the future.

Resolution - Supporting Juvenile Crime Prevention Council Allocation Expansion

SUPPORTING JUVENILE CRIME PREVENTION COUNCIL ALLOCATION EXPANSION

- **WHEREAS,** Juvenile Crime Prevention Council (JCPC) funding is a partnership between the State of North Carolina and the County to ensure a local continuum of services for court involved and at-risk juveniles; and,
- WHEREAS, the Juvenile Crime Prevention Council, under the authority of NCGS§143B-851, and within the scope of its powers and duties, "Each County Council shall annually review the needs of juveniles in the county who are at risk of delinquency or who have been adjudicated undisciplined or delinquent and the resources available to address those needs. In particular, each County Council shall assess the needs of juveniles in the county who are at risk or who have been associated with gangs or gang activity, and the local resources that are established to address those needs," and,
- **WHEREAS,** the Juvenile Justice Reinvestment Act passed in 2017, also referenced as North Carolina's Raise the Age legislation, expands the age of juvenile jurisdiction, increasing it to include juveniles ages 16 and 17 years of age effective December 1, 2019; and,
- **WHEREAS,** Raise the Age legislation will increase the need for immediate and age-appropriate sanctions and diversion services for juvenile offenders and those at-risk of delinquency; and,
- WHEREAS, JCPC funding has seen no increase in more than nine years; and,
- **WHEREAS,** the effort to immediately and effectively address juvenile offending behavior is an evidence-based investment in North Carolina's future; and,
- **WHEREAS,** effective intervention and programming reduces detention and youth development commitments as a cost savings to the state and county.

NOW, THEREFORE, BE IT RESOLVED, we the members of the Durham County Board of Commissioners fully support an adequate and timely increase of local Juvenile Crime Prevention funding to ensure program expansion and successful implementation of the Juvenile Justice Reinvestment Act Raise the Age Legislation, set for December 1, 2019.

Quarterly Management Report Q2 FY 18-19

Wendell Davis, County Manager shared the Quarterly Management Report (QMR) which outlined the following: Strategic Plan and Managing for Results (MFR), QMR Quarter One, Updated QMR

Appendix. Greg Marrow, Chief Information Officer, shared the *Durham County's Transparency Portal* and Keith Lane, Director of Budget and Management, demonstrated the *Data Driven Durham County* www.data-dconc.org.

The Board asked if there was a decrease in enrollment in the Court Date Reminder Program. County Manager Davis responded he would contact Gudrun Parmer, Criminal Justice Resource Center Director for clarification on the final report. The Board inquired about County contracts with people of color. County Manager Davis responded he would plan a meeting with the purchasing staff to review and explain that data. The Board asked would all projects be summarized in the QMR and inquired about how the projects highlights were selected. Dionne Hines, Assistant to the County Manager, responded the project highlights would remain the same for the fiscal year and would be reported in the appendix. Drew Cummings, Chief of Staff, replied the projects highlights were selected if they were in alignment with the strategic plan and if the projects changed.

The Board asked when the data reporting tools would be complete and if they would be on the website for public access. Mr. Lane responded it could possibly be years before the data reporting tools were completed. County Manager Davis responded added the County website was scheduled to be updated to reflect the changes.
