

#### Board of Elections Mission & Vision



Develop cutting edge procedures and practices consistent with and exceeding legal and administrative requirements.


#### **GOAL 4: EDUCATING FOR SUCCESS**

## Durham County Board of Elections Organizational Chart & Structure



Board of Elections is comprised of 5 members that oversee elections administration for Durham County. A Director of Elections is hired by the Board of Elections, and approved by the Executive Director of the State Board of Elections, to execute the elections process as delegated by the Board.

The Director is charged with hiring administrative staff to execute the duties delegated by the County Board of Elections. The Board does not delegate quasi-judicial or policymaking authority to the Director of Elections.






## Durham County Board of Elections Key Divisions, Programs & Initiatives

#### **Voter Registration and Public Information Division**

The Voter Registration and Public Information Division is responsible for registering voters, conducting list maintenance procedures, fulfilling public records requests, and geocoding to ensure accurate jurisdiction assignments for voters.




## Durham County Board of Elections Key Divisions, Programs & Initiatives

#### **Training and Compliance Division**

The training and compliance division is responsible educating election officials on proper procedures for election administration at the precinct level, overseeing public engagement, ensuring that all voters desiring to utilize the absentee by mail voting process have that opportunity, and overseeing campaign finance regulations for committees under the purview of the Durham County Board of Elections.


