#### **Citizen Comments**

## **Katie Moore**

I'm a lifelong resident of Durham County and am emailing to ask the communication in its next meeting to join the city and school board in approving the Durham Community-Led Safety and Wellness Task Force and its bylaws. Police brutality exists in Durham, and it is long overdue for real, community-led solutions to that issue.

I'm also urging you to keep any law enforcement officials or members of the Sheriff office off of the task force. There are many, many instances of task forces or oversight boards that have been completely ineffective because of involvement of law enforcement, and we need to make sure that this force is able to truly, accomplish the goals.

Finally, I'm asking you to remove SROs from Durham Public Schools and redirect that funding for nurses and trauma-informed counselors. We need for out schools to be safe, but there to ample evidence that SROs do not create more safety for students, especially for Black and Brown students.

## Emma Dunlop

I am writing to advocate that we removed SROs from Durham County and fund/support community wellness taskforces. Anytime I have acted out/done something against the rules, it's because a need hasn't been met. I am an adult and struggle with self-control when I am going through something hard. The children in our schools do not need punishment, they need support to encourage them to make better decisions from themselves.

I do not understand the argument to keep SROs in schools. Those are children. School should be a safe place for all children. Police officers are not needed in school.

# <u>David Sapiro-Gheiler, Michelle Metzler, Jim McQuiad, Brittany Prempin, Elizabeth Templeton, Lara Morrison, Conor McDonough, Andrew Flynn and Shah Ruchi</u>

As a resident of Durham County, I am writing to urge the Durham County Board of County Commissioners at its upcoming meeting to join the Durham City Council and the Durham School Board in approving the Durham Community-Led Safety and Wellness Task Force and its bylaws. Those bylaws create a collaborative process between the city, county, and the school board to build better systems of public safety for all of our communities by developing alternatives to police and sheriff's departments.

I also urge you not to include the Sheriff or any Sheriff's Department as County representatives on this Task Force because that would defeat the Task Force's purpose-to move beyond reactive short-term solutions using a punishment or imprisonment framework.

I also ask you to removed School Resource Officers (SROs) from the classrooms and hallways of

Durham Public Schools. There is substantial evidence that SROs do not make schools safer, and in fact cause serious harm to young people, especially Black children, School Resource Officer referrals disproportionately impact students of color. A report published by the U. S. Department of Education Office of Civil Rights found that Black students are more than twice as likely to receive discipline through law enforcement, despite composing a significantly smaller proportion of overall students. The funding for SROs should be redistributed to ensuring nurses and trauma-informed counselors are present in each school. Invest in the safety and well-being of students in Durham County.

#### **Haley Garvin**

I am a resident, teacher, and future parent in Durham. I am writing to ask, you to approve the Durham Community-Led Safety and Wellness Task Force and its bylaws. This is a deeply important step to making sure. ALL Durham citizens feel safe in our communities.

Please do not include the Sheriff or any Sheriff's Deputies as County as County representatives on this Task Force. We have to have safety that thinks beyond punishments.

I am also urging you to removed School Resource Officers (SROs) from the classrooms and hallways of Durham Public Schools. I have seen first-hand the harm that SROs physically and psychologically cause to students. As a teacher I have always felt their presence its threating. We need to invest in the well-being of all Durham students. The money for SROs needs to be redistributed for more counselors, therapists, and nurses in schools.

#### Rann Bar-On

I am writing to urge you to pass the bylaws for the Community Safety and Wellness Taskforce as passes by City Council and the Board of Education. The time is long past due for residents of our Count to be given a direct say in the way mechanisms of community safety and wellness are governed and funded in Durham.

I strongly urge you to pass the bylaws without any members of law enforcement being given seats as members of the Taskforce. The police have enormous power over these issues already and have a budget that vastly outstrips the proposed funding for the Taskforce. The Taskforce will exist in order to consider, imagine, and recommend implementation of \*alternatives\* to policing. Therefore, it seems contrary to its fundamental purpose to have police as members. Nothing in the bylaws prevents the Taskforce from consulting with the Police and Sheriff's departments as it studies safety and wellness to our communities. Explicit seats for cops on the Taskforce are unnecessary and would merely serve to take away seats from community members to whom such powers have not been granted. It is fundamentally less democratic to include police on the Taskforce than to not do so.

#### Jose Romero, Citizen

During this global pandemic, Durham County Commissioners have been tasked with a difficult burden, equitable allocation of resources, but have a simple choice ahead to make that process easier: <u>deny the request from the Durham detention Center for Window Replacement (419DC084)</u>. This unexpected

request is a the very least cold-hearted during an intense time of financial strain when Durham braces for growing evictions and more waves of illness In truth, this request reflects a multi-year and systemic violation of the constitutional rights of people held in the Detention Center who right to due process is often only heard by pounded windows. At a time when we should be improving health systems for justice-involved folks and the community at large, new windows will not cure Coronavirus and they will not answer the large problem of how to transform the criminal justice system in Durham. I want a Durham that is healthier, not one where handcuffs are made with gold. I urge the County Commissioners to use their discretionary power on this item and deny the request pending (1) further community input (2) transparency on the source of the damage, and above all (3) a medical review that constructing new windows and transferring inmates does not pose a major SARS-CoV2/health risk.

Chair Jacobs responded the window replacement at the detention center was a public health and safety issue the County was required to address.

## **Consent Agenda**

- Item 20-0330 Chair Jacobs suggested including language in the contract to have County videos translated and bilingual. Deborah Craig-Ray, General Manager stated conversation were initiated to discuss having the videos, forms, publications and materials translated, to include closed captioning and to have the County website Americans with Disabilities Act (ADA) approved. She added the item would be discussed at a Work Session to develop the budget and steps for a pilot program. Chair Jacobs asked that contracts with the Latinx community be incorporated as well.
- Item 20-0331 Chair Jacobs acknowledged Nicole Thompson, CEO, Downtown Durham Inc. and staff for their work on the item.
- Item 20-0332 Chair Jacobs thanked Geoff Durham, President, Greater Durham Chamber of Commerce and Bryan Fox, Vice President of Public Affairs, Greater Durham Chamber of Commerce for their work in the community. Chair Jacobs asked for an explanation of the scope of work. Andrew Miracle, Economic Development Officer responded the policy set the framework for the projects with the County and the Durham Chamber was a primary author and on the core team.

Commissioner Howerton also thanked Mr. Durham for the work they continued to do. She stated the work the Chamber recently did around the Groundwater Racial Institute where the community was invited to attend – was very informative as they continued to address the framework on racial issues in our environment in Durham County.

Hearing no additional comments, Chair Jacobs entertained a motion for approval.

Jamie Sunyak, Senior Planner stated the Board was requested to hold a public hearing to consider a request to change the zoning atlas for property located at 2622 South Miami Boulevard and 2120 Brunson Road from Industrial Light (IL), Commercial Neighborhood (CN), and Residential Suburban-20 (RS-20) to Industrial Light (IL).

Chair Jacobs asked how the criteria would support solar panels. Ms. Rosenberg responded the Planning staff and the Environmental Affairs Board were working to figure out the best options to move forward with solar panel installations and decide if necessary, to have an allowance for solar gains.

Rodney Jenkins, Public Health Director thanked the Board and County Management for their support.

Mr. Jenkins provided the following updates for Durham County:

- 4651 total cases
- 64 seven-day moving average
- 26.8 percent were African American; 22.5 percent were Caucasian; 50 percent were LatinX
- 27704 zip code held the highest positive cases at 20.8 percent
- 11m percent Durham infection growth rate
- The Temporary Order was into effect mandating that all labs report both positive and negative test results.
- A statewide order for COVID testing was released from the State Health Director

The Board inquired about fewer hospital cases due to hospitals not reporting numbers. Mr. Jenkins replied the County was receiving reports from Duke and the reports indicated hospitals were reporting constant cases.

Ryan Eaves, Stormwater and Erosion Control Division Manager, McKenzie Gentry, Stormwater Manager and Inga Kennedy, President, Planners for Environmental Quality (PEQ) shared the *Stormwater Utility Fee Outreach Update* which highlighted the following: Summary of Stormwater Utility Fee, Public Outreach Efforts, Stormwater Utility Fee Ordinance and Program Priorities.

## 20-0298 Discussion on the Joint Durham Community Safety and Wellness Task Force

The following comment was submitted in response to the above-mentioned discussion item.

## **Citizen Comment:**

#### Jose Romero

I urge the County Commissioner's to vote with the heart of Durham and approve the Safety and Wellness Task Force and DENY the request to have law enforcement serve on the task force in any capacity. The letter from CJRC Director Gudrun Parmer acknowledges that Law Enforcement already occupy a formal position on at least 3 City and County Committees and informally on various others, meanwhile there is currently not a single committee at the city or county level tasked with justiceinvolved alternatives that is entirely community-led. The presence of ANY local or extra-local law enforcement agency (DPD, DSO, US Marshals, etc.) on the Safety and Wellness Taskforce would dramatically decrease the scientific validity of the recommendations and deter community members from reporting harm experienced at the hands of law enforcement. For these reasons, as well as the origins of this proposal in a specific definition of community-led, the presence of law enforcement on the taskforce is compatible with its mission of 'examining," "educating," and "providing recommendations for additional programs to enhance public safety and wellness." Indeed, local, state, and federal reports have shown time and time again that when law enforcement, including Durham's own, are asked to hold themselves accountable for racial bias, they are systematically incapable of doing so regardless of the identity of any one officer. There has never been a taskforce of this kind in history of Durham and I ask you to help us help y 'all collectively build a healthier Durham for all.

Chair Jacobs provided a brief overview of the revisions to the bylaws and asked for the Board for suggestions. Jodi Miller, General Manager stated Gudrun Parmer, Director, Criminal Justice Resource Center (CJRC) submitted a document to the Board with suggested revisions to the functions proposed in the bylaws and a compilation of feedback from other County departments and criminal justice groups.

Commissioner Reckhow suggested the appointments include a Durham Public Health Board member, CJRC member, Juvenile Crime Prevention Council (JCPC) member, Sheriff Citizen Board member and an At-Large Resource Panel member.

Commissioner Howerton asked for the item to be placed on a later meeting agenda to allow the Board to receive information on police trainings, share and receive feedback from the community and receive funding/staffing data.

Vice-Chair Hill stated residents in the community wanted to moved forward to approve the taskforce. He added some residents were disappointed that the Sheriff and Police Chief were not included on the taskforce and stated it was not reasonable for the exclusion.

Chair Jacobs recommended the Board delay voting on the item until the August 3, 2020 Work Session.
