Chair Howerton read the following statement on behalf of the Durham County Commissioners condemning the deadly mass shootings at Atlanta Georgia area businesses:

Like many others, I watched in horror as news reports of multiple deaths resulting from three separate shooting incidents in and near Atlanta Georgia emerged Tuesday evening. I was especially heartbroken to learn that a gunman had viciously murdered eight people, the majority of whom were Asian women. Indeed, our hearts and prayers go out to the families of the victims whose lives have been forever altered by the loss of their loved ones. We also pray for the recovery of the surviving victim and his family.

Tragically, the first incident took place in Cherokee County, Georgia where five people were shot by the suspect and only one victim survived. About an hour later, the suspect traveled to Atlanta and again fired shots at victims in two other businesses located in the same proximity. Three women were shot to death inside the first business, and a fourth woman was found dead in the other business across the street.

If not for a positive ID of the gunman shared by family members as a result of cameras located at the businesses, and coordination of law enforcement officials in the two jurisdictions, the suspect most likely would have extended his killing spree to other locations, leaving more victims in his wake.

While an official motive is not yet confirmed and the investigation continues, the fact is that 8 innocent people are dead, and most of them were Asian. Over the past year, we've seen a marked increase in various crimes against members of the Asian community in our major urban centers and in smaller towns. We are mindful of the current anti-Asian sentiments that continue to escalate, and we simply cannot thrive as a nation if we continue to perpetuate a spirit of hatred against any minority groups.

Tragic, heartbreaking killings such as these continue to amplify the need for our communities to come together and show a spirit of unity. We must begin to have conversations that lead to a greater understanding of our differences, and earnestly work to develop respect for our worth, dignity and values in order to thrive as a more perfect union.

Together, we must do the work if we want to see change.

Public Hearings

<u>21-0203 Public Hearing regarding Not to Exceed \$225,000,000 Limited Obligation Bonds, Series 2021A & 2021B</u>

Susan Tezai, Chief Financial Officer explained the obligation would refund the County's 2020C and 2020D Limited Obligations Bonds and finance additional projects including both County and school projects.

The Board inquired about the additional projects the bond would finance. Ms. Tezai responded the new Northern High School, improvements to existing schools, Sheriff firing range improvements, new youth home and the purchase of a convenience center site.

Chair Howerton opened the public hearing. Monica Toomer, Clerk to the Board stated there were no public comments.

Chair Howerton stated the public hearing would be open for 24 hours for receipt of comments.

Other Business

21-0057 Durham County Public Health Focused Update on the COVID-19 Crisis.

Rodney Jenkins, Public Health Director thanked the Board and County Management for their support in the COVID response.

Mr. Jenkins provided the following updates for Durham County:

- 23,332 total cases
- 65 seven-day moving average
- 36 percent were African American; 40.8 percent were Caucasian; 13.7 percent were Latinx
- 12.5 percent cases were under age 18
- Greatest number of cases were among people who worked in universities, scientific, technical and unemployed
- Approximately 25 percent of Durham County residents were partially vaccinated and 16 percent were fully vaccinated

The Board announced Krispy Kreme Doughnuts was offering a free doughnut to anyone who showed their COVID-19 Vaccination Record Card. The Board asked how many vaccination sites were in Durham. Mr. Jenkins responded 53 active sites. The Board asked if the percentage of vaccinations per population rate was referring to overall population or people who were able to get vaccinated. Mr. Jenkins replied people who were able to get vaccinated. The Board asked about informing the Latinx community about the vaccination, support for Durham Public Schools (DPS) and if Group Four would have a waitlist. Mr. Jenkins responded organizations were working together for continued information in the Latinx community; DPS had a great plan in place for return of in-person school and Group Four was a large group and the waitlist had increased. The Board asked if Public Health staff were taking care of themselves. Mr. Jenkins responded his staff were trying to take care of themselves.

21-0090 Presentation of the Fiscal Year (FY) 2020 Annual Financial Audit and Comprehensive Annual Financial Report (CAFR) and the FY 2020 Annual Single Audit and Compliance Report

Susan Tezai, Chief Financial Officer introduced Scott Duda, Engagement Partner at Cherry Bekaert LLP. Mr. Duda shared the *Audit Wrap Up and Presentation* which highlight the following: Table of Contents, Overview, Audit Areas of Focus, Results on Financial Statement, Results on OMB Uniform Guidance Audit, Results on State Single Audit and Required Communications.

The Board asked about the corrective action plan to address the non-material compliance with filling the Department of Social Services (DSS) vacant positions. Mr. Duda responded the FY 2021 audit would review the FY 2020 audit to determine if the errors and issues of concern were addressed. Mike Carey, Senior Audit Manager at Cherry Bekaert LLP explained the audit team was onsite for one day due to 95 percent of the audit being done remotely. The Board stated the amount of paperwork and compliance documents would require the frozen DSS positions to be opened and filled. Mr. Duda added sample sizes would be increased for the FY 2021 audit.

Ms. Tezai thanked County staff for their great work with handling the malware attack and COVID-19 impacting the organization. She added she was proud of the organization receiving a clean audit. Wendell Davis, County Manager stated DSS and Social Services critical positions have exceptions to allow the positions to be filled. The Board thanked Ms. Tezai and staff for a clean audit report.

21-0204 Fiscal Year 2020-21 Financial Update

Claudia Hager, General Manager shared the *Durham County Government Fiscal Update* which highlighted the following: American Rescue Plan Act Highlights, Hazardous/Differential Pay Options – Proposed through June 30, 2021, FY 2021-22 Budget Development COVID-19 Related Expenses, Department Comments: Public Health, Emergency Services, Register of Deeds, Office of the Sheriff.

The Board thanked Rod Jenkins, Public Health Director, Jim Groves, Office of Emergency Services Director, Sharon Davis, Register of Deeds and Clarence Birkhead, Durham County Sheriff for their comments and leadership. The Board thanked County staff for being front-line workers and keeping the community safe.

The Board inquired about the filing of \$3.9 million dollars of hazardous pay for Federal Emergency Management Agency (FEMA) reimbursement. Ms. Hager responded the County had not received a response from FEMA. The Board asked what was submitted to FEMA and for what time period. Ms. Hager replied submitted hazardous pay for Emergency Medical Service (EMS) workers for the last fiscal year. Ms. Tezai added all of the documents were reviewed by the compliance manager and auditor before being submitted.

The Board asked when would hazardous pay and incentive pay end and would the County reinstate raises and cost of living increases. County Manager Davis responded staff would present recommendations to the Board at the April 5th Work Session meeting and discuss future plans. He added as more people get vaccinated, hazardous pay could end. County Manager Davis stated a recommended budget including an incentive for all employees would be presented to the Board.

Commissioner Burns moved, seconded by Commissioner Allam to approve 10 percent differential pay for certain classified positions.

The motion carried unanimously.

The Board asked to discuss the American Recovery and Reinvestment Act (ARRA) at the April 5th Work Session meeting. Ms. Hager responded the initial set of guidelines have not been provided to the State. She added ARRA could be discussed at the April 5th Work Session meeting at a high level until more information was received.

Directive: Chair Jacobs asked to discuss the American Recovery and Reinvestment Act (ARRA) at the April 5th Work Session meeting.

Board and Commission Appointments

Chair Howerton recommended for the Board to change the language of the vacant position on the Durham Community Safety and Wellness Taskforce from "Parent of a Murdered Child" to "A person who had experienced two deaths in their family due to gun violence." Vice-Chair Jacobs recommended to change the language to "A person who had experienced a death in their family." Commissioner Burns recommended "A person who had experienced a death in their family due to gun violence." The Board agreed to the language change.

Willie Darby, Senior County Attorney announced the voting results.
