2. **Department of Social Services to Administer a New Property Tax Program** – The DSS department in partnership with the Tax Administration have developed the Low-Income Homeowners Relief Program. This program will serve exclusively Durham homeowners who have owned their homes 10 years or more, and who are currently not receiving any state tax subsidies for their property. Eligible homeowners must have incomes  $\leq$  30% of the average median income.

We, the Durham County Board of Commissioners, strongly state our abhorrence for hate speech of any kind and our commitment to tolerance, inclusion and upholding the human rights of our LGTBQT+ community and all people. We support the efforts of our staff to finalize a draft Nondiscrimination Ordinance and look forward to this being brought forward and adopted by our board as soon as possible.*

*To our friends and neighbors who have been hurt by this vicious language, the Commissioners of Durham County see you, accept you and love you.”*

### **21-0621 Proclamation – National Hispanic Heritage Month**

Commissioner Burns read the following proclamation:

#### **NATIONAL HISPANIC HERITAGE MONTH | 2021**

**WHEREAS,** Americans annually observe National Hispanic Heritage Month from September 15 to October 15, by celebrating the histories, cultures and contributions of American citizens whose ancestors came from Spain, Mexico, the Caribbean and Central and South America; and

**WHEREAS,** this observation was first held in 1968 as Hispanic Heritage Week under President Lyndon Johnson and was later expanded in 1988 by President Ronald Reagan; and

**WHEREAS,** generations of Hispanic Americans have defended democracy along with this nation’s liberty and freedoms throughout the world by serving in our armed forces; and

**WHEREAS,** approximately 14% of Durham County’s residents are of Hispanic descent; and

**WHEREAS,** our communities are made stronger when we recognize our diversity and work to honor, understand and appreciate the history, achievements, art, music, cuisine, customs, unique traditions and cultures of our friends, family and neighbors who represent the Hispanic community; and

**WHEREAS,** This year’s Hispanic Heritage Month national theme is “One Endless Voice to Enhance our Traditions”, and we are fortunate to have a community which takes time to celebrate and honor contributions and service by our Hispanic residents every day.

**NOW, THEREFORE, BE IT RESOLVED** I, Brenda Howerton, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby proclaim September 15 - October 15, 2021 as

**“NATIONAL HISPANIC HERITAGE MONTH”**

in Durham County, and urge all residents to celebrate Hispanic Heritage Month by always honoring generations of Hispanic residents who have made our nation strong and prosperous with their essential contributions to North Carolina, Durham County and beyond.

**21-0625 Proclamation – Indigenous People Day 2021**

Vice-Chair Jacobs read the following resolution:

**INDIGENOUS PEOPLES DAY | 2021**

**WHEREAS,** at first European contact, native tribes populating North Carolina comprised three linguistic groups: Iroquoian, Siouan, and Algonquian; and

**WHEREAS,** the earliest Native inhabitants in this region experienced conquest, enslavement, displacement, and disease which decimated the population; and

**WHEREAS,** recognizing Indigenous Peoples Day serves as a reminder to reflect on the native people who were here before us, and their descendants; and

**WHEREAS,** Durham County is built upon the ancestral homelands of the Indigenous peoples now recognized as the Coharie, Eastern Band of Cherokee, Haliwa-Saponi, Lumbee, Meherrin, Occaneechi Band of the Saponi, Sappony, and Waccamaw Siouan and affirms the legal rights of the eight state recognized tribal nations in the State of North Carolina; and

**WHEREAS,** Triangle Native American Society, representing over 11,000 American Indian citizens from these eight state recognized tribes and a variety of other tribal nations now residing in Durham County and the Triangle area.

**NOW, THEREFORE, BE IT RESOLVED I,** Brenda Howerton, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby proclaim October 11, 2021 as

**“INDIGENOUS PEOPLES DAY”**

in Durham County, and we ask that you acknowledge and celebrate the culture and sacrifice of the first people on this land.

Commissioner Burns stated Indigenous history was being taught at the local and national level after being overlooked for a long time. Vice Chair Jacobs stated she looked forward to monuments and memorials for indigenous people and others not recognized in the community as recommended by the Durham City-County Committee on Confederate Monuments and Memorials.

**21-0628 Resolution – Leandro Plan**

Commissioner Allam read the following proclamation:

**RESOLUTION URGING THE STATE TO FULFILL ITS CONSTITUTIONAL DUTY TO PROVIDE EVERY CHILD ACCESS TO A SOUND BASIC EDUCATION**

**WHEREAS,** for more than 25 years, North Carolina lawmakers from both parties have failed to meet their constitutional obligation to provide all children in the state with a sound basic education; and

**WHEREAS,** far too many students, particularly students of color, students from economically-disadvantaged families, students with disabilities, English learners, and rural students have been denied the opportunities promised to them under the North Carolina Constitution; and

**WHEREAS,** the State Constitution and North Carolina General Statutes place the responsibility to fund a public school system that provides every child in the state with access to a sound basic education with the State of North Carolina, both the executive and legislative branches; and

**WHEREAS,** adequate educational opportunities cannot realistically be provided without adequate education funding; and

**WHEREAS,** on March 15, the State submitted to the court a long-term comprehensive remedial plan (“Leandro Plan”) detailing specific steps State leaders must enact to remedy the ongoing constitutional violations in our public school system and ensure that all students have access to the education they are owed under the State Constitution; and

**WHEREAS,** the Leandro Plan represents the bare minimum of the steps State leaders must take to fulfill their constitutional duties and is not a menu from which policymakers may select their preferred initiatives; and

**WHEREAS,** Governor Cooper’s Budget Recommendations for 2021-23 demonstrate that the Leandro Plan can be fully implemented within existing State resources; and

**WHEREAS,** on June 7, Judge W. David Lee ordered the state to implement the Leandro Plan “in full and in accordance with the timelines set forth therein;” and

**WHEREAS,** district leaders, including school board members, stand ready to direct additional State resources to the students and schools with the greatest needs, such that all children have an equal opportunity to realize their full potential; and

**WHEREAS,** receiving a quality education is paramount to catalyzing the full growth and self-actualization of students, families, communities, and our State as a whole.

**NOW, THEREFORE, BE IT RESOLVED,** that we the Durham County Commission request(s) that the North Carolina General Assembly fully enact the policy and funding reforms included in the Leandro Plan to ensure that all North Carolina students have access to a sound basic education by the 2028 school year.

**21-0627 Proclamation – Durham Domestic and Care Workers Day 2021**

Commissioner Carter read the following proclamation:

**DURHAM DOMESTIC WORKERS DAY OF RECOGNITION | 2021**

- WHEREAS,** domestic and care workers are the childcare, direct care providers and housecleaners who do the important work of making our homes safe environments and offer much needed care for ourselves and our loved ones; and
- WHEREAS,** domestic and care workers are the backbone of our economy and make it possible for others to work; and
- WHEREAS,** there is an increasing need to fill essential roles of caring for the elderly individuals (70% of all adults over 65 years old) who will need in-home services in the future and the third of all young children needing care; and
- WHEREAS,** domestic and care workers provide physical, medical, emotional and spiritual support for the individuals they work with; and
- WHEREAS,** historically these roles have been performed by women, Black people and people of color, undocumented individuals and other vulnerable populations, and have been invisibilized and devalued; and
- WHEREAS,** there are almost 3.5 million domestic and care workers nationwide whose contributions go unnoticed, who do not receive fair wages or benefits, who labor in unsafe conditions, and aren't covered by comprehensive labor protections; and
- WHEREAS,** there are over 53 million unpaid family caregivers who make up 21% of all adults and who provide assistance to the majority of aging adults, are not recognized for the invaluable support they provide; and
- WHEREAS,** COVID-19 has had devastating impacts on workers in general, domestic and care workers have worked throughout the pandemic providing services to support our families and loved ones and risk their own and family's health, and have finally been widely acknowledged as essential workers; and
- WHEREAS,** there is a history of domestic and care workers creating and leading social justice movements, and domestic and care workers in the South like Dorothy Bolden have organized and demanded dignity and recognition and pushed for policy and social change to honor this vital workforce; and

**NOW, THEREFORE, BE IT RESOLVED** I, Brenda Howerton, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby recognize

**“DURHAM DOMESTIC WORKERS DAY OF RECOGNITION”**

**21-0641 Proclamation – National Breast Cancer Month**

Chair Howerton read the following proclamation:

**NATIONAL BREAST CANCER AWARENESS MONTH | 2021**

- WHEREAS,** each year nearly 225,000 women get breast cancer and 42,000 will die from the disease; and
- WHEREAS,** Breast cancer is about 100 times more common in women than men, 1 in 8 women will be diagnosed with the disease, and diagnoses increase as patients get older; and
- WHEREAS,** Breast Cancer Awareness Month serves as an opportunity to increase awareness of the disease and to encourage individuals to have a plan to detect the disease in its early stages; and
- WHEREAS,** it is vital that those affected by breast cancer have access to quality, affordable care, and that research of all forms of breast cancer continues to be vigorously supported; and
- WHEREAS,** over the years and thanks to dedicated medical researchers, great progress has been made in the detection and treatment of breast cancer; and
- WHEREAS,** with the enactment of the Affordable Care Act, millions more patients have access to coverage which enables them to receive regular mammograms and thus many more lives have been saved.

**NOW, THEREFORE, BE IT RESOLVED I,** Brenda Howerton, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby proclaim October 2021 as

**“NATIONAL BREAST CANCER AWARENESS MONTH”**

**Other Business**

**21-0492 Durham County Public Health Focused Update on the COVID-19 Crisis**

Rodney Jenkins, Director of Public Health shared the *COVID-19/Vaccine Distribution Updates* which highlighted the following: COVID-19 Layered Prevention Strategies, Current COVID-19 Statistics, Durham County COVID-19 Confirmed Cases, Current COVID-19 Race and Ethnicity Trends, COVID-19 Percent Positive Labs, CDC Vaccine Updates Durham County Residents, Vaccine Dashboard Data for Durham Residents, Number and Percent of Post Vaccination Cases, Vaccines by Month by Race/Ethnicity, Attack Rate Increasing for Vaccinated Individuals, COVID-19 by Age, and Vaccine Dose (1, 2 and 3) Since January 1, 2021, Risk of Dying Increases for Unvaccinated Individuals, All COVID-19 Deaths Reported to Durham County Public Health Since March 17<sup>th</sup>, 2020, Educational Clusters, Usage and Capacity Hospitalization Data.

The Board questioned the increase in deaths of women from COVID-19. Mr. Jenkins replied more women were frontline workers and help positions in occupations under the essential job category. The Board asked what percentage of county residents would need to be vaccinated for the county to reach herd immunity. Mr. Jenkins responded around 80 to 85 percent of residents would need to be vaccinated. The Board asked if companies were reaching out to Public Health after President Joe

Biden's Vaccine Mandate. Mr. Jenkins replied no companies had reached out due to the high rate of vaccination in the county.

### **Closed Session**

Chair Howerton stated the board was requested to adjourn to Closed Session for the following:

- To consult with an attorney employed or retained by the public body in order to preserve the attorney-client privilege between the attorney and the public body, which privilege is hereby acknowledged; pursuant to G. S. 143- 318.11(a)(3)

Commissioner Allam moved, seconded by Vice-Chair Jacobs to adjourn into Closed Session.

The motion carried unanimously.


