Macio Carlton, Deputy Clerk to the Board read the following announcements:

1. **Department of Social Services to Administer a New Property Tax Program** – The DSS department in partnership with the Tax Administration have developed the Low-Income Homeowners Relief Program. This program will serve exclusively Durham homeowners who have owned their homes 10 years or more, and who are currently not receiving any state tax subsidies for their property. Eligible homeowners must have incomes less than or equal to 30% of the average median income.

## **Ceremonial Items**

### **21-0654 Proclamation – Domestic Violence Awareness Month**

Commissioner Burns read the following proclamation:

#### **DOMESTIC VIOLENCE AWARENESS MONTH | 2020**

**WHEREAS,** the safety, security, physical and emotional wellbeing of our neighbors affects the lives of everyone in our community; we recognize that domestic violence takes a variety of forms and believe all individuals have the right to live their best and fullest lives free of violence and fear; and

**WHEREAS,** we recognize that 1 in 3 women and 1 in 4 men report experiencing severe violence by an intimate partner in their lifetimes, according to the National Coalition Against Domestic Violence, violence is a serious, preventable public health concern involving the manipulation of power and control, including willful intimidation, physical and sexual assault, emotional and financial abuse, and other abusive behaviors; and

**WHEREAS,** anyone can be a victim of intimate partner violence, regardless of gender, age, race, socioeconomic status, ability, or relationship choice. We believe that everyone deserves a life free of violence, regardless of gender identification, ethnicity, ability, age, religion, or social status; and

**WHEREAS,** we recognize that the crime of domestic violence impacts victims, families, and society, and can lead to long-term health problems, missed days of work and loss of employment, psychological distress, family instability and homelessness, and increased risk for future violence; and

**WHEREAS,** ending domestic violence starts with awareness and education, changing social norms about gender and violence, and mobilizing our communities, including men, boys, our faith institutions, the public, and private sectors.

**NOW, THEREFORE**, I, Brenda Howerton, Chair of the Durham Board of County Commissioners and on behalf of the **Durham** Board of County Commissioners, do hereby proclaim October 2021 as

**“DOMESTIC VIOLENCE AWARENESS MONTH”**

in Durham County. We urge all who engage with youth to teach and model respect, consent, and healthy relationships. We encourage government, health professionals, law enforcement, faith communities, and civic organizations to ensure an inclusive environment that supports survivors of domestic violence and sustains their efforts to rebuild their lives without violence in Durham. We are strongly committed to working with all partners so that every individual can access appropriate and affirming resources to address and end violence in our communities.

Vice Chair Jacobs stated the Board read the proclamation yearly due to domestic violence being a common statistic with local 9-1-1 calls and hoped to receive an update on domestic violence in Durham. Commissioner Burns encouraged the community to speak up about domestic violence and stated the holidays season would cause a spike in domestic violence. Chair Howerton shared a brief overview of domestic violence and the importance of educating the community on awareness.

**21-0628 Tax Administration Earns the IAAO Certificate of Excellence in Assessment Administration**

Dwane Brinson, Tax Administrator thanked the Board, Claudia Hager, Interim County Manager and the Tax Administration staff for their support and assistance in earning the Certificate of Excellence in Assessment Administration. Department staff shared their experience and overall excitement for the achievement – highlighting Mr. Brinson for motivating everyone.

The Board thanked Mr. Brinson and the Tax Administration staff member for becoming the fifth jurisdiction in North Carolina to earn the certification.

**21-0629 Tax Administration Staff Earns Thirteen (13) New International Designations**

Dwane Brinson, Tax Administrator stated Durham County Tax Administration as a single jurisdiction, earned more new designations than any other jurisdiction last year and assisted North Carolina in earning the coveted Virginia Cup. Mr. Brinson recognized the ten (10) Tax Administration staff members who earned the combined total of thirteen (13) new international professional designations. Corey Moore, Staff Development Supervisor stated staff had strived to become efficient and skilled tax professionals.

The Board thanked Mr. Brinson and the Tax Administration staff members for the achievement of international designations during the pandemic.

Mr. Fitts thanked the Board and Mr. Groves for the recognition of the award. He stated he was grateful to be an employee of the OES Division and thanked his co-workers for their support.

**21-0669 Proclamation – National Disability Employment Awareness Month**

**NATIONAL DISABILITY EMPLOYMENT AWARENESS MONTH | 2021**

**WHEREAS,** October 2021 marks the 76th anniversary of National Disability Employment Awareness Month; and

**WHEREAS,** National Disability Employment Awareness Month was first declared in October 1988 by Congress to increase awareness of the employment needs and contributions of individuals with all types of disabilities; and

**WHEREAS,** this year’s theme is America’s Recovery: Powered by Inclusion” which notes that people with disabilities must be fully included in our recovery from the COVID pandemic; and

**WHEREAS,** the goal of this observance is also to educate citizens about disability employment issues, work to eliminate barriers to employment and celebrate the many and varied contributions of America’s workers with disabilities; and

**WHEREAS,** workplaces such as Durham County that welcome the talents of all people, including people with disabilities, are a critical part of our efforts to build an inclusive community and strong economy.

**21-0671 Resolution – Supporting Federal Legislation that Protects Workers’ Right to Form or Join A Union**

Commissioner Carter read the following proclamation:

**“SUPPORTING FEDERAL LEGISLATION THAT PROTECTS WORKERS’ RIGHTS TO  
FORM OR JOIN A UNION”**

**WHEREAS,** H. R. 842 “Protecting the Right to Organize Act” passed in the U.S. House in early March 2021; and

**WHEREAS,** the bill attempts to dismantle barriers to union membership by giving employers and unions the freedom to establish contracts, allowing unions to collect fair-share fees to cover costs of collective bargaining and contract enforcement for the benefit of workers, and allow for impactful penalties against companies that violate rights of workers; and

**WHEREAS,** statistically speaking, union workers earn approximately 11.2% more in wages than their non-unionized peers and North Carolina has one of the lowest rates of union membership in the nation; and

**WHEREAS,** the legislation makes it an unfair labor practice to require or coerce employees to attend employer meetings designed to discourage union membership and prohibits employers from entering into agreements with employees under which employees waive the right to pursue or a join collective or class-action litigation; and

**WHEREAS,** H. R. 842 also allows collective bargaining agreements requiring all employees represented by the bargaining unit to contribute fees to the labor organization for the cost of such representation.

**NOW, THEREFORE, BE IT RESOLVED,** that we the Durham County Commission do hereby support the right of all workers to unionize, especially during this time of unprecedented challenges for workers.

**BE IT ALSO RESOLVED** that we wholeheartedly endorse the principles of H.R. 842, and in addition call on members of the U.S. Senate, including North Carolina Senators Richard Burr and Thom Tillis support this important bill when it comes before them.

**BE IT FURTHER RESOLVED** that a copy of this resolution be transmitted to Senators Richard Burr and Thom Tillis.

## **Items Pulled from the Consent Agenda**

**\*21-0619 Budget Amendment Ordinance No. 22BCC00040 Social Services to recognize \$9,116,036.60 in Additional ERAP funding through NCPRO (NC Pandemic Recovery Office) from both the Consolidated Appropriations Act (CAA) and the American Rescue Plan Act (ARPA) from the state's allocation for Durham County to provide emergency rental assistance payments for eligible families.**

Janeen Gordon, Department of Social Services (DSS) Assistant Director shared the *Durham Emergency Rental Assistance Program (ERAP)* which highlighted the following: Unites States Department of Treasury, Eligibility Requirements for ERAP, Treasury Regulations, Program Guidelines, Help to Assist Tenants Completing an Application, Durham ERAP, City/County Direct Funding Awards and Transition to State ERA Funds.

The Board asked if the application process changed. Ben Rose, DSS Director responded the City was creating a new application and residents with pending applications would not need to reapply. The Board recommended creating a data sharing application program to ensure all applications were valid and not duplicated. Mr. Rose responded the County tracked and verified all applications. The Board asked how many temporary staff were hired to assist with the program and if the ERAP information was being shared with the community. Mr. Rose replied 15 temporary staff were hired and Ms. Gordon stated DSS worked with the Public Information Office and the Community Development Department to provide the community with weekly updates.

**\*21-0620 Budget Ordinance Amendment No. 22BCC00041 for the Department of Social Services to recognize funds in the amount of \$984,919.90 as part of the American Rescue Plan Act (ARPA) to administer the Emergency Rental Assistance Program (ERAP 2.0) for Durham County to provide emergency rental assistance payments on behalf of the Department of Treasury.**

The following public comment was shared:

Public Comment

Ajax Woolley

Dear County Commissioners,

On behalf of the Durham CAN Housing team co-chairs, please accept the following comments on the County's portion of newly awarded federal funds for Emergency Rental Assistance, named ERA 2:

- Our Eviction issue campaign involves research to support community input on issues regarding Emergency Rental Assistance.
- These research actions include ongoing Court watching at Eviction court, community-wide engagement with tenants, and Listening Sessions with landlords, among other initiatives.
- ERA 1 (including the additional funding dubbed "ERA 1.1") is still an active area of concern for us and multiple other community organizations.
- Although the City portion of funds distributed by DSS through the February 2021 ILA is exhausted, pending applications from ERA 1, distribution of "ERA 1.1", and the lessons learned are of vital interest to the public, and developing future solutions will require radical transparency of data and due process.
- ERA 2 is a resource that requires careful administration and community input in order to successfully align with the County's Strategic Plan (specifically Goals 2 and 3).
- Durham CAN and other community organizations have a vested interest in ongoing participation with County and City leaders regarding the plans for short term distribution, as well as long-term structural changes that these ERA funds will support.

Thank you in advance for your efforts to include Durham CAN and other community organizations in the ongoing outreach and engagement regarding the urgent need for a transformative approach to County and City administration of federal funds.

**\*21-0658 Budget Ordinance Amendment No. 22BCC000038 - Transferring \$6,341,514 of General Fund Fund Balance to the Capital Financing Fund in Recognition of Final Sales Tax Collection from the Prior Year in Adherence to Board Policy.**

The Board asked why sales tax collections were increased from previous years. Keith Lane, Budget and Management Director responded the Commissioners would have to contact the State for clarification on the increase in sales taxes. He added Durham residents could have spent more money locally due to the pandemic. David Ades, Budget and Management Assistant Director stated sales tax collections were higher than expected and occupancy tax collections were lower than expected.


