The program's participation levels were recently expanded to include increasing the qualifying income to 80% of Area Median Income (AMI). Qualifications of the LIHR Pilot Program now include:
  - Property must be located in Durham County;
  - Must not participate in any State tax relief programs, such as the Homestead Exclusion;
  - Must have lived in home as a primary residence for at least the preceding ten (10) years;
  - Household gross income must not exceed 80% AMI, with priority funding going to those at 60% of AMI or less;
  - Qualifying applicants to receive grant benefit (payable directly to Durham County Tax Administration) for half of the current year tax bill up to a maximum of \$750.

### 21-0656 Proclamation - National Adoption Month

Vice Chair Jacobs read the following proclamation:

#### NATIONAL ADOPTION MONTH | 2021

- **WHEREAS,** the County of Durham recognizes the importance of giving children in foster care permanent, safe and loving families through adoption; and
- **WHEREAS,** every child deserves the opportunity to grow up in a loving, stable home and adoption is one way to build a family; and
- **WHEREAS,** caring adults can make all the difference in the lives of young people, sibling groups, children with special needs, and teenagers; and
- **WHEREAS,** more than 317 children in Durham County, NC are in foster care and of that total number of 16 children in Durham County, NC are legally free for adoption and waiting for permanent families; and
- **WHEREAS,** since November 2020 Durham County has successfully recruited families for children waiting to result in a total of 20 finalized adoptions, including 4 sibling groups and 3 older youth; and
- **WHEREAS,** this effort along with similar celebrations in all 50 states around the country will offer children the chance to live with stable and loving families and encourage other dedicated individuals to make a powerful difference in the lives of a child through adoption.

**NOW, THEREFORE,** I, Brenda Howerton, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby proclaim November 2021 as

#### "NATIONAL ADOPTION MONTH"

in Durham County. I commend this observance to our citizens and urge all citizens to join in raising awareness on behalf of the 16 children in Durham County who are waiting for a loving family. "Every Conversation Matters" when helping our youth in finding their permanent family. I further encourage communities, businesses, schools, faith-based organizations and families to start a conversation about adoption and "answer the call" to honor the special needs of Durham County's children in hopes of securing a permanent, loving family for each and every child regardless of race, age, gender, healthy, emotional or behavioral condition and past distress.

#### 21-0670 Proclamation – Veterans Day 2021

#### **VETERANS DAY | 2021**

- **WHEREAS,** each year, our Nation pauses to pay tribute to the many men and women who have pledged their allegiance to the United States Armed Forces; and
- **WHEREAS,** their loyalty to the military is evident in their commitment and willingness to make sacrifices to protect our country; and

### **Public Hearings**

# 21-0685 Public Hearing to Consider Allocating Economic Development Funds to Jaguar Gene Therapy

Andy Miracle, Economic Development Officer stated the Board was requested hold a public hearing to consider allocating a total of \$525,000 to Jaguar Gene Therapy and authorize the County Manager or Interim County Manager to enter into preliminary negotiations and execute an agreement. He added Jaguar Gene Therapy would locate a Good Manufacturing Practice facility in Durham, creating 200 jobs over 8 (eight) years and investing \$125 million dollars.

The Board asked how the County planned to verify companies were confirming to project details. Mr. Miracle replied the County worked with local partners to ensure companies were confirming to project details. The Board asked if the two (2) Durham Public School interns would be included in the annual report. Mr. Miracle responded yes.

Chair Howerton opened the public hearing.

#### Andrew Knudten, Chief Operating Officer at Jaguar Gene Therapy

Mr. Knudten thanked the Board for their support and stated the company was proud to become a part of the Durham community.

# Bryan Fox, Vice President of Public Policy at Greater Durham Chamber of Commerce

Mr. Fox commented on behalf of The Greater Durham Chamber of Commerce: The Commerce appreciated Durham County's continued support of opportunities and was happy to welcome Jaguar Gene Therapy to the Durham community.

The Board stated companies located in Durham were eco-friendly, supported local infostructure,

diversity and inclusion. Mr. Knudten added Jaguar Gene Therapy planned to connect with students of all ages and support the community.

Chair Howerton closed the public hearing and entertained a motion for approval.

Vice Chair Jacobs moved, seconded by Commissioner Burns to allocate a total of \$525,000 to Jaguar Gene Therapy and authorize the County Manager or Interim County Manager to enter into preliminary negotiations and execute an agreement with the Company.

# <u>21-0686 Resolution to Enact an Ordinance Prohibiting Discrimination in Public Accommodations</u> and Employment

The Board read the following resolution:

# A RESOLUTION TO ENACT AN ORDINANCE PROHIBITING DISCRIMINATION IN PUBLIC ACCOMMODATIONS AND EMPLOYMENT

- WHEREAS, Durham County welcomes all people and recognizes the importance of diversity and the importance of all people being free from discrimination based on race, ethnicity, creed, color, sex, sexual orientation, gender identity or expression, national origin or ancestry, marital or familial status, pregnancy, military status, religious belief or non-belief, age, or disability.; and
- **WHEREAS**, Durham County desires to safeguard the rights and opportunities of all persons to be free from discrimination in public accommodations and employment; and
- **WHEREAS**, on March 30, 2017, Section 3 of S.L. 2017-4 went in effect, preempting local governments from enacting and amending ordinances regulating public accommodations and private employment practices; and
- WHEREAS, Section 3 of S.L. 2017-4 expired on December 1, 2020; and
- WHEREAS, invidious discrimination and the tolerance of invidious discrimination is detrimental to the health, safety, and welfare of the citizens of Durham County and the peace and dignity which Durham County seeks to promote for all its residents; and
- WHEREAS, pursuant to North Carolina General Statute § 153A-121(a), "[a] county may by ordinance define, prohibit, regulate, or abate acts, omissions, or conditions detrimental to the health, safety, or welfare of its citizens and the peace and dignity of the county; and
- WHEREAS, pursuant to North Carolina General Statute § 153A-4, "[i]t is the policy of the General Assembly that the counties of this State should have adequate authority to exercise the powers, rights, duties, functions, privileges, and immunities conferred upon them by law. To this end, the provisions of this Chapter . . . shall be broadly construed and grants of

power shall be construed to include any powers that are reasonably expedient to the exercise of the power"; and

- **WHEREAS**, in 2020, the United States Supreme Court, in *Bostock v. Clayton County*, held that Title VII's prohibition on discrimination "because of . . . sex" includes discrimination on the basis of gender identity and sexual orientation; and
- **WHEREAS**, the Supreme Court's analysis and decision applies equally to other laws prohibiting discrimination on the basis of sex, a fact already recognized by the Federal government in the interpretation of other laws and regulations prohibiting discrimination on the basis of sex; and
- **WHEREAS**, the purpose and intent in enacting this Ordinance is to promote the principles of diversity, inclusion, harmony, and equal treatment for all and thereby the health, safety, and welfare of those who live in, work in, and visit Durham County as well as to promote the peace and dignity of Durham County; and
- **WHEREAS**, the Durham County Board of Commissioners hereby finds and determines that it is in the best interest of the citizens and residents of Durham County to enact this Ordinance.

**NOW**, **THEREFORE**, **BE IT ORDAINED AND RESOLVED** by the Board of Commissioners (the "Board") for the County of Durham, North Carolina (the "County").

Curtis Massey, Senior Assistant County Attorney stated he assisted the Board and County staff to achieve the ordinance for Durham community. Joanne Pierce, General Manager stated equity work was included in the ordinance and she was thankful for the resolution.

Chris Brook, Equality North Carolina (NC) and American Civil Liberties Union thanked the Board and staff for taking the proper steps to make it easier for all Durham County residents to feel safe and welcomed. Celeste Jones, Executive Assistant at Equality NC thanked the Board for the ordinance and hoped other counties would follow their lead.

The Board thanked Equity NC for leading the way and supporting the ordinance and thanked Attorney Massey and County staff for answering questions.

Commissioner Burns moved, seconded by Commissioner Allam to approve the resolution to enact an ordinance Prohibiting Discrimination in Public Accommodations and Employment.

The motion carried unanimously.

#### 21-0492 Durham County Public Health Focused Update on the COVID-19 Crisis

Rodney Jenkins, Director of Public Health shared the *COVID-19/Vaccine Distribution Updates* which highlighted the following: COVID-19 Layered Prevention Strategies, Current COVID-19 Statistics, Durham County COVID-19 Confirmed Cases, Current CODID-19 Race and Ethnicity Trends, COVID-19 Percent Positive Labs, CDC Vaccine Updates Durham County Residents, Vaccine Dashboard Data for Durham Residents, Number and Percent of Post Vaccination Cases, Vaccines by Month by

Race/Ethnicity, Attack Rate Increasing for Vaccinated Individuals, COVID-19 by Age, and Vaccine Dose (1, 2 and 3), Risk of Dying Increases for Unvaccinated Individuals, All COVID-19 Deaths Reported to Durham County Public Health Since March 17<sup>th</sup>, 2020, Educational Clusters, Usage and Capacity Hospitalization Data and Hold the Line with Masking.

The Board inquired about temperature checks at libraries. Mr. Jenkins replied Durham County was being cautious with temperature checks at building entrances to keep employees and residents safe. The Board expressed concern with Latino residents having a higher percentage of COVID-19 cases. Mr. Jenkins responded the County was working with community partners to level out cases with Latino residents. The Board asked if breakthrough cases were being tracked with demographic data. Mr. Jenkins replied yes, adding additional information would be shared with the Board.

### 21-0544 Renewable Energy Plan Update

Tobin Freid, Sustainability Manager shared the *Renewable Energy Plan* which highlighted the following: How Do We Use Energy, Definition, Renewable Energy Plan, Equity Considerations, Strategies, Energy Efficiency, Renewables, Fleet, Filling the Gap, Considerations, Approaches – Phased Versus Accelerated, Phased Investment, Accelerated Investment and Implementation.

The Board inquired about a timeline of the next report and if the County was planning to partner with the City. Ms. Freid replied the next report should be expected in February 2022 and the County was partnering with the City on the Green Source Advantage Program and was discussing solar panels. She added the County was discussing partnering with Durham Public Schools and other public entities as well.
