Monica Wallace, Clerk to the Board read the following announcements:

## 22-0026 Resolution – Honoring Mr. Linward Hedgspeth

Vice Chair Jacobs read the following resolution:

#### LINWARD HEDGSPETH

- WHEREAS, Linward Hedgspeth is a native of Rougemont in Durham County, North Carolina where he lives with his wife Anne as well as many extended Hedgspeth family members, he has two sons Daryl and Eric and daughter -in -law Latoya; and
- WHEREAS, Mr. Hedgspeth attained educational certifications and degrees from NC State University, Durham Technical Community College and the IBM Quality Institute and worked for IBM for 35 years as a Quality Engineering, New Product Manager in both Foreign and Domestic areas; and
- WHEREAS, Linward Hedgspeth is a dedicated member of the New Harris Grove AME Church where he has served in many roles including Board of Trustees Chair, Choir Vice President, Steward Board Chair, Usher, Sunday School Teacher and was recognized as Man of the Year in 2014; and
- WHEREAS, Mr. Hedgspeth is a long standing and committed member of the Rougemont Ruritan Club, an organization devoted to the well-being of the Rougemont community, serving as Director, and in the role of Committee Chair, and Mentor, and Vice President and President of the Rougemont Club; and
- WHEREAS, Linward Hedgspeth has served in numerous district and state leadership roles of North Carolina Ruritan including District Governor (2014-2015), District Lt. Governor (2013-

2014), Fundraising Chair, Cabinet Member and District Convention Planning Chair and President of the Association of North Carolina Ruritans and an Honorarius Member of the Association of Virginia since 2015; and

WHEREAS, Mr. Hedgspeth has risen to leadership roles at the National Level of Ruritan, as National Director (2016-2018), Convention Delegate (2008-2017), Convention Chair's Committee (2014, 2015), Sargent-at-Arms 2014, 2015 and Ruritan Forever Endowment and Tom Downing Fellow; and

WHEREAS, Linward Hedgspeth made history in 2019 as the first Black President- Elect and National President from 2020 to 2021 in the 93 year history of Ruritan National, a civic service organization founded in 1928 dedicated to "improving communities and building a better America through Fellowship, Goodwill and Community Service"; and

WHEREAS, National President Linward Hedgspeth and First Lady Anne Hedgspeth provided inspirational and transformative leadership for the nearly 25,000 Ruritan Club members in 900 local communities throughout the United States during the unprecedented and challenging time of a global pandemic and President Hedgspeth encouraged members to continue to help others with a focus on welcoming, listening to and mentoring new members and this strong vision: "Let's continue to focus our energy not on fighting the old, but on building the new, and SOARING LIKE AN EAGLE".

**NOW, THEREFORE, BE IT RESOLVED**, that we, the members of the Durham County Board of Commissioners, do hereby honor and celebrate the legacy of outstanding leadership and service to others of

#### LINWARD HEDGSPETH

in the Rougemont Community, Durham County, the state of North Carolina and throughout the United States of America and do hereby recognize and congratulate Mr. Hedgspeth on his groundbreaking and historic role as the first Black President of Ruritan National.

Linwood Hedgspeth, President of Ruritan National stated he was honored to represent the Durham community and thanked the Board for the recognition. Mr. Hedgspeth stated he served as President during a year with COVID-19 and learned to evolve and lead virtually.

The Board thanked Mr. Hedgspeth for becoming an inspired leader, representing the Rougemont community, years of service and acknowledged his groundbreaking role as the first Black National Ruritan President..

#### 22-0027 Resolution – Honoring the life and legacy of Archbishop Desmond Tutu

Chair Howerton read the following resolution:

#### ARCHBISHOP DESMOND TUTU

WHEREAS, South African Archbishop Desmond Tutu was born in 1931 and transitioned on December 26, 2021, at the age of 90; and WHEREAS, as a cleric in the Anglican church, Desmond Tutu successfully rose through the church ranks to become the Archbishop of Cape Town in 1986; and this theologian became widely known as a human rights activist, especially for his impact WHEREAS, as an anti-apartheid activist as he worked in concert with Nelson Mandela following Mandela's release from prison in 1990; and WHEREAS, Archbishop Tutu was a teacher, mentor, humanitarian and 1984 Nobel Peace Prize winner as a result of his tremendous body of work; and WHEREAS, past and present world leaders shared the following reflections of a life well lived: •South African President Cyril Ramaphosa called Archbishop Desmond Tutu "the spiritual father of our new nation." •Former President Barack Obama called him "A universal spirit... grounded in the struggle for liberation and justice in his own country, but also concerned with injustice everywhere,"; and •Former President Jimmy Carter noted "he lived his values in the long struggle to end apartheid in South Africa. WHEREAS, we pause to honor this insightful humanitarian and dedicated amazing life force who will always be remembered for his faith, his genuine sense of fairness and a love of others. NOW, THEREFORE, BE IT RESOLVED, that we, the members of the Durham County Board of Commissioners, do hereby resolve to pay tribute to the life and legacy of ARCHBISHOP DESMOND TUTU for a life of distinguished of service. ## 22-0030 Proclamation – National Mentoring Month

Commissioner Allam and Commissioner Carter read the following proclamation:

#### **NATIONAL MENTORING MONTH | 2022**

- WHEREAS, created in 2002 by the Harvard School of Public Health and MENTOR: the National Mentoring Partnership; January 2022 marks the 20th anniversary of National Mentoring Month, an annual campaign to focus attention on the need for quality, consistent and competent mentors, and;
- WHEREAS, a mentor is a caring, dependable and authentic person that provides support, guidance, advice, assistance and devotes time to a young person to help youth discover personal strength to persevere and achieve their potential through a structured and trusting relationship on a regular basis; and
- WHEREAS, quality mentoring encourages and empowers youth to make positive choices, promote self-esteem and character development, support academic achievement, social-emotional learning, leadership and professional development, college readiness and career exploration; and
- WHEREAS, the goals of National Mentoring Month are to raise awareness of mentoring, recruit individuals to mentor, equip mentors with the skills needed to support youth, encourage organizations to engage and integrate quality mentoring into their efforts with a focus on academic support, life skills training, and career readiness/workforce preparation to motivate youth to excel; and
- **WHEREAS,** during the COVID-19 pandemic, mentoring programs have stepped up to fill gaps for youth and families, connecting them with resources and ensuring that mentoring relationships continue virtually to prevent social disconnection and mitigate learning loss; and
- WHEREAS, positive youth development theory understands adolescence as a distinct developmental phase where boundary testing and individual identity development are critical steps on the path to adulthood, steps that need to be supported, nurtured and cultivated by patient and caring adults in safe environments; and
- WHEREAS, research shows that youth who meet regularly with their mentors are more than 52 percent less likely than their peers to skip a day of school, youth who face an opportunity gap but have a mentor are 55 percent more likely to be enrolled in college than those who did not have a mentor; youth who meet regularly with their mentors are 46 percent less likely than their peers to start using drugs and 27 percent less likely to start drinking; and
- WHEREAS, mentors serve a critical role in helping youth successfully complete high school and gain admission to college or training program, earn a post-secondary credential or certification, build new in-demand skills, prepare for the future of work and succeed in an ever-changing workforce; and
- WHEREAS, mentoring programs must incorporate work-based learning to prepare and connect youth with real-life work experiences where they can apply academic, technical and soft skills and develop their employability while exploring career pathways; and
- **WHEREAS**, the Durham County Strategic Plan Goal 1 is to provide access to educational, vocational, economic and cultural opportunities while empowering citizens to choose pathways for their own success;

WHEREAS, the Durham Board of County Commissioners supports community-based mentoring programs as key community partners to support our mission for a safe, healthy and vibrant community; and

**WHEREAS,** National Mentoring Month is the time of year to celebrate, elevate, and encourage mentoring and recruit caring adult mentors in Durham County;

**NOW THEREFORE**, I, Brenda A. Howerton on behalf of the Durham Board of County Commissioners do hereby proclaim the month of January 2022 as

#### "NATIONAL MENTORING MONTH"

and call upon public officials, educators, business and community leaders, and citizens to observe this month with appropriate ceremonies, activities and programs in order to:

- recognize individuals who serve as staff and volunteers at quality mentoring programs and help our youth find inner strength and reach their full and unlimited potential;
- acknowledge that mentoring is beneficial because it facilitates healthy identity development, encourages educational achievement, reduces juvenile delinquency, expands career readiness, improves life skills and outcomes, and strengthens communities;
- promote the creation, expansion, sustainability, and funding of quality mentoring programs across Durham to equip youth with the tools needed to lead healthy, productive and meaningful lives; and
- support initiatives to close the academic, achievement, opportunity and mentoring gaps and promote critical mentoring to support boys of color with mentors who perceive and understand social, political and economic racism and oppression and to take action against racism and oppressive elements of society.

# <u>22-0035 Resolution – Celebrating and Honoring the Life and Services of Dr. Martin Luther King, Jr.</u>

Commissioner Burns read the following resolution:

## CELEBRATING & HONORING THE LIFE & SERVICE OF DR. MARTIN LUTHER KING, JR.

whereas, a champion of nonviolence and justice, Dr. Martin Luther King, Jr. devoted his life to strengthening the content of American character and fought unrelentingly for the civil rights of all Americans and taught us that courage displaces fear, love transforms hate, acceptance dissipates prejudice and mutual regard cancels enmity; and

- **WHEREAS**, in the face of hatred and violence, Dr. King preached a doctrine of nonviolence and civil disobedience to combat segregation, discrimination, and racial injustice, and believed that people have the moral capacity to care for other people; and
- **WHEREAS**, Dr. King was one of the leaders of the successful 381 day Montgomery bus boycott in 1955 to protest the arrest of Rosa Parks and the segregation of the bus system; and
- WHEREAS, Dr. King helped found and served as the first president of the Southern Christian Leadership Conference in 1957 to coordinate and support nonviolent direct action as a method of desegregating bus systems across the South; and
- WHEREAS, between 1960 and 1964, Dr. King spoke in Durham at White Rock Baptist Church, the Durham Business & Professional Chain, Hillside High School, the Southern Political Science Association at the Jack Tar Hotel, North Carolina College (now North Carolina Central University) and Duke University urging civil disobedience and nonviolent protests to end racial segregation and discrimination; and
- **WHEREAS**, Dr. King traveled more than 6,000,000 miles, spoke more than 2,500 times, and wrote 5 books and numerous articles supporting efforts around the country to end injustice and bring about social change and desegregation between 1957 and 1968; and
- WHEREAS, on August 28, 1963, Dr. King led the March on Washington for Jobs and Freedom, the largest rally of the civil rights movement, during which, from the steps of the Lincoln Memorial and before a crowd of more than 200,000 people, Dr. King delivered his famous "I Have a Dream" speech in which he called for an end to racism and advocated for the civil and economic rights of African Americans; and
- WHEREAS, the March on Washington was instrumental in the passage of the Civil Rights Act of 1964 which outlawed discrimination based on race, color, religious sex or national origin and prohibited unequal application of voter registration requirements and racial segregation in schools, employment and public accommodations; and
- WHEREAS, Dr. King helped to organize the monumentally inspiring Selma to Montgomery marches in 1965 to advocate for passage of the Voting Rights Act of 1965 to guarantee African American citizens the right to vote; and
- WHEREAS, Dr. King was supporting the garbage workers in Memphis, Tennessee, and planning the Poor People's Campaign to promote economic justice, when he was assassinated in Memphis on April 4, 1968; and

**NOW, THEREFORE, BE IT RESOLVED**, we the Durham Board of County Commissioners do hereby resolve to recognize and honor the life and work of Dr. Martin Luther King, Jr. and his commitment to improve the human condition of all people through the adoption of a racial equity framework for governmental decision-making, access to quality education, affordable housing, equal opportunity, shared prosperity, living wage employment, safe and humane labor conditions for all employees and quality healthcare.

**BE IT FURTHER RESOLVED THAT** the Durham Board of County Commissioners call on the residents of Durham County to join us in reflecting on and advancing Dr. King's life and fulfilling his dream.

#### **Other Business**

#### 22-0033 Durham County Public Health Focused Update on the COVID-19 Crisis

Rodney Jenkins, Director of Public Health shared the *COVID-19/Vaccine Distribution Updates* which highlighted the following: COVID-19/Vaccine Distribution Updates, COVID-19 Prevention Strategies, Current COVID-19 Strategies, Current COVID-19 Race and Ethnicity Trends, COVD-19 Percent Positive Labs, Usage and Capacity Hospitalization Data, Vaccine Updates, CDC Vaccine Updates Durham County Residents, Vaccine Dashboard Data for Durham Residents, Free COVID-19 Testing, Testing Updates, Mask Guidance, Mask Distribution Update and Final Thoughts.

The Board inquired about an email portal for residents with questions. Mr. Jenkins replied Public Health does not have an email portal setup for resident questions; however, he would check into establishing that system. The Board questioned the combination of the flu and COVID-19. Mr. Jenkins responded 'Flurona' was a term used to describe when a person was diagnosed with the flu and COVID-19 at the same time; he noted the different variants were highly transmittal and could be contacted easily. The Board asked if the contracted community-based organizations could assist with distribution of at-home COVID-19 test and mask for residents in need. Mr. Jenkins stated the contract with those organizations

expired in December 2021 – adding he would check into a contract extension or the possibility of the organizations willingness to assist without a contract in place. The Board inquired about Durham Public Schools (DPS) receiving mask and asked that the presentation be available for the public. Mr. Jenkins responded he would contact DPS regarding the mask being made available to the County; he also added that the presentation would be available on the public health website.

# 22-0025 Approval of Interlocal Agreement between Durham County and the City of Durham for a Temporary COVID-19 Testing Site

Rodney Jenkins, Public Health Director stated Wheels Fun Park located at 715 North Hoover Road in Durham would become a temporary COVID-19 testing site. He added Wheels was chosen due to the site location, ability to handle a large volume of cars and the accessible by public transportation.

The Board thanked the City for allowing Wheels to be used as a testing site and for a partnership to help better serve the residents of Durham.

Vice Chair Jacobs moved, seconded by Commissioner Burns to approve the Interlocal Agreement between Durham County and the City of Durham for a temporary COVID-19 testing site.

The motion carried unanimously
