Public Hearings

22-0736 Public Hearing - Resolution Requesting the North Carolina Department of Transportation Designate a Certain Portion of North Carolina Highway 751 and Cameron Boulevard from Kerley Road to Duke University Road in Honor of Coach Michael William Krzyzewski

Jay Gibson, General Manager of Environmental Stewardship and Community Prosperity stated the Board was requested to conduct a public hearing and adopt a resolution requesting the North Carolina Department of Transportation (NCDOT) to designate a certain portion of Highway 751 and Cameron Boulevard from Kerley Road to Duke University Road in honor of Coach Michael William Krzyzewski.

Commissioner Burns read the following resolution:

RESOLUTION REQUESTING THE NORTH CAROLINA DEPARTMENT OF TRANSPORTATION DESIGNATE A CERTAIN PORTION OF NORTH CAROLINA HIGHWAY 751 AND CAMERON BOULEVARD FROM KERLEY ROAD TO DUKE UNIVERSITY ROAD IN HONOR OF COACH MICHAEL WILLIAM KRZYZEWSKI

WHEREAS, North Carolina General Statute 136-18(8) grants the North Carolina Department of Transportation (NCDOT) authority to name or designate certain highway assets in honor of North Carolinians who have made notable contributions to the State and its residents;

WHEREAS, Coach Michael William Krzyzewski, better known as "Coach K," has distinguished himself and brought honor to the State of North Carolina in myriad ways including military service to our Nation, serving as Head Coach of the Duke University Men's Basketball

program for 42 consecutive years, compiling an impressive record of 1,129 wins and five NCAA National Championships while Duke's Head Coach and an unparalleled Division I record of 1,202 wins in total while serving as a Head Coach;

- **WHEREAS**, Coach K served with distinction on over 21 different USA Basketball coaching staffs for which these teams achieved over a 95% winning record;
- **WHEREAS**, Coach K further served as the Head Coach for the US Olympic Men's Basketball Team, becoming the only Olympic Head Coach to ever win three consecutive men's basketball gold medals;
- **WHEREAS**, Coach K has further invested in the well-being of the Durham community, more especially its young people, via the founding and ongoing support of the Emily K Center which now serves more than 2,000 students of various grade levels annually;
- WHEREAS, the Durham County Board of Commissioners wishes to honor Coach K by supporting the request of Duke University to honorarily designate a portion of N.C. Highway 751 and Cameron Boulevard from Kerley Road to Duke University Road, as "Coach K Highway".
- **WHEREAS**, a Public Hearing was held on the matter on January 9, 2023 by the Board of Commissioners.

NOW THEREFORE, BE IT RESOLVED that the Durham County Board of Commissioners adopts this Resolution in enthusiastic support of Duke University's request to petition the North Carolina Department of Transportation to honorarily designate a portion of N.C. Highway 751 and Cameron Boulevard from Kerley Road to Duke University Road, as "Coach K Highway".

Commissioner Burns recommended amending the resolution to add Coach Krzyzewski winning five national championships. Mr. Gibson responded he would contact NCDOT about the maximum words acceptable in the resolution and would add the amendment if feasible.

Katie Lipe, Duke University, Assistant Director Duke-State Relations made the following statement:

"To honor Coach K's illustrious 42-year career as head coach of the Duke University men's basketball team and to recognize his decades of service and leadership in Durham County, North Carolina, and nationally, Duke University is seeking to honorarily designate a portion of NC Highway 751 and Cameron Boulevard from Kerley Road to Duke University Road in Durham. The North Carolina Board of Transportation requires support from local governments in the form of a unanimously passed resolution and letters of support from civic, business and service organizations in the county. The Emily K Center, the Durham Chamber of Commerce, and State House Representatives Marcia Morey and Vernetta Alston from Durham have all provided letters of support for this honorary designation, and the Durham City Council unanimously passed a resolution in support of the road designation in December. We greatly appreciate the Durham County Board of Commissioners' willingness to consider this resolution tonight."

Acting Chair Carter opened the public hearing.

Monica Wallace, Clerk to the Board stated there were no public comments.

Acting Chair Carter closed the public hearing.

Ms. Wallace showed a recorded video with comments from Chair Howerton and Vice Chair Jacobs. The Board thanked Coach Krzyzewski for his accomplishments at Duke and his support for the Durham community.

Commissioner Burns moved, seconded by Commissioner Allam to adopt the resolution requesting NCDOT to designate the specified portion of Highway 751 in honor of Coach Michael William Krzyzewski.

The motion carried unanimously

Directive: Commissioner Burns recommended amending the resolution to add Coach Krzyzewski winning five national championships.

Adjournment

Commissioner Allam moved, seconded by Commissioner Burns to adjourn the Regular Session meeting at 7:33 p.m.
