23-0183 Proclamation – 2023 as Year of the Trail in North Carolina

Vice Chair Jacobs read the following resolution:

YEAR OF THE TRAIL | 2023

- **WHEREAS**, Durham County's natural beauty and access to recreation are critical to its residents' quality of life, health, and economic wellbeing; and
- **WHEREAS**, Durham County's natural assets and resources are integral to disaster recovery and resiliency to climate change for future generations; and
- **WHEREAS**, Durham County's nature preserves and partnership parks are welcoming to all and provide a common ground for people of all ages, abilities and backgrounds to access our rich and diverse natural, cultural, and historic resources; and
- **WHEREAS**, trails offer quality-of-life benefits to all as expressions of local community character and pride, as outdoor workshops for science education, as tools for economic revitalization, as free resources for healthy recreation, as accessible alternative transportation, and as sites for social and cultural events; and
- WHEREAS, Durham County provides foot and mountain-biking trails within our nature preserves that are an integral part of our County's outdoor recreational opportunities and promote an appreciation of Durham's natural resources by residents and visitors; including 20 miles of natural surface trails and biking trails at Hollow Rock Park, Little River Regional Park, and New Hope Preserve, and
- WHEREAS, Durham County supports several significant regional trails including the East Coast Greenway that stretches 3,000 miles from Maine to Florida, connecting Durham to 450 cities and towns and 15 states; and the Mountains-to-Sea Trail that stretches across North Carolina for more than 1,000 miles from the mountains to the coast; and
- WHEREAS, North Carolina is known as the "Great Trails State;" and

- **WHEREAS,** the North Carolina General Assembly designated 2023 as the Year of the Trail in North Carolina to promote and celebrate the state's extensive network of trails that showcase our state's beauty, vibrancy and culture; and
- **WHEREAS,** Durham County will host or participate with our partners in several events during 2023 that will highlight and celebrate Trails in Durham County

NOW, THEREFORE BE IT RESOLVED, I, Brenda Howerton, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby proclaim 2023 as

"THE YEAR OF THE TRAIL"

in Durham County, North Carolina.

Brendan Moore, Open Space Land Manager thanked the Board for the proclamation and their continued support. He added throughout 2023, trail events would be held across the state to celebrate and encouraged residents to attend the events.

The Board asked how Durham County trails would be highlighted and advertised for residents to use and explore. Mr. Moore replied signs placed in parks and information posted on social media. The Board reminded residents about the Durham County Open Space Matching Grants Program.

<u>23-0189 Resolution – Honoring the Retirement of the Honorable US Congressman David E. Price</u> Chair Howerton read the following resolution:

HONORABLE U.S. REPRESENTATIVE DAVID EUGENE PRICE

- **WHEREAS,** this Tennessee native, received his formal education, first at Mars Hill University then transferred to the University of North Carolina at Chapel Hill where he earned a B.A degree in history and mathematics, and then to Yale University where he earned a Bachelor of Divinity degree and a Ph.D. in political science; and
- WHEREAS, David Price was first elected to the U. S. House of Representatives in 1986 to serve the North Carolina's 4th Congressional District; and
- **WHEREAS,** Price worked for the North Carolina Democratic Party, serving as its executive director and eventually the state chair prior to his election to Congress; and
- **WHEREAS,** he represented North Carolina for a total of 34 years during two separate terms of service from 1986-1994 and again from 1996 until his retirement in 2022; and
- WHEREAS, during his congressional service he was highly regarded for his leadership including his work as Chairman of the Transportation and Housing Appropriations Subcommittee,

along with service on the House Budget Committee, and the Appropriations Subcommittee for Homeland Security and more; and

- **WHEREAS,** throughout his tenure he courageously fought to enact legislation and policies centered around helping the least among us, and worked to level the playing field for those without an effective voice; and
- **WHEREAS,** one only needs to drive through the Research Triangle Park region to witness the impact of his public service which brought substantial federal funding for infrastructure projects, job training, airport upgrades, economic development expansions and more; and
- WHEREAS, in his final term of office, Representative Price ensured that the 4th District received \$35.9 million in community project funding, and that Durham County residents received \$700,000 for Hayti Reborn to bring a coordinated effort to reduce community violence through methods such as educational programming, reentry services, and mentorship opportunities, along with \$750,000 for Ross Road Apartments to redevelop distressed housing into quality multi-bedroom apartments to serve low and very low-income households, including supportive housing for formerly unhoused individuals and families; and
- **WHEREAS,** Representative Price will long be celebrated for demonstrating diversified skills and abilities, critical thinking, tough negotiation, and strategic planning efforts, that helped him effectively maneuver the many complexities of successfully operating in Congress for many years.

NOW, THEREFORE, BE IT RESOLVED, that we, the members of the Durham County Board of Commissioners, do hereby resolve to express our most sincere and deepest appreciation to

U.S. REPRESENTATIVE DAVID EUGENE PRICE

For his passion, advocacy and productivity representing the residents of the 4th District for 34 years with distinction.

Public Hearings

23-0181 Public Hearing – Zoning Map Change, Kempski Milstead Home (Z2200026)

Alexander Cahill, Senior Planning Manager stated the Board was requested to conduct a public hearing and receive public comments on the Zoning Map Change, Kempski Milstead Home (Z2200026) which proposed to change the zoning designation of one parcel of land, totaling 22.584 acres located at 220 and 214 Riley Drive. He added the current zoning was Residential Rural with a Development Plan (RR(D) with a proposed change to Residential Rural to facilitate the construction of a single-family home. Mr. Cahill stated the proposal was a general rezoning with no text or graphic development plan.

Chair Howerton opened the public hearing.

Sam Milstead, Caitlin Kempski's Husband

Mr. Milstead stated his wife submitted the application to construct a house on the property and to remove the provision of a disc golf course.

The Board confirmed the property was zoned for a disc golf course that was never developed and the rezoning was similar to adjacent properties.

Chair Howerton close the public hearing.

First Motion:

Commissioner Allam moved, seconded by Commissioner Burns to adopt an ordinance amending the Unified Development Ordinance by taking property out of Residential Rural with a Development Plan (RR(D)), Falls/Jordan District-B (F/J-B) and establishing the same as Residential Rural (RR), Falls/Jordan District-B (F/J-B).

The motion carried unanimously.

Second Motion:

Vice-Chair Jacobs moved, seconded by Commissioner Allam to adopt the appropriate Statement of Consistency pursuant to NCGS §160D-605.

The motion carried unanimously.

23-0182 Public Hearing – Zoning Map Change, Blanchard Property (Z2200046)

Alexander Cahill, Senior Planning Manger stated the Board was requested to conduct a public hearing and receive public comments on Zoning Map Change, Blanchard Property (Z2200046) which proposed to change the zoning designation of one parcel of land totaling 3.073 acres located at 2935 US 70 Highway East. He added the current zoning was Residential Rural (RR) and Commercial General (CG) and proposed the designation to be entirely Commercial General (CG) to facilitate future commercial

development. Mr. Cahill stated the proposal was a general rezoning with no textual or graphic development plan.

The Board asked about rezoning the property for commercial use without access to public services. Mr. Cahill responded the property would need to be annexed into the City to receive public services. The Board asked if the applicant was encouraged to make bicycle and pedestrian improvements. Mr. Cahill replied the rezoning was text only and did not require a development plan. The Board inquired about the next steps if the rezoning was approved. Mr. Cahill responded the rezoning would go before the Planning Commission and then go before City Council.

The Board requested that the County supplement be included in the education impact cost to reflect the true total cost and asked if Emergency Medical Services (EMS) and Fire Services cost were included with the rezoning. Mr. Cahill replied due to EMS staffing shortages, EMS was unable to provide an administrative reviewer and Fire Services were not include in the rezoning changes. The Board requested EMS and Fire Services cost to be included with the rezoning cost model.

The Board asked if Commercial General zoning allowed residential and the proximity of health care locations. Mr. Cahill responded high-density residential and primary care was available in the area, although specialists were not. The Board inquired about available commercial uses due to not knowing what would be built on the property. Mr. Cahill responded self-storage, retail and pawn shops were examples of possible uses. The Board expressed process concerns and storm water impacts if the property was developed. Mr. Cahill replied if the rezoning was approved, the process concerns would be addressed at the site plan stage.

Chair Howerton opened the public hearing.

Randy Herman, Attorney at BA Folk

Mr. Herman stated he was representing the applicant who inherited the property from parents and was not a developer. He added the goal was to change the zoning to match surrounding parcels and to sell the property. Mr. Herman stated the property was submitted to the City for annexing and rezoning and the City would not approve.

The Board asked why the City denied annexing and rezoning. Mr. Cahill replied annexing required knowing what would be built on the property and a cost model would need to be provided.

Chair Howerton closed the public hearing.

Vice-Chair Jacobs stated she would approve the rezoning, although she was concerned with the unknown of what would be built on the property and with the wide range of available commercial uses.

First Motion:

Commissioner Burns moved, seconded by Commissioner Allam to adopt an ordinance amending the Unified Development Ordinance by taking property out of Residential Rural (RR) and Commercial General (CG), Falls/Jordan District-B (F/J-B) and establishing the same as Commercial General (CG), Falls/Jordan District-B (F/J-B).

The motion carried unanimously.

Second Motion:

Commissioner Burns moved, seconded by Vice Chair Jacobs to adopt the appropriate Statement of Consistency pursuant to NCGS §160D-605.

The motion carried unanimously

Directives:

- Vice Chair Jacobs asked Planning staff to include the County supplement in the education impact cost.
- Vice Chair Jacobs asked Planning staff to include EMS and Fire Services cost with the rezoning cost model.

23-0198 Public Hearing to Adopt the Resolution related to Not to Exceed \$235,000,000 Limited Obligation Bonds, Series 2023A and 2023B

Susan Tezai, Chief Financial Officer stated the Board was requested to hold a public hearing on the negotiation of an amendment to an installment financing contract in connection with the execution and delivery of not to exceed \$235,000,000 Limited Obligation Bonds (LOBs) and the related projects to be financed and refinanced thereby.

The Board asked for a purpose overview for the resolution. Ms. Tezai responded the resolution would approve the execution and delivery of an amendment to an installment financing agreement to provide long-term financing for a port of the projects originally financed by the County's 2021 A and B Limited Obligation Bonds, finance additional County projects, and refund for saving of the County's outstanding 2012 and 2013 Limited Obligation Bonds. The Board asked if the LOBs would provide debt service for County purchases. Ms. Tezai responded yes, adding would finance \$86 million in projects including the Shoppes at Hope Valley, Snow Hill Pump Station and the New Youth Home.

Monica Wallace, Clerk to the Board reported to the Board that a notice of a public hearing relating to financing the projects described in pursuant to an amendment to an installment financing contract in a principal amount not to exceed \$235 million dollars on March 23, 2023 stating the Board would hold the public hearing on March 13, 2023.

Vice-Chair Jacobs moved, seconded by Commissioner Carter to open the public hearing.

The motion carried unanimously.

No citizens were signed up to speak.

Commissioner Allam moved, seconded by Commissioner Burns to close the public hearing.

The motion carried unanimously.

Vice-Chair Jacobs moved, seconded by Commissioner Allam to adopt the resolution

(the "Resolution") which authorized the negotiation of an amendment to an installment financing contract in connection with the execution and delivery of not to exceed \$235,000,000 Limited Obligation Bonds. The resolution approved the execution and delivery of an amendment to an installment financing agreement in order to provide long-term financing for a portion of the projects originally financed by the County's 2021A and B Limited Obligation Bonds, finance additional County projects, and refund for savings of the County's outstanding 2012 and 2013 Limited Obligation Bonds. In addition, the resolution authorizes County staff to execute and deliver the amendment and documents related thereto.

The motion carried unanimously.

Other Business

23-0143 Department of Social Services Updated Child Welfare Placement Protocol and Guidelines The Board was requested to hear from DSS on the updated protocols for placement of children with medically complex needs.

Jovetta Whitfield, Assistant Director Child and Welfare Services stated Durham County prioritized placing children in their custody in a non-institutional setting where the children could live in a family-like, community-based setting. She added prior to children being placed in a facility, multi-level staffing occurred and included the involvement of a Program Manager. Ms. Whitfield stated the County strived to identify and maintain a single, stable, community-based placement for children in their custody who have medically complex needs and were at risk of institutionalization due to their medical needs. She stated the following guidelines and protocols were added to describe how the County recruits, identifies, and secures community-based placement for those children: Prioritization of Non-Institutional Settings, Prioritization of Family Placements, Recruitment of Resource Parents who can Care for Medically Complex Children, Informing Resource Parents and Agencies about how Durham County will Help them Care for Medically Complex Children.

Elizabeth Simpson, Citizen and Emancipate North Carolina Strategic Director & Attorney

Ms. Simpson stated she submitted a public record request with the Department of Social Services (DSS) and was not provided with the requested information. She added only after filing a lawsuit against DSS was the information received. Ms. Simpson stated the updated Child Welfare Placement Protocol changes were due to the lawsuit and DSS withholding information from the public.

The Board asked if resource parents were required to work and if the requirement was by law. Ms. Whitfield responded resources parents were required to be able to support their household without a stipend from the State and the requirement was not a law. The Board asked if the protocols were the same in a hospital and other institutions. Ms. Whitfield replied not all, but some of the protocols were the same.

The Board thanked Ms. Whitfield for the update.
