

## **April 2023 ANNOUNCEMENT**

The Durham Board of County Commissioners solicits applicants to fill positions on the following citizen boards and commissions:

- Adult Care Home Community Advisory Committee (17 At-Large Positions)
  - o This committee's primary function is to maintain the rights of residents living in adult care homes including assisted living facilities and family care homes. They serve as the link between the community and the homes, seeking to increase community involvement and, at the same time, promoting community education and awareness of the needs of the residents in these homes.

<u>Special Requirements:</u> 6-24 hours per quarter, 15 hours of initial training before visits can begin, must complete 10 hours of annual training and must serve on a subcommittee. Miscellaneous: 1 hour per week responding to phone calls, emails and subcommittee meetings.

- Bicycle and Pedestrian Commission (1 "Duke University Representative" Position)
  - o The Durham Bicycle and Pedestrian Advisory Commission (BPAC) advises the Board of County Commissioners on questions relating to bicycle and pedestrian issues. The commission consists of 17 members with seven members appointed by the Board of County Commissioners representing citizens in subject areas such as bicycle commuting, urban trails and greenways, university students/university facilities, transportation planning/policy, recreation/recreation business and Inter-Neighborhood Council.
- City-County Appearance Commission (3 At-Large Positions)
  - o The mission of the commission is to cultivate excellence in design, communicate the economic, social and aesthetic value and to celebrate exemplary design within the community. Applicant shall have expertise in a design field such as architecture, landscape design, city planning, horticulture, urban design or a related field.
- Community Child Protection/Child Fatality Prevention Team (1 "(Parent of) Death of Child before 18" Position)
  - o This team promotes the development of a community-wide approach to the problems of child abuse and neglect and seeks ways to protect children from preventable deaths. The team reviews selected cases that are being serviced by child protective services and cases in which a child has died of suspected abuse or neglect.
- Dangerous Dog Appeal Board (1 "County Employee" Position)
  - o Designated as the board to hear all reviews and appeals authorized by the Durham County Animal Control Ordinance. The Dangerous Dog Appeal Board was established by the Board of County Commissioners, pursuant to General Statute 67-4.1 (c). It is as a five-member board responsible for hearing the appeal of dog owners who have had their dogs declared dangerous or potentially dangerous.
- Durham Open Space and Trails Commission (1 "Carr/Oak Grove Township" Position)
  - o Advises the City Council and the Board of Commissioners on matters relating to open space preservation and trail development while involving and educating all segments of the Durham community.
- Historic Preservation Commission (1 At-Large Position)
  - o The Historic Preservation Commission (HPC) holds quasi-judicial public hearings to determine whether requested changes to the exterior of historic district or landmark properties are appropriate by State law, local ordinance and historic preservation plans for the districts.
- Durham Racial Equity Commission (1 "Leader/Community Organizer of Community-Rooted Organization Based Position)
  - o Advise local government entities regarding the implementation of City-County-DPS specific recommendations from the City of Durham Racial Equity Taskforce Report.

- Farmland Protection Advisory Board (2 Positions: 1 "Cape Fear VAD" Position and 1 "Business Representative" Position)
  - o The Farmland Protection Advisory Board seeks to promote the best use of land in Durham County so that development and growth will be accompanied by protection of our attractive and ecologically desirable forests and farms.
- Juvenile Crime Prevention Council (1 At-Large Position)
  - o The council reviews the needs of Durham juveniles who are at risk of delinquency or who have been adjudicated, undisciplined, or delinquent, review and evaluate the resources available to address those needs, develop and implement a request for proposals process, and submit a written plan of action for the expenditure of juvenile sanction and prevention funds to the Durham Board of County Commissioners.
- Nursing Home Community Advisory Committee (11 At-Large Positions)
  - This committee is responsive to the needs of nursing home residents and promotes community involvement and cooperation with nursing homes. Members must be County residents and have no financial interest (directly or indirectly) in a nursing home, and no immediate family of a resident can be on the committee.

    Special Requirements: 6 hours of initial required official training; 1.5-6 hours required per month for committee meetings, nursing home visits and unofficial training. Requested to participate in various community events.
- Raleigh-Durham Airport Authority (1 At-Large Position)
  - o The authority was created by the N.C. General Assembly to develop, operate and maintain the Raleigh-Durham Airport Authority. The authority is made up of eight representatives, two of each from the City of Durham, Durham County, the City of Raleigh, and Wake County.
