#### 23-0240 Proclamation - Second Chance Month

Commissioner Allam read the following proclamation:

## **SECOND CHANCE MONTH | 2023**

- **WHEREAS,** more than 400 Durham County residents return to our community from state and federal prisons and nearly 6,600 cycle through our local detention facility annually; and
- **WHEREAS,** Durham County Government and its Board of County Commissioners have been supporting reentry and rehabilitation efforts in Durham County for more than 30 years; and
- **WHEREAS,** effective reentry programs offer the chance for a better life to those who return from our nation's corrections facilities; and
- **WHEREAS,** it's up to all of us, working together, to emphasize the importance of these programs and policies that make such a positive and lasting difference, not only to the individuals served, but to the communities in which they return; and
- **WHEREAS,** over the last thirteen years, the US Department of Justice has partnered with state, local and tribal agencies as well as national organizations to support hundreds of reentry programs across the country, yet the demand for effective reentry programs remains high; and
- WHEREAS, in an effort to highlight the important work of these services, the US Department of Justice has designated April as Second Chance Month and has called upon communities across the country to plan and host appropriate events, ceremonies and activities in observance; and
- **WHEREAS,** the Durham County Board of County Commissioners joins the effort to highlight the value of local reentry programs and calls upon the Durham community to support their work. The investments we make today through the resources we dedicate, and the enthusiasm we generate, will greatly benefit the returning citizens and the overall public safety in Durham County.

**NOW THEREFORE**, I, Brenda A. Howerton, Chair and on behalf of the Durham Board of County Commissioners do hereby proclaim the month of April 2023 as

#### 23-0241 Resolution - Honoring Vernon O'Mar Taylor

Commissioner Carter read the following resolution:

#### **VERNON O'MAR TAYLOR**

- WHEREAS, on Thursday, February 16, 2023, the Durham community lost a valued member and leader with the death of Vernon O'Mar Taylor, a devoted husband to his wife Karen Henrya and a proud father; and
- WHEREAS, O'Mar Taylor was born and raised in East Orange, New Jersey where he worked as a Residential Case Manager at Housing Works, developing his lifelong passion for quality housing; aiding those suffering from homelessness, incarceration, mental health, and chronic disease and addiction, moving to Durham in 2001; and
- WHEREAS, O'Mar was a local housing provider and the leader of "Just A Clean House, Inc.", a non-profit organization that has provided sober living for formerly incarcerated individuals and individuals in recovery since 2005; creating a transitional housing model based on a 12-step philosophy and family style of residential living; and
- WHEREAS, O'Mar Taylor's organization has been the vendor managing the Criminal Justice Resource Center's transitional house since 2009 assisting clients maintain sobriety while developing their skills to transition into more permanent housing placements; and
- WHEREAS, O'Mar provided clean, safe, and sober living for thousands of Durham Residents in the last 18 years, working with and receiving referrals from various community agencies, always willing to meet with people in need of housing often with little notice; and
- WHEREAS, O'Mar never let his favorite holiday, Christmas, pass without an Annual Christmas celebration at which each house resident received a personal gift, and making sure all residents had what they needed throughout the year, and
- **WHEREAS,** beginning in 2014, O'Mar served on the Durham Criminal Justice Advisory Committee and the Durham Local Reentry Council where he advocated and worked tirelessly to develop safe and affordable housing for justice involved individuals in Durham, NC.

**NOW, THEREFORE, BE IT RESOLVED**, that we, the members of the Durham County Board of Commissioners, do hereby resolve to honor

#### **VERNON O'MAR TAYLOR**

for his lifelong work as a passionate, generous, and highly respected advocate, community leader and visionary.

- **WHEREAS,** this year marks the commemoration of the 55<sup>th</sup> anniversary of the passage of the Fair Housing Act, the landmark civil rights law signed by President Lydon B. Johnson; and
- **WHEREAS.** more than fifty years after the passage of the Act making discrimination in housing transitions unlawful, housing injustice persists as many communities remain segregated and the need to protect those vulnerable to inequities continues; and
- **WHEREAS**, Durham County is committed to the mission and intent of Congress to provide fair and equal housing opportunities for all; and
- **WHEREAS**, our social fabric, the economy, health, and environment are strengthened in diverse, inclusive communities; and
- **WHEREAS,** acts of housing discrimination and barriers to equal housing opportunity are unacceptable to a common sense of decency and fairness.

# RECOGNITION OF THE SERVICE OF PATRICK D. HANNAH AS THE RALEIGH-DURHAM AIRPORT AUTHORITY MEMBER AND CHAIRPERSON (2015-2023)

- WHEREAS, Patrick Hannah has represented Durham County on the Raleigh-Durham Airport Authority Board since 2015, and has served as Chairman of the Board since 2021. During his tenure as Chairman, he helped the airport successfully navigate the impacts of the COVID-19 global health pandemic and chart its path to recovery; and
- **WHEREAS,** Hannah managed the development of the Authority's 2022-2026 Strategic Plan, which provides the strategic direction, priorities and management strategies for the Authority over the next five years; and
- **WHEREAS,** during his Chairmanship, the Board approved the concessions operator model, which is intended to increase revenue for RDU and provide more opportunities to small and diverse businesses by seeking to reduce barriers for those interested in doing business at the airport; and
- WHEREAS, Hannah is credited with providing strong financial stewardship with Fitch Ratings and Moody's re-affirming the Airport Authority's 'AA-' and Aa3 rating; respectively, in 2022 citing careful financial management and a strong recovery in passenger traffic; and
- **WHEREAS,** under his leadership the airport adopted an Owner-Controlled Insurance Program for major capital construction projects that removes a barrier for small businesses to work with the Authority; and
- **WHEREAS,** his vision resulted in a new air service incentive program that lured new airlines and routes to RDU including the introduction of Icelandair, Bahamasair, Avelo and Breeze Airways.

## 23-0216 Public Hearing – To Adopt the Revised County Stormwater Ordinance
