23-0415 Resolution – Honoring the Life of Conen Trevell Morgan

Chair Howerton, Commissioner Burns and Commissioner Allam read the following resolution:

CONEN TREVELL MORGAN

- **WHEREAS,** Conen T. Morgan, a native of Garner, NC, attended North Carolina State University, where he obtained his undergraduate degree in computer science as a Caldwell Fellow; and was also a proud member of Kappa Alpha Psi Fraternity; and
- WHEREAS, Morgan's love of serving others began at an early age, elected Student Body President of Garner High School, where he used his platform to speak up for students and educators by addressing the Wake County School Board in 1999 in support of a school bond referendum; and
- **WHEREAS,** his passion for politics was often unmatched by his love of science, dedicating much of his free time to volunteer and emcee for the North Carolina Science Olympiad, in homage to his time as a competitor while in high school, and his service to the Olympiad

was honored in 2016 when he received the Dr. Jason L. Painter Distinguished Service Award; and

- **WHEREAS,** Morgan founded and served as Managing Partner of Longleaf Agency, using his skill sets and talents to progress positive change across North Carolina through the support of candidates and advocacy organizations, and to champion a platform of equity and justice at every level of his work and government; and
- WHEREAS, he unselfishly shared his talents with others, leading as a visionary and mentor for many young and old across the State and country, and while serving as President of the Young Democrats of North Carolina, Morgan made it his mission to pass on the torch and lift up young leaders, especially young leaders of color to advocate for equity across our State; and
- WHEREAS, his service to Durham came full circle from his high school days when he served as the primary consultant on the 2022 Durham bond referendum, championing one of his earliest passions, supporting public education, and where his integral contributions assisted the Blue Ribbon committee to raise awareness, and pass the bonds overwhelmingly with over 80% of support from residents; and
- WHEREAS, Conen T. Morgan leaves behind his lovely wife Reyna Walters-Morgan, his parents Pamala and Timothy, his sister Jaleesa Morgan, family members, friends, and colleagues; and
- **WHEREAS,** Conen was simply an amazing life force who shared his grace, kindness and respect with everyone he came in contact with. This gifted, passionate leader and philanthropist will long be remembered as a role model, mentor, and dynamic visionary to all who were blessed to know him. The legacy of his work will continue on through those he loved and inspired.

23-0422 Proclamation – Pride Month June 2023

The Board read the following proclamation:

PRIDE MONTH | 2023

- **WHEREAS,** the Stonewall Riots, a period of protests and violent clashes with law enforcement in June 1969, is commonly viewed as the origin of the modern gay rights movement in this country; and
- WHEREAS, the LGTBQIA+ movement in Durham is rooted in an April 17, 1981 protest in response to the hate motivated assault of four men at the Little River on April 12, 1981 and resulting death of Ronald, "Sonny" Antonvevitch: Durham's first NC Pride March in 1986 was organized by the Triangle Lesbian and Gay Alliance (TLGA) and Mayor Wib Gulley's proclamation of Durham's first anti-discrimination week in 1986 resulted in him being challenged by an unsuccessful recall campaign, and
- WHEREAS, celebrating Pride Month raises awareness and provides support and advocacy for the LGBTQIA+ community, and is an opportunity to become educated, engage in dialogue, strengthen alliances, and build understanding; and
- **WHEREAS,** LGBTQIA+ Americans continue to face discrimination simply for being who they are, and the County of Durham stands with this community in the struggle to ensure equal treatment for all; and
- **WHEREAS,** while much progress has been advanced, we know that there is still work to be done to ensure that everyone enjoys the full promise of dignity, protection, equity, and freedom; and
- WHEREAS, more than 400 anti-LGBTQIA+ bills have been introduced in state legislatures all across the United States since the start of the year, and progressive officials and citizens must speak up to protect LGBTQIA+ rights; and
- **WHEREAS,** Durham County Government continuously advocates for protections for all LGBTQIA+ individuals in order to make it clear that there is no place in this progressive community, state or nation for denial of human rights regardless of anyone's sexual orientation, gender identity, or gender expression; and
- WHEREAS, Durham County's Non-Discrimination Ordinance, approved in 2022 by the Board of County Commissioners, provides freedom from discrimination on the basis of race, ethnicity, creed, color, sex, pregnancy, marital or familial status, sexual orientation, gender identity or expression, national origin or ancestry, marital or familial status, pregnancy, military status, religious belief or non-belief, age, or disability in employment and access to all places of public accommodation.

NOW THEREFORE, I, Brenda A. Howerton, Chair and on behalf of the Durham Board of County Commissioners, do hereby proclaim June 2023 as

"PRIDE MONTH"

in Durham County. We call upon Durham County residents to recognize the achievements of the members of the LGBTQIA+ community, and to celebrate and support a culture of inclusiveness and acceptance during this month and every month.

Other Business

23-0414 Adoption of the FY 2023-24 Budget Ordinance

Dr. Kimberly Sowell, County Manager thanked the Board for their commitment to Durham County. She also thanked Keith Lane, Budget Director, the Budget Department staff and Claudia Hager, Deputy County Manager for their assistance with the budget.

DeWarren Langley, Citizen

Mr. Langley asked for the Board to approve \$250,000 requested funds to help the Charles Hamilton Houston Foundation Program and approve the \$210,330 initial requested funds for the Juvenile Crime Prevention Council.

Chari Howerton read the following statement:

"As we come to the culmination of this year's dynamic budget process, I want to sincerely thank our extraordinary staff who did the work to get us to this point. As I often tell community members, our Board succeeds in addressing critical needs and requests from residents, thanks to the hardworking and dedicated staff we have in departments across this organization.

Dr. Sowell, Deputy County Manager Hager, Budget Director Lane along with the entire staff of Budget and Finance, let me just say we are so fortunate to have your leadership over this annual process.

Thanks, are also due to out department heads for working together as "team players" to help make this responsible budget that will serve us well over the coming year. All of you have collaborated to respond to the ideas and priorities of each of out Board members, and to ensure that they have been included in this budget. And for that, I say thank you!

This budget totals nearly \$890 million dollars and includes significant investments in recruiting and retaining critical county employees, educational improvements, public safety, affordable housing and efforts to continue to recover from the pandemic.

This year's budget increases the County property tax rate by 3cents to 75.22 cents per \$100 valuation. Certainly, inflation played a role in this decision, and you will recall that voters approved our largest ever bond referendum last fall for schools and public buildings. At that time, we noted that a tax increase would result. But know that we will continue to offer our popular Low Income Housing Relief Program to eligible residents with that tax bill.

I am very proud that our Board continues to make education a priority. To that end, we provided \$10.8 million dollars more to Durham Public Schools. Those additional funds will help improve salaries for certified employees, as well as for classified workers. The funding also provides for a salary study along with increased funding for charter school support.

We are increasing funding Durham Technical Community College to help them continue to train our residents to compete for certain skilled jobs that continue to be available in biopharma, medical technology and more as new companies arrive and expand in Durham County.

This budget allows us to continue to expand the number of Pre-K classrooms for our youngest residents...something I'm so proud to say we have prioritized for years. We continue to help give them a great start in their educational journey.

Our resilient county employees have certainly hung in there with us over the years, especially during pandemic. We all know that his has not been the easiest time to be in government service. We've asked a great deal from county employees, especially this in certain public facing positions, and we are happy to include a significant across the board increase, as well as other supportive services to promote the health and wellbeing of our most valuable asset...our employees!

The budget includes investments in adding a few employees to help address new demands for services critical to our growing population. Some of those services enhancements include supporting food security efforts for our most vulnerable residents, expanding outreach to our veterans, and providing a new facility for our Board of Elections.

Also, we are funding a broadband manger to help us level the digital divide and effectively oversee the federal and state broadband improvements and hiring a new Medical Director position to manage all programs related to the Opioid Treatment Program and Medication Assisted Treatment at the Durham County Detention Center.

We have much to celebrate with this budget, and I am proud of the work that we have done together in developing a budget that will produce improved outcomes and services throughout Durham County. Now let's get to work."

Vice Chair Jacobs read the following statement:

"I am proud to support adoption of this FY 23/24 budget of \$889,514,622 worth of investment in our community. This budget is a reflection of our values and priorities.

We are fortunate in Durham County. Our sales and property tax revenues continue to rise. Our community overwhelmingly supports our public schools and educational institutions as evidenced by the recent successful \$530 m Bond Referendum. And as reflected in this budget, Durham County Government continues to make targeted investments for ALL people to have more equitable access to the good jobs, education and feeling of safety and well-being enjoyed by so many in our community.

Budget decisions are always hard to make. We always have more demand than available funding. There are always urgent and competing needs that deserve funding. This budget is a reflection of our ongoing board priorities- investing in our strong education to jobs pipeline, investing in early childhood and support for our mothers and families, and investing in our staff who ARE the vital programs and services Durham residents depend on each day. With this budget, our Board and Durham County Government continues to lead the way with a wholistic and systemic approach to fight poverty and create equitable access to shared prosperity and well-being for all. With this budget Durham County's minimum living wage will now be \$19.22 per hour. We are setting the bar and standard for others to meet and follow. We are funding the requested increase for salaries for Durham Tech's janitors and Durham Public Schools classified staff including bus drivers, cafeteria workers and assistant teachers. Ensuring people have good paying jobs to support their families is one of the best ways to address many of our current societal challenges around mental health, substance use, food security and housing affordability.

With the adoption of this budget, we continue our strong investment in education and preparing our children and youth for the great jobs Durham County Government directly supports in RTP, Treyburn and Downtown Durham. Our per-pupil funding increases by 7% to \$4,650 per student, one of the highest in the state. We provide more than \$2.4 million in scholarships for Durham students to attend Durham Tech and we increase our funding for high quality PreK education to \$7.9 million we know is fundamental for successful lifelong learning and achievement.

There are many additional investments I am excited to support in this budget such as the Familiar Faces Initiative. This will be housed in our Justice Services Department and will use a data driven approach to better track and deliver services to our most vulnerable residents who cycle in and out of many county funded services and program. I am also excited to approve distribution of our first Opioid Settlement funds for our Community Linkages to Care program that uses peer support to connect people to ongoing substance use and mental health treatment and a Medical Director to support expansion of medication assisted treatment for people with opioid use disorder in the Durham County Detention Center.

I am grateful to you, Manager Sowell, for leading us through what may be the most non-controversial budget process I think I have experienced in my nearly 11 years in elected office! Thank you to Budget Director Keith Lane, Assistant Budget Director David Ades, and all of your A Team of budget staff for leading everyone through this complex, multi month process and ensuring our Board always has our questions answered and all the information we need to make the best decisions possible. And thank you to Deputy Director Claudia Hager for your ongoing financial management and expertise. Thank you to every Durham County staff member, at every level of leadership, who has contributed to this process. Thank you to my fellow board members- it is a pleasure to work and serve our Beloved Durham alongside each of you. And most of all, thank you to Durham County residents for your engagement, input, and involvement with this year's budget process. It is because of each and every one of you, that Durham is such a special, caring and wonderful community."

Commissioner Burns announced highlights of the historic FY 2023-2024 adopted budget. She stated the Board communicated with the residents in the community and agreed with the needed investments for Durham County.

The Board thanked County staff for preparing and assisting with the budget, budget development skills, and having the budget prepared for approval in a timely manner.

Commissioner Burns moved, seconded by Commissioner Allam to approve the FY2023-24 Budget Ordinance.

Kate Senner, Citizen

Ms. Senner stated the NC Museum of Life and Science was a community staple to take children, get married and work; she also thanked the Board for supporting the funding request.

Curtis Massey, Senior Assistant County Attorney stated the Board was requested to adopt the Resolution amending Chapter 4 of the Durham County Code of Ordinances to allow for the creation of a Trap-Neuter-Vaccinate-Release Program (TNVR). He added this matter came before the Board at the May 22, 2023 meeting for consideration and to give direction to the County Attorney's Office. Mr. Massey stated upon consideration of the presentation, public comments, and the different proposed ordinances, the Board directed the County Attorney to draft a resolution amending Chapter 4 in accordance with the proposed amendments prepared by the local working group and dated March 21, 2023. He added the resolution complied with the Board's direction.

The Board thanked Mr. Massey for overseeing the creation of the TNVR Program and assisting all involved with the program to compromise and agree – they also thanked advocates and residents for contributing. The Board lastly thanked Commissioner Carter for championing and assisting with the creation of the TNVR Program.
