## 23-0416 Proclamation – Durham Refugee Day

Chair Howerton read the following proclamation:

## **DURHAM REFUGEE DAY | 2023**

- **WHEREAS,** the overwhelming majority of people seeking refuge through The Office of the United Nations High Commissioner for Refugees and the United States Department of State are vulnerable women and children who will otherwise remain in harm's way; and
- **WHEREAS,** a significant portion of refugees fleeing to the United States are coming to join family members from whom they have been separated for years; and
- **WHEREAS,** the United States has a proud humanitarian tradition since the late 1970's of welcoming refugees of all nationalities and religions a tradition which is deeply grounded in our most fundamental and deeply-held national values; and
- **WHEREAS,** Durham County has a long-standing commitment not only to being open and welcoming to immigrants and refugees but also to understanding that our immigrant and refugee communities are integral to the life of our county.

**NOW THEREFORE**, I, Brenda A. Howerton, Chair and on behalf of the Durham Board of County Commissioners, do hereby proclaim July 8, 2023 as

# Public Hearings

## 23-0450 Public Hearing to Consider the Naming Request for Lowell L. Siler Lobby

Shannon Trapp, Chief of Staff stated the Board was requested to hold a public hearing to consider naming the lobby of the Administrative II Building after Lowell L. Siler, former County Attorney. She added during this public hearing, the Board would hear public comments, provide additional feedback, and approve the request.

Ms. Trapp shared a presentation titled *Naming Request for the Lowell L. Siler Lobby* which highlighted the following: Durham County Naming/Renaming Policy Highlights, Durham County Naming Committee, Naming Request: Lowell L. Siler Lobby, Committee Recommendation and Next Steps.

The Board shared feedback on different locations based off the information presented. After discussion, the Board agreed to locate the picture and naming detail on the left wall – when entering the Administrative II Building. This would allow no distraction to the display.

Chair Howerton asked for a motion to open the public hearing.

Commissioner Carter moved, seconded by Commissioner Allam to open the public hearing.

The motion carried unanimously.

## Antonio Jones, Citizen

Mr. Jones stated he submitted the application for the Lowell L. Siler Lobby and shared how Mr. Siler impacted the community. He added that the lobby naming would show appreciation and respect.

## Henry Pruette, Citizen

Mr. Pruette stated Mr. Siler was a friend, Counselor at Law and was respected in the law community - he approved of the lobby naming.

## Clayton Jones, Citizen

Mr. Jones stated he was the first African American Chief District Judge in Durham County thanks to Mr. Siler willingness to teach, mentor and advise.

## Philip Terry, Citizen

Mr. Terry stated Mr. Siler was a friend and requested for him to be honored with the naming of the lobby.

## Michael Palmer, Citizen

Mr. Palmer stated Mr. Siler would find answers to problems, loved people and was the ultimate public servant.

## James (Butch) Williams, Citizen

Mr. Williams stated Mr. Siler worked at his law office before coming to work for the County and the naming of the lobby would be an honor.

Chair Howerton entertained a motion to close the public hearing.

Commissioner Burns moved, seconded by Commissioner Allam to close the public hearing.

The motion carried unanimously.

The Board thanked the Durham Committee on the Affairs of Black People, the Beta Phi Chapter of Omega Psi Phi Fraternity, Inc. and community friends for attending the meeting. The Board inquired about the time for the unveiling event on July 14<sup>th</sup>. Ms. Trapp responded she would work with the Board to decide on a time and inform the community of the unveiling details.

Commissioner Burns moved, seconded by Commissioner Allam per County policy to name the Lowell L. Siler Lobby located on the first floor of Administration II located at 201 E. Main Street, Durham, NC 27701.

The motion carried unanimously.

# 23-0456 Public Hearing on Not to Exceed \$60M General Obligation (GO) Refunding Bonds, Series 2023, Adoption of Bond Order, and Adoption of Bond Resolution

Crystally Wright, Interim Chief Financial Officer stated the Board was requested to hold a public hearing for the issuance of General Obligation Refunding Bonds Refunding Bonds, Series 2023 (not-to-exceed \$60M). She added following the public hearing, the Board was requested to adopt the bond order (the "Bond Order") and adopt the bond resolution (the "Resolution") which authorizes the General Obligation Refunding Bonds Refunding Bonds, Series 2023 (\$60M), in an amount not to exceed \$60,000,000. Ms. Wright stated the Bonds would refund the County's General Obligation Bond, Series 2021, which was authorized pursuant to bond orders approved in the 2016 referendum for community college, library, museum, and school purposes.

Monica Wallace, Clerk to the Board reported to the Board that the bond order entitled "**BOND ORDER AUTHORIZING THE ISSUANCE OF \$60,000,000 GENERAL OBLIGATION REUNDING BONDS OF THE COUNTY OF DURHAM, NORTH CAROLINA,**" which was introduced at a meeting of the Board held on June 12, 2023, was published on June 20, 2023, with notice that the Board would hold a public hearing thereon on June 26, 2023 at 7:00 p.m. I'd also like to report that there has been filed in my office a statement of debt showing the net indebtedness of the County to be 1.24 percent of the assessed valuation of property in the County subject to taxation, and a statement of disclosure showing the estimated total interest to be paid on the proposed bonds over the expected term of the bonds is \$35,434,933.33.

Chair Howerton moved, seconded by Commission Carter to hold the public hearing, notice of which has been properly made as referenced by the Clerk, on the general obligation refunding bond order.

The motion carried unanimously.

Chair Howerton stated the Board would now hear anyone who wished to be heard on the questions of

the validity of the general obligation refunding bond order and the advisability of issuing the general obligation refunding bonds. She added the Clerk had a copy of the bond order and the notice of public hearing relating thereto if anyone would like to see a copy.

Ms. Wallace stated no citizens were signed up to speak.

Chair Howerton moved, seconded by Commission Carter, to close the public hearing.

The motion carried unanimously.

## Adoption of the Bond Order

Chair Howerton moved, seconded by Commission Cater for the Board to adopt the obligation refunding bond order entitled, general **"BOND ORDER** AUTHORIZING THE ISSUANCE OF \$60,000,000 OF **GENERAL** OBLIGATION REFUNDING BONDS OF THE COUNTY OF DURHAM, NORTH CAROLINA," which was introduced at the meeting of the Board held on June 12, 2023, and direct the Clerk to publish a notice of adoption of the bond order, as prescribed by The Local Government Bond Act.

The motion carried unanimously.

## Adoption of the Bond Resolution

Chair Howerton stated the Board had a resolution entitled "A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE COUNTY OF DURHAM, NORTH CAROLINA PROVIDING FOR THE ISSUANCE OF THE NOT TO EXCEED \$60,000,000 GENERAL OBLIGATION REFUNDING BONDS, SERIES 2023 OF THE COUNTY OF DURHAM, NORTH CAROLINA" before the Board for consideration. Chair Howerton asked for a motion to adopt the Resolution.

Commissioner Allam moved, seconded by Commission Cater for the Board to adopt the Resolution.

The motion carried unanimously.

## 23-0326 Durham Sports Commission Update on Sports Complex Future Development/Uses Opportunities

Marcus Manning, Executive Director of Durham Sports Commission and Susan Amey, President and CEO of Discover Durham shared a presentation *Durham Sports Complex – Breaking Ground on a Transformational Path Forward for Youth Participation and Community Development* which highlighted the following: The Benefits of Play, Why Sports, Parents' Desired Outcomes for Their Child Playing Sports, Sports Improves Mental Health, Impacts – Health, Social and Other, Groups at Risk of Exclusion from Society have a Lower Health Status and More Health-Related Problems, Youth Sport Participation, Durham County Youth Risk Behavior, A Bull City Transformation, Durham's Population, Destinations Investing in New Sport Facilities, Why Break Ground Now, A Transformational Path Forward, The Opportunity, Definitions of Success and Transformational Impact, Proposed Concept, Indoor Complex, Auxiliary Gym and Flex Space, Outdoor Complex, Balancing Local Programming and Sport Tourism, Potential Programmatic Opportunities, Sport Tourism Funds Local Community Growth, Economic Impact, Event Types, Projected Performance, Next Steps, Definitions of Success and

Transformational Impact.

The Board asked about the economic and social sense of owning a Sports Complex and the Memorial Stadium. Mr. Manning replied that the Sports Commission would hire a consultant to provide recommendations, adding the new facility would not duplicate the Memorial Stadium. Ms. Amey shared the location of the new facility was important and she looked forward to working with County staff to explore potential location options. The Board asked how youth with limited income would be able to access the facility. Mr. Manning stated funds earned from tournaments would help offset the cost of weekday activities for youth and the community. The Board stated they would like for the intentions to be in writing to ensure the new facility was accessible to everyone in the community. They also would like the Sports Commission to collaborate with Durham Parks and Recreation and include Minority and Women-Owned Businesses.

The Board thanked Mr. Manning and Ms. Amey for the presentation and looked forward to the next steps.
