Jacqueline Wagstaff

Ms. Wagstaff inquired about the Boards and Commission application process and deadlines. She stated she submitted her application for the Alcoholic Beverage Control (ABC) Board although she was not on the voting ballot and asked for the Board to include her application for the open position.

<u>23-0504 Proclamation – North Carolina Senior Tar Heel 30th Anniversary Celebration</u> Chair Howerton read the following proclamation:

NORTH CAROLINA SENIOR TAR HEEL 30TH ANNIVERSARY | 2023

- **WHEREAS,** the North Carolina Senior Tar Heel Legislature (NCSTHL) is unique serving as a bipartisan, unicameral body by the North Carolina General Assembly in the Senate with passage of Bill 479 in 1993, tasked to identify the most pressing issues facing older adults across the state and proposing legislation that will improve their quality of life; and
- WHEREAS, each of North Carolina's 100 countries may appoint delegates and alternates to provide information and education to older adults on the legislative process and matters being considered by the NC General Assembly; promote citizen involvement and advocacy concerning aging issues before the General Assembly; and assess the legislative needs for older adults by convening a forum modeled after the General Assembly; and
- **WHEREAS,** since its inception, the NCSTHL has supported the passage of 11 Bills into law and has consistently promoted increased funding for programs supporting the growing population of older adults and their caregivers policies to protect them; and
- **WHEREAS,** Durham County is committed to support the NCSTHL in engaging and supporting older adults, their families, and caregivers and to protecting and safeguarding the rights of older individuals; and
- **WHEREAS,** it is appropriate for Durham County to recognize the NCSTHL and to celebrate its 30 years of positive impact on behalf of older adults in North Carolina.
