Ceremonial Items

23-0713 Proclamation – Minority Enterprise Development Week October 2-6, 2023

Chair Howerton read the following proclamation:

MINORITY ENTERPRISE DEVELOPMENT WEEK | 2023

- **WHEREAS,** it is the policy of the County of Durham that purchasing by the County and contracts with the County be open to all people and be free of discrimination on the basis of race and gender; and
- **WHEREAS,** diverse entrepreneurship encourages progress toward innovative solutions to the problem of economic growth, and supports the promise of thriving communities that embrace inclusion and a better life for all families
- **WHEREAS,** the Durham County Minority and Women Enterprise Ordinance Section 8-132 provides minorities and women equal opportunity to participate in all aspects of the County's contracting program, including, but not limited to, employment, construction projects, and/or materials and service contracts, consistent with law; and
- **WHEREAS,** G.S. 143-128, provides for Good Faith Efforts to be made in an effort to ensure fair participation of minority and women business owners in all County projects; and
- **WHEREAS** according to the Stanford Institute for Economic Policy Research, the impacts of the Covid 19 have contributed to a staggering 41 percent drop in African American business owners, 32 percent decline in Latin business owners, 26 percent in Asian business owners and a 25 percent reduction in women owned businesses nationwide, and
- **WHEREAS,** it is further the policy of the County to conduct its contracting programs so as to prevent such discrimination, correct present discrimination and to resolve claims of such discrimination; and
- WHEREAS, the County of Durham is a sponsor of the Minority Enterprise Development Week.
- **WHEREAS,** During Minority Enterprise Development Week, we recognize that our County and our economy are stronger because of the hardworking men and women who comprise America's minority business community. They consistently demonstrate the courage it takes to overcome adversity, seize opportunity, and contribute to our shared prosperity.

NOW, THEREFORE, BE IT RESOLVED I, Brenda Howerton, Chair of the Durham Board of County Commissioners and on behalf of the Durham Board of County Commissioners, do hereby proclaim October 2 - 6, 2023 as

"MINORITY ENTERPRISE DEVELOPMENT WEEK"

in Durham County.

23-0734 Domestic Violence Awareness Month

Commissioner Burns read the following proclamation:

DOMESTIC VIOLENCE AWARNESS MONTH | 2023

- **WHEREAS,** the safety, security, physical and emotional wellbeing of our neighbors affects the lives of everyone in our community; we recognize that domestic violence takes a variety of forms and believe all individuals have the right to live their best and fullest lives free of violence and fear; and
- WHEREAS, we recognize that 1 in 4 women and 1 in 9 men report experiencing physical violence by an intimate partner in their lifetimes, according to the National Coalition Against Domestic Violence. Domestic violence is a serious, preventable public health concern involving the manipulation of power and control, including willful intimidation, physical and sexual assault, emotional and financial abuse, and other abusive behaviors; and
- WHEREAS, anyone can be a victim of intimate partner violence, regardless of gender, age, race, socioeconomic status, ability, or relationship choice. We believe that everyone deserves a life free of violence, regardless of gender identification, ethnicity, ability, age, religion, or social status; and
- **WHEREAS,** we recognize that the crime of domestic violence impacts victims, families, and society, and can lead to long-term health problems, missed days of work and loss of employment, psychological distress, family instability and homelessness, and increased risk for future violence; and
- **WHEREAS,** ending domestic violence starts with awareness and education, changing social norms about gender and violence, and mobilizing our communities, including men, boys, our faith institutions, the public, and private sectors.

NOW, THEREFORE, I, Brenda Howerton, Chair and on behalf of the Durham Board of County Commissioners, do hereby proclaim October 2023 as

"DOMESTIC VIOLENCE AWARENESS MONTH"

in Durham County. We urge all who engage with youth to teach and model respect, consent, and healthy relationships. We encourage government, health professionals, law enforcement, faith communities, and civic organizations to ensure an inclusive environment that supports survivors of domestic violence and sustains their efforts to rebuild their lives without violence in Durham. We are strongly committed to working with all partners so that every individual can access appropriate and affirming resources to address and end violence in our communities.

Damien Talley, Domestic Crisis Response Center (DCRC) Executive Director thanked the Board for the proclamation and for the opportunity to highlight the importance of domestic violence awareness. He invited the community to attend the annual "Reading of the Names" of the lives lost to domestic violence this year on Monday, October 2nd at 8 a.m. at 101 E. Morgan Street in the back parking lot.

The Board stated domestic violence increased during the holidays and the community's first Family Justice Center was now open in Durham. Mr. Talley stated the Family Justice Center would provide support for families affected by domestic violence, sexual violence, and human trafficking. The Board stated the Durham County Sheriff's Office was available at the center and Mr. Talley shared the Sheriff's Office availability at the center was limited along with representatives from the Crisis Response Team and Legal Aid.

The Board thanked Mr. Talley and the DCRC staff for assistance, support and services for domestic, sexual, and family violence, human trafficking, and their families in Durham.

23-0737 Proclamation – Hispanic Heritage Month

Commissioner Carter read the following proclamation:

NATIONAL HISPANIC HERITAGE MONTH | 2023

- **WHEREAS,** National Hispanic Heritage Month, known as "Mes de Herencia Hispana," is celebrated from September 15 to October 15; and
- **WHEREAS,** the annual celebration recognizes the diverse histories, cultures, and contributions of American citizens whose ancestors came from Spain, Mexico, the Caribbean, and Central and South America; and
- WHEREAS, this observation was first held in 1968 as Hispanic Heritage Week under President Lyndon Johnson and was later expanded in 1988 by President Ronald Reagan; and
- **WHEREAS,** generations of Hispanic Americans have defended democracy along with this nation's liberty and freedoms throughout the world by serving in our armed forces; and

- **WHEREAS,** approximately 15.4% of Durham County's residents are of Hispanic or Latino descent and more than 62 million Latinos contribute to communities across the country; and
- WHEREAS, our communities are made stronger when we recognize our diversity and work to honor, understand and appreciate the history, achievements, art, music, cuisine, customs, unique traditions and cultures of our friends, family and neighbors who represent the Hispanic community; and
- **WHEREAS,** the theme for National Hispanic Heritage Month 2023 is "Todos Somos, Somos Uno: We are All, We Are One", and is intended to emphasize the diversity and unity of the Hispanic/Latino population as well as the indispensable role members play in shaping and enriching our American society.

NOW, THEREFORE, I, Brenda Howerton, Chair and on behalf of the Durham Board of County Commissioners, do hereby proclaim September 15 – October 15, 2023 as

"NATIONAL HISPANIC HERITAGE MONTH"

in Durham County and urge all residents to celebrate National Hispanic Heritage Month by honoring generations of Hispanic residents who have made our nation strong and prosperous with their essential contributions to Durham County, North Carolina, and beyond.

The Board stated according to the U.S. Census Bureau, there were approximately 63.7 million Hispanics or Latinos in the United States in 2022, accounting for approximately 19.1 percent of the total U.S. population. The Board added approximately 30 percent of Durham Public School students were Hispanic or Latino and approximately 14 percent of Durham's population identified as Hispanic or Latino. They also shared the importance of an equitable and accessible Durham community.
