#### Commissioner Jacobs read the following statement:

"Tonight, I speak out against the unprecedented attack of Hamas militants on the people of Israel. The deliberate and targeted killing of civilians, including children and seniors, families, and youth in their homes, villages, kibbutz's and at a music festival

and the intentional taking of hostages is horrific and can never be justified for any purposes.

As noted in the Guardian newspaper: "The US special antisemitism envoy, Deborah Lipstadt, who is one of the world's most renowned Holocaust scholars, called the Hamas attacks "the most lethal assault against Jews since the Holocaust". She said there was "no justification" for the "heinous, barbaric terrorism against Israeli civilians" and mass murder."

I also want to recognize the ongoing suffering and indiscriminate killing of the Palestinian people and the 2.3 million Palestinian residents of Gaza who have been virtually imprisoned within the small area of the Gaza Strip for more than 16 years. Scores of innocent Palestinians are being killed in Israeli military retaliation and response to the Hamas terrorist attack and ongoing bombing into Israel from Gaza. Residents are now struggling to survive with no access to electricity, fuel, food and water.

War, terrorism and the indiscriminate killing of innocent people must be condemned and must stop. There must be a two-state solution. The Palestinian people must have a homeland. The people of Israel must be able to live in safety and security. Peaceful coexistence and self-determination for all is the only just and possible way forward."

Commissioner Allam read the following resolution:

# Resolution Honoring Indigenous People's Day

#### INDIGENOUS PEOPLES' DAY

WHEREAS, Durham County, North Carolina acknowledges its presence on the ancestral lands of the Eno, Tuscarora, Lumbee, Occaneechi, Cheraw, Shakori, Saponi, and Catawba tribes, whose rich history and continued contributions have greatly shaped the cultural, historical, and environmental landscape of our community; and

- WHEREAS, the Indigenous people of the Eno, Tuscarora, Lumbee, Occaneechi, Cheraw, Shakori, Saponi, and Catawba tribes have inhabited this region for time immemorial, maintaining a profound connection with the land, waterways, life force, and environment that sustain our community; and
- WHEREAS, prior to colonization, Indigenous Peoples lived and flourished in what is known as the Americas for time immemorial; Whereas the European colonization of North America led to the suppression, forced assimilation, and genocide of Indigenous Peoples and their cultures; and
- **WHEREAS**, the Indigenous people of this region have experienced historical and present day injustices and dispossession of their ancestral lands, leading to adverse social, cultural, economic, and health impacts on their communities; and
- WHEREAS, Durham County recognizes the vital role the Eno, Tuscarora, Lumbee, Occaneechi, Cheraw, Shakori, Saponi, and Catawba tribes play in promoting understanding, respect, and preservation of Indigenous heritage, language, traditions, and customs, which continue to enrich our community's diverse cultural fabric; and
- **WHEREAS**, the Durham County Board of Commissioners is committed to fostering inclusive and equitable policies and practices that respect and celebrate the heritage, culture, and contributions of Indigenous Peoples.

**NOW, THEREFORE, BE IT RESOLVED,** that we, the members of the Durham County Board of Commissioners, do hereby honor resolve to:

- 1. Honor the ancestral lands of the Eno, Tuscarora, Lumbee, Occaneechi, Cheraw, Shakori, Saponi, and Catawba tribes on which Durham County is situated and acknowledge their enduring presence in our community.
- 2. Express its gratitude for the historical and ongoing contributions of the Eno, Tuscarora, Lumbee, Occaneechi, Cheraw, Shakori, Saponi, and Catawba tribes to the cultural, environmental, and social vitality of Durham County.
- 3. Commit to fostering a spirit of respect, understanding, and cooperation with the Indigenous communities in Durham County, recognizing their sovereignty and their right to self-determination.
- 4. Encourage educational initiatives, cultural exchange programs, and partnerships that promote the awareness and preservation of the heritage, language, traditions, and customs of the Eno, Tuscarora, Lumbee, Occaneechi, Cheraw, Shakori, Saponi, and Catawba tribes.
- 5. Continue to work towards policies and practices that advance equity, inclusivity, and social justice for all residents of Durham County, with a particular focus on addressing disparities faced by Indigenous communities.

Chair Howerton read the following statement:

"Our Country was conceived on a promise of equality and opportunity for all people — a promise that despite the extraordinary process we have made through the year, we have never fully lived up to. That is especially trye when it comes to upholding the rights and dignity of the Indigenous people who were here long before colonization of the Americas began. For generations, Federal policies systematically sought to assimilate and displace Native people and eradicate Native cultures. Today, we recognize Indigenous peoples' resilience and strength as well as the immeasurable positive impact that they have made on every aspect of American society. We also recommit to supporting a new, brighter future of promise and equity for Tribal Nations — a future grounded in Tribal sovereignty and respect for the human rights of Indigenous people in Durham and around the world.

The contributions that Indigenous people have made throughout history – in public service, entrepreneurship, scholarship, the arts, and countless other fields – are integral to our Nation, our culture and our society.

I encourage everyone to celebrate and recognize the many Indigenous communities and cultures that make up our great country as Indigenous People's Day. I call upon the people of Durham County to observe this day with appropriate ceremonies and activities."

The Board thanked Commissioner Allam, Mary Oxendine, Food Security Coordinator and the Public Art and Public History Program. The Board encouraged residents to apply for the Durham County Open Space Matching Grants Program before the November 15<sup>th</sup> deadline and stated Durham needed an Indigenous People Memorial.

# **Public Hearings**

# <u>23-0754 Public Hearing - An Ordinance to Amend the Durham Unified Development Ordinance Provisions Related to the Comprehensive Plan</u>

Scott Whiteman, Planning Manager stated the Board was requested to conduct a public hearing and receive public comments on the Unified Development Ordinance, incorporating revisions to Common Review Procedures (Section 3.2), Comprehensive Plan Adoption/Amendment (Section 3.4, Zoning Districts (Article 4) and Purpose, Applicability and Use Regulations for Design Districts (Section 16.1) effective upon adoption. He stated due to the draft ordinance not being properly updated to show all the changes, a recommendation was made for the public hearing to be continued until the next meeting which was scheduled for October 23, 2023.

The Board asked for an example of a benefit for removing limitations on zoning districts in each development tier. Mr. Whiteman responded that an example was the Planned Development Residential District (PDR), which was limited to the Urban and Suburban Tier and if allowed to other tiers; it would provide more density. The Board inquired about notification changes and the difference between University and College Districts (UC). Mr. Whiteman replied no changes were planned for notifications and UC was more for Duke and UC-2 was added for North Carolina Central University.

The Board questioned the process for residents around access and equity for public utilities. Sarah Young, Planning Director replied staff was notified to address water issues as a top priority and for entire development areas to be infrastructure ready. She added developers were not including existing homes when developing large tracks of land. Ms. Young stated changes in the City Code were being planned to allow extensions of sewer and water. The Board inquired about the North Carolina Law on blasting permits. Ms. Young stated blasting permits were not included in the Unified Development Ordinance nor were they under the Planning Department. The Board asked County Manager Dr. Sowell to bring the City and County staff together to address blasting permits and blasting issues in Durham.

Chair Howerton opened the public hearing.

Commissioner Allam moved, seconded by Commissioner Carter to continue the public hearing to the October 23, 2023 Regular Session meeting.

The motion carried unanimously.

Lisa Miller, Principal Planner stated she was part of the team working on the Comprehensive Plan and thanked the City, County and the community for the approval and adoption of the plan.

The Board thanked the City-County Planning Department and the community for their continued work to accomplish the approval of the Comprehensive Plan.

Commissioner Burns read the following statement:

"A Comprehensive Plan is more than a piece of paper or a collection of maps and graphs. It reflects our collective vision, shared dreams and unwavering

commitment to the welfare of every resident in Durham. The plan lays out the road map for our County's future growth, ensuring that as we regress no one is left behind."

Directive: Vice Chair Jacobs asked County Manger Dr. Sowell to bring the City and County staff together to address blasting permits and blasting issues in Durham.

#### **Closed Session**

Chair Howerton stated the board was requested to adjourn to Closed Session for the following:

- To consider the qualifications, competence, performance, character, fitness, conditions of appointment, or conditions of initial employment of an individual public officer or employee or prospective public officer or employee; or to hear or investigate a complaint, charge, or grievance by or against an individual public officer or employee; pursuant to G. S. 143-318.11(a)(6).
- To consult with an attorney employed or retained by the public body in order to preserve the attorney-client privilege between the attorney and the public body, in the matter of Robin Barefoot, et al vs. Durham County, which privilege is hereby acknowledged; pursuant to G. S. 143-318.11(a)(3).

Commissioner Burns moved, seconded by Commissioner Allam, to adjourn into the Closed Session.

The motion carried unanimously.

# **Reconvene to Open Session**

Chair Howerton announced the Board met in Closed Session and provided direction to staff.

Commissioner Allam moved, seconded by Commissioner Burns to adjourn the Regular Session meeting at 9:45 p.m.
