# **Public Hearings**

24-0052 Public Hearing on Not to Exceed \$87,000,000 Limited Obligation Bonds, Series 2024A & 2024B

Chair Allam stated the Board was requested to hold a public hearing on the negotiation of an amendment to an installment financing contract in connection with the execution and delivery of not to exceed \$87,000,000 Limited Obligation Bonds (the "Bonds") and the related projects to be financed and refinanced thereby.

Monica Wallace, Clerk to the Board reported to the Board that a public hearing notice relating to financing (i) renovations to a shopping center, a portion of which would house the County's Board of Elections office, (ii) the construction of a pump station known as the Snow Hill Road Pump Station, (iii) renovations and public safety improvements to various County school facilities, and (iv) the construction of a parking facility located at the 500 Block of East Main Street in the County pursuant to an amendment to an installment financing contract, in a principal amount not to exceed \$87,000,000, was published on January 11, 2024 stating that the Board would hold a public hearing thereon on January 22, 2024.

Chair Allam opened the public hearing.

Clerk Wallace stated no citizens were signed up to speak.

Chair Allam closed the public hearing.

Vice Chair Burns moved, seconded by Commissioner Carter, to close the public hearing.

The motion carried unanimously.

Chair Allam stated a resolution entitled "RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE COUNTY OF DURHAM, NORTH CAROLINA, APPROVING AN AMENDMENT TO THE INSTALLMENT FINANCING AGREEMENT AND DELIVERY THEREOF AND RELATED MATTERS" was before the Board for consideration authorizing staff to move forward, as County Representatives, with the proposed financing the projects the Clerk described and authorizing the execution and delivery of certain documents in connection with this financing.

Chair Allam entertained a motion to adopt the Resolution.

Commissioner Carter moved, seconded by Commissioner Jacobs to adopt the resolution (the "Resolution") which authorized the negotiation of an amendment to an installment financing contract in connection with the execution and delivery of not to exceed \$87,000,000 Limited Obligation Bonds.

The motion carried unanimously.
