

# A Few Facts

- 1 in 20 preschool children & 1 in 4 school aged children are affected by a vision problem
- Left uncorrected, these could lead to permanent vision loss
- No national guideline exists mandating ages at which vision screening should occur at school.
- NC Legislation requires vision screening for students entering kindergarten or upon school entry.
- Prevent Blindness of NC trains & certifies school health nurses & school staff every 2 years to provide vision screenings.

# Our Why

- Exams & glasses can be expensive. Almost 15% of children that need new or replacement glasses lack them due to cost
- During the 2022-2023 school year, nearly 600 DPS students were referred for professional eye care & 66% secured the needed care
- School nurses were able to screen 118 students for vision during the 2023-2024 school year prior to the partnership with Project SIGHT
  - Of this, 42 were referred for professional eye care & 20 have been able to secure care

#### Our Partnership

Durham County Public Health School Health, Durham Public Schools, Durham Technical Community College & the City Of Medicine Volunteer Medical Corps created a partnership & developed an MOU to bring needed vision care to Durham County students starting in 2022

## **Process**

After need is identified, planning visit to school & preparation by nurse

Vision Screening with City of Medicine VMC


For failed screenings, parent/ guardian notification & consent for eye exam

Project SIGHT van provides eye exams & glasses (if needed)

Glasses delivered to the school. One year warranty for lost/broken glasses.

## Current School Year Events

For elementary school, 1st, 3rd, & 5th grades are screened. For middle school, 7<sup>th</sup> grade. For high school, 9<sup>th</sup> grade. Students from other grades are also screened if there are vision concerns or if there's capacity to screen other whole grades.
