Public Hearing

24-0099 Public Hearing – Text Amendment – Remainder Lot Width (TC2300006)

Bo Dobrzenski, Assistant Planning Director stated the Board was requested to conduct a public hearing on the Remainder Lot Width, which was a privately initiated amendment that proposed changes to Unified Development ordinance paragraph 7.1.2B to allow a minimum lot width of 80 feet in the Residential Suburban 20 (RS-20) district for the remaining standard lot after a flag lot was subdivided from the lot.

Mr. Dobrzenski shared the Remainder Lot Width – TC23000006 presentation which highlighted the

following: Overview, Intent and Summary of Changes to 7.1.2B.

The Board inquired about the number or lot owners with request or interest for the text amendment change. Mr. Dobrzenski responded the amendment was not allowed previously; therefore, the department expected an incremental number of requests if the amendment was approved.

Chair Allam opened the public hearing.

Keenan Conder, Associate with Morningstar Law Group and Applicant

Mr. Conder stated the text amendment proposed change creation was due to a deep lot in the Spring Valley neighborhood in West Durham that was limited by frontage and the back of the lot was not developed and perfect for a second home. Mr. Conder stated the amendment would help Durham with the increased housing demand, new housing within existing neighborhoods and modestly priced homes.

The Board asked if flag lots existed in Durham. Mr. Dobrzenski responded yes, adding the current minimum width of a flag lot was 100 feet and the text amendment would change the required minimum width to 80 feet. The Board asked if the Planning Commission unanimously approved the text amendment changes. Mr. Dobrzenski replied yes and stated the text amendment was approved by City Council. The Board asked if the flag lot would adhere to septic and well requirements if not in the City limits. Mr. Dobrzenski responded yes, due to the urban and rural tiers requirement for wells and septic permits.

Chair Allam closed the public hearing.

Chair Allam announced the Board met in Closed Session and provided direction to staff.

Commissioner Carter moved, seconded by Vice Chair Burns that the Board ratify the action of the Interim County Attorney and abstain from voting on the Chapter 11 Plan of Reorganization of Endo International and its Affiliate Debtors.

The motion carried unanimously.
