<u>24-0076 Authorize the County Manager to execute an Interlocal Agreement with the City of Durham for the Southeast Durham Watershed Improvement Plan including contribution of \$910,895.51 towards its development.</u>

Pamela Andrews, Citizen

Ms. Andrews asked the Board to stop allowing developers to mass grade, clear trees and build near critical watersheds in Durham.

Tammie Sawaya, Citizen

Ms. Sawaya stated the Southeast Durham Watershed Improvement plan needed revisions and asked what the County would get out of the plan. She requested that Preserve Rural Durham and residents to receive monthly reports on the progress of the plan.

Tom Freeman, Citizen

Mr. Freeman asked the Board to stop all high-density construction until the outcome of the finding was received and reviewed.

Chair Allam requested staff to follow up with the citizen speakers.

The Board thanked the speakers for their comments and continued support of the watersheds in Durham. They stated the plan was an interlocal agreement with the City and there was a need to discuss the plan's concerns and issues with City Council. The Board stated they were looking at how the plan could be interfaced with the Unified Development rewrite and the implementation of prevention practices.

Ryan Eaves, Stormwater and Erosion Control Division Manager stated the department was planning robust outreach sessions to hear from all stakeholders and he would contact the citizen speakers to provide information.

Dr. Kimberly Sowell, County Manger stated the Interlocal Agreement would allow approval of the project and in the future, public outreach and engagement sessions would be held.

Directive: Chair Allam requested staff to follow up with the citizens speakers.

Commissioner Carter moved, seconded by Commissioner Jacobs to approve Item 24-0076 on the Consent Agenda.

The motion carried unanimously.
