Duke Diet and Fitness Wetland

Mr. Paul Wiebke, Stormwater Group Manager, presented the City's concept plan to convert the former Duke Diet and Fitness Center property into a constructed wetland. It would "filter pollution out of the stormwater runoff that accumulates from the Trinity and Downtown basins, a 485-acre area of downtown Durham. The concept plan includes re-directing the tributary of South Ellerbe Creek into the new constructed wetland; constructing shallow marsh, deep marsh, and deep pool areas in the wetland with a variety of native vegetation; improving the vegetation and habitat conditions to the creek; re-aligning the South Ellerbe Creek Trail; and adding amenities, such as seating areas, for recreational and educational purposes."

The conversion would necessitate the removal of the existing building. Commissioner Bowles, Chair of the Open Space Committee will attend a scheduled public meeting to see if the idea resonates with attendees to move the building to a different location on the site.

Section 3.1.5 add "d. County Open Space and Real Estate Administrator"

Section 3.2 In the first sentence, add "consecutive" before "years." Delete the second sentence. Delete the next-to-last sentence.

Section 5.5.1 change 3 to 2

Section 5.5.2 change to "A member who missed 40% of regular Commission meetings within a one-year period of time counting both excused and unexcused absences."

Section 5.5 in the last paragraph/sentence, add "or has violated the ethics or conflict of interest standard" before "the Chair of the Commission shall notify..."

Section 5.6 delete last paragraph

Section 6.4 add "Associate Committee Members do not have to reside in Durham County."
