Ceremonial Items

24-0379 Office of Emergency Services Receives Community Impact Award from CPI Security and WRAL

Dwane Brinson, Assistant County Manager stated the Emergency Medical Services' Community Paramedics Program received the award for the Bridge to Medication Assisted Therapy (MAT) Program. He added the program helped to reduce opioid overdose and supported individuals grappling with addiction in the community.

Mark Lockhart, Office of Emergency Services Director thanked the Board for the recognition and introduced the award recipients: Captain Helen Tripp, Program Manager, Phillip Keene, Community Paramedic and Lisa Smith, Community Paramedic. He added CPI donated \$1,000.00 to the Vic Pearson Memorial Fund.

Captain Tripp stated the Bridge to MAT Program started in May 2023 and 26 patients were inducted into the program. Ms. Smith stated the Community Paramedics not only helped keep citizens alive, but they also helped citizens thrive.

The Board thanked Mr. Lockhart, Captain Tripp, Ms. Smith and Mr. Keene for their dedicated services provided by the OES/EMS Departments. The Board inquired about the Vic Pearson Memorial Fund. Captain Tripp replied that the memorial fund was established by the family in memory of Vic Pearson, who was a Paramedic with Durham County EMS and passed. She added the award was presented to the EMS employee who displayed the highest level of competency and compassion to patients each year or employees who were faced with hardship.

24-0382 Proclamation – Durham Refugee Day

Commissioner Carter read the following proclamation:

DURHAM REFUGEE DAY | 2024

- **WHEREAS,** Durham Refugee Day was launched in 2017 to celebrate the courage, strength, and determination of refugees and immigrants living in Durham; and
- **WHEREAS,** more than 108.4 Million people are forcibly displaced worldwide by the end of 2023 as a result of persecution, conflict, violence, human rights violations or events seriously disturbing public order, and
- **WHEREAS,** the United States and Durham County have a proud humanitarian tradition since the late 1970's of welcoming refugees and immigrants of all nationalities and religions; and
- **WHEREAS,** the Durham County community knows that inclusion, respect and understanding of all those that work, play, worship, and live here promotes a community that we can be proud of.

NOW THEREFORE, I, Nimasheena Burns, Vice Chair and on behalf of the Durham Board of County Commissioners, do hereby proclaim June 29, 2024, as

"DURHAM REFUGEE DAY"

in Durham County, and hereby urge all residents to take note of this observance.
