Ceremonial Items

24-0582 Recognition of a \$1.5 Million Grant Award to Create and Implement the Energy Burden and Emissions Reduction Program

Tobin Freid, Sustainability Manger stated the \$1.5 Million Grant Award was to create and implement the Energy Burden and Emissions Reductions Program (EBERP). She added the EBERP was a new program to provide energy efficiency retrofits and limited home repair to low-to-moderate income households in Durham, Orange and Granville Counties over a three-year period. Ms. Freid presented the ceremonial check to the Board.

Megan Pendell, Sustainability Specialist stated the program goal was to upgrade 200 homes at no cost to the homeowner. She added the program would be employing local residents as neighborhood ambassadors and a Community Energy Fellow to assist the program for 18 months.

The Board asked about the program's neighborhood approach. Ms. Freid replied the program would be a phased approach to help under-resourced communities and the criteria would be established for neighborhoods. She added the bulk of the funding would be spent on neighborhoods in Durham County. The Board asked if the program would only assist a homeowner-occupied home. Ms. Freid responded the program would assist both owner-occupied and renter-occupied homes.

The Board thanked Ms. Freid and Ms. Pendell for the grant award and implementing the program.

- **WHEREAS,** Durham County invites you to join in partnerships, collaborations, and advocacy efforts to promote well-being, inclusion, and health equity for persons with dementia.

- **WHEREAS,** recovery from mental and substance use disorders occurs every day through a variety of prevention, recovery support resources and treatment programs. WHEREAS, the burden of brain disorders in the Unites States is among the highest of all diseases and among the most common cause of disability, Recent figures indicate the about 25% of all adults' experience symptoms of a mental disorder every year. Mental health disorders also affect children and adolescents at an increasingly alarming rate and people with untreated mental health disorders are at high risk for many unhealthy and unsafe behaviors, including alcohol and drug misuse, violent or self-destructive behavior and suicide. In addition, accidental overdose deaths, primarily due to fentanyl, continues to plague our nation as it is now combined with many other drugs. Given these statistics we must strive to reduce the stigma associated with brain disorders with the goal that the larger community will learn to view them as we would any other chronic medical condition, such as diabetes or hypertension; and

WHEREAS, behavioral health is now recognized as an essential part of one's overall health and wellbeing; and

WHEREAS, the theme for National Recovery Month is Recovery, Hope and Healing; and

- **WHEREAS,** the cost of not encouraging substance use recovery is significant for individuals, families, neighborhoods and the community at large; and
- **WHEREAS**, the behavioral health of every citizen is essential to the emotional and economic prosperity of our families, communities, and businesses; and
- **WHEREAS,** substance use disorders affect people of all ages, races, ethnicities, and socio-economic backgrounds; and
- WHEREAS, In 2023, there were more than 4,000 suspected overdose deaths in North Carolina; and
- **WHEREAS,** prevention of substance use disorders works, treatment is effective, and recovery is possible; and
- **WHEREAS,** feelings of personal shame and fears of social stigma and discrimination prevent many living with substance use disorders from seeking help; and
- **WHEREAS**, untreated substance use disorders leads to legal problems, serious health issues, financial difficulties, and damage to personal relationships; and
- **WHEREAS**, stigma can be reduced by increasing awareness of treatment and the available resources for substance use disorders in the Durham County community; and
- **WHEREAS,** recovery is a process of change through which individuals improve their health and wellness, live a self-directed life and strive to reach their full potential by building on their strengths, talents, coping abilities and community resources; and
- **WHEREAS,** we strive to create connections in Durham County that will support recovery by increasing access to treatment, educating ourselves and the community about the effectiveness and availability of treatment for substance use disorders; and

Public Hearings

24-0572 Public Hearing – Utilities Division's Engineering Report/Environment Information Document (ER/EID) for the Chin Page Road Lift Station, Force Main and Gravity Main Project

Vincent Chirichella, Senior Project Manager stated the Board was requested to conduct a Public Hearing to receive comments on the Utilities Division's Engineering Report/Environment Information Document (ER/EID) for the Chin Page Road Lift Station, Force Main and Gravity Main project. He added a new Chin Page Road Lift Station and associated piping was recommended to increase sewer capacity in the Northeast Creek basin, which consisted of the majority of Research Triangle Park (RTP) and surrounding areas. Mr. Chirichella stated the current sewer infrastructure in this basin did not have sufficient capacity for proposed development, re-development, and future flows anticipated from the adopted Durham City-County Comprehensive Plan.

The Board asked why a public hearing was required. Mr. Chirichella responded that the project was being funded in part by a loan. The Board inquired about the project completion timeline since the current sewer infrastructure was at capacity and asked if the project was designed to accommodate proposed development and future flows. Mr. Chirichella replied the project was projected to be complete in two and a half years and was designed to accommodate proposed development and future flows. The Board asked if the County could create a fund with Economic Development to support paying for new

lift stations to eliminate borrowing money. Andy Miracle, Economic Development Director responded he could have discussions with the Board about creating a fund.

Chair Allam opened the Public Hearing. With no one signed up to speak, Chair Allam closed the public hearing.

There was no vote required for the Public Hearing.

The Board thanked Mr. Chirichella for the Public Hearing on the Chin Page Rad Lift Station.
