Proclamation—Home Care and Hospice Month

Chairman Page read the following proclamation into the record to designate November as National Home Care and Hospice Month in Durham County:

PROCLAMATION

WHEREAS, in-home health, hospice, and community-based services provide for an individual's health and social needs across the continuum of life—compassionate care which serves expectant mothers, infants, children, adults, the disabled, and elderly, and also provides love, comfort, and support at the end of life; and

WHEREAS, in-home health, hospice, and community-based services enable Durham County citizens to access a wide variety of quality health and social services, including preventive care, acute care, sustainable long-term care, and palliative care; and

WHEREAS, these services include care provided by home health agencies, licensed home care agencies, hospice agencies, adult day care, and adult day health care facilities, and home medical equipment companies; and

WHEREAS, in-home health, hospice, and community-based services build upon a strong tradition of care and compassion, striving to keep families intact and responsible while preserving an individual's independence and dignity in the setting of their choice;

WHEREAS, Duke Home Care & Hospice services have provided care to terminally ill patients and their families for 33 years:

NOW, THEREFORE, BE IT RESOLVED that I, Michael D. Page, Chairman of the Durham Board of County Commissioners, do hereby proclaim November 2012 as

HOME CARE AND HOSPICE MONTH

in Durham County. I urge our citizens to celebrate all in-home and community-based services.

Carol Ann Mullis, Program Manager, Duke HomeCare and Hospice, thanked the Board for the proclamation. She provided a brief overview of the services provided by Duke HomeCare.

Proclamation—National Adoption Month

Each year National Adoption Month is celebrated in November to raise awareness of the need for adoptive homes for children in foster care.

Chairman Page read the following proclamation to recognize the importance of adoption as a path to permanency for children in foster care in our community:

PROCLAMATION

WHEREAS, the County of Durham recognizes the importance of giving children in foster care permanent, safe, and loving families through adoption; and

WHEREAS, every child deserves the chance to grow up in a loving, stable family; and

WHEREAS, children of all ages need adoptive homes: 40% percent are five years of age and under; 40% are between 6 and 12 years; and 20% are between 13 and 18 years old. Many of them are siblings and need to be placed together; and

WHEREAS, more than 130,000 children in the United States foster care system are waiting to be adopted; and

WHEREAS, more than 10,000 children in North Carolina are waiting for permanent families; and

WHEREAS, more than 158 children in Durham County are in foster care—23 of whom are legally free for adoption, and 7 of that number are not in an adoptive placement and are waiting for permanent families; and

WHEREAS, this effort along with similar celebrations in all 50 states around the country will offer children the chance to live with stable and loving families and encourage other dedicated individuals to make a powerful difference in the lives of a child through adoption:

NOW, THEREFORE, BE IT RESOLVED that I, Michael D. Page, Chairman of the Durham Board of County Commissioners, do hereby proclaim November 2012 as

ADOPTION AWARENESS MONTH.

I commend this observance to our citizens and urge all citizens to join in raising awareness on behalf of the seven children in Durham County who are waiting for a loving family. I further encourage communities, businesses, schools, faith-based organizations, and families to "answer the call" and honor the special needs of Durham County's children in hopes of securing a permanent, loving family for each and every child regardless of race, age, gender, healthy, emotional, or behavioral condition and past distress.

Victor Isler, Child Placement Program Manager, DSS, elaborated on the department's process and initiatives for placing foster children.

Chairman Page inquired about workshops and events in honor of Adoption Awareness Month.

Janice Williams, Adoption Supervisor, provided statistics on children placed in foster care and those who had been placed with families.

Commissioner Howerton thanked Mr. Isler and Ms. Williams for their devoted work.

As a former foster parent, Commissioner Karriker thanked the foster care unit and commended the community for stepping forward to adopt Durham's displaced children.

Vice-Chairman Reckhow asked that thanks be relayed to staff for their work which contributes to the unit's innovative leadership.

Chairman Page presented the proclamation to Mr. Isler and Ms. Williams.
