Budget Ordinance Amendment No. 11BCC000018 – Recognizing and Appropriating A \$542,492 Grant Award from The Substance Abuse And Mental Health Administration (SAMSHA) for the Building Every Chance of Making It Now And Grown Up Project (BECOMING) Project And Approving Five New Positions Related To The Grant

The Durham Center requests that the FY 2010-11 Mental Health budget be increased by \$542,492. The Durham Center was recently awarded a grant by The Substance Abuse and Mental Health Services Administration (SAMSHA) for the BECOMING (Building Every Chance of Making It Now and Grown Up) project. The amount of the proposed budget increase reflects the Year One grant award. These federal dollars will fund two full time positions (2 FTEs) and 3 half time positions (1.5 FTEs) plus benefits for a total of \$224,035. It also includes \$26,600 for two required grantee meetings (10 persons per trip specified by SAMHSA), \$67,630 for computers, phones and office supplies, \$56,378 for rent and furniture and \$167,850 for consultation and evaluation activities.

The project is to begin September 30, 2010 and continues until September 29, 2016. It will target high-risk 16-21 year olds who have a serious mental illness and significant problems functioning in their relationships, at school, or in the community. As a result, these young people have become disconnected or are at risk of becoming disconnected from the services and supports that can assist them with a successful transition to adulthood.

<u>County Manager's Recommendation</u>: The County Manager recommends the Board recognize the SAMSHA grant award, approve Budget Ordinance Amendment No. 11BCC000018 appropriating \$542,492 of SAMSHA grant funds to the Mental Health budget, and approve the creation of two full time positions and three half time positions related to the grant.
