6. <u>Public Hearing to Consider Allocating Economic Development Investment Funds to bioMerieux, Inc. (20 min)</u>

The Board is requested to hold a public hearing to consider allocating \$400,000 in economic development investment funds to bioMérieux, Inc., the U.S. subsidiary of a French medical diagnostic healthcare company with its US headquarters in Treyburn Corporate Park in Durham, North Carolina. bioMérieux, Inc. provides diagnostic healthcare solutions that improve patient health and ensure consumer safety. The

company is a worldwide leader in developing tests that bring high medical value for clinical decisions related to infectious diseases, cardiovascular emergencies, targeted cancers, and tests assisting doctors in making health care decisions for patients. In industrial applications, the company significantly contributes to preventing contamination risks in agri-food, pharmaceutical and cosmetic products.

- bioMérieux is celebrating its 50th anniversary in 2013 and employs approximately 7,000 workers globally at 21 industrial sites. The company is experiencing strong global growth which requires adding additional manufacturing capacity to meet growing demand. The company is considering options to expand its capacity in Brazil, India, China or Durham.
- 3) bioMérieux employs approximately 637 full-time employees in North Carolina. The Treyburn facility in Durham is a manufacturing operation providing blood culture bottles for the global market and currently employs approximately 108 full-time manufacturing employees. Company officials have stated that 33 of the company's jobs in Durham County would be lost should bioMérieux locate its expansion elsewhere. Durham County is being asked to partner with the State of North Carolina in a One NC Fund grant to support the retention of these jobs in North Carolina and the creation, through expansion, of 44 new full-time jobs with an average salary of \$50,000. If bioMérieux selects Durham County to locate its expansion, the 33 Durham County jobs at risk would be retained, and the company would create 44 new full-time jobs in Durham by 2015. The company proposes to add 25,500sf to the production facility, built to LEED standards. This would entail a capital investment of approximately \$48 million dollars to fund the expansion. Company officials have stated that local incentives will be a key factor in its decision of where it will locate its expansion operations.
- 4) Because bioMérieux is an important partner in our community's biotechnology sector, the proposed expansion is being supported by the North Carolina Biotechnology Center. A decision to locate its new production facility elsewhere could adversely impact the sector's future growth in Durham County.
- Staff is recommending that the county provide four hundred thousand dollars (\$400,000) to encourage bioMérieux's \$48 million dollar capital investment in Durham County, and to retain the 33 current jobs at risk, and the creation of 44 new full-time jobs through expansion. Funds would be furnished over a five year period through an economic development incentive fund performance contract. No payment would be made unless and until the company commits to stay in Durham. Should the company leave Durham during the life of the contract, some or all of any payments made may be recovered. The County funds will be used to reimburse bioMérieux, Inc. for expenses related to site preparation. The funds will be paid from the General Fund of the County of Durham.

<u>County Manager's Recommendation</u>: The County Manager recommends that the Board conduct the public hearing and, if appropriate, approve the proposed incentives.

7. <u>FY 2013-2014 Annual Action Plan "Needs" Public Hearing</u> (20 min)

- The City of Durham Department of Community Development requests that the Board of County Commissioners hold the FY 2013-2014 Annual Action Plan "Needs" public hearing on February 11, 2013 to receive citizen comments. The purpose of this meeting is to receive citizen comments on how City-County HOME Consortium funds can be used to address housing needs in Durham for the 2013-2014 fiscal year.
- Durham anticipates receiving approximately \$652,712 in HOME Consortium funds from the U. S. Department of Housing and Urban Development (HUD). Due to the renewal of a HOME Consortium Agreement in 2011with Durham County, HOME Consortium funds will be jointly awarded to the City and County on a pro rata share of approximately 95% and 5%, respectively. In previous years, HOME Consortium funds have been used primarily for housing activities in Durham with special focus on target neighborhoods; including existing homeowner rehabilitation and first-time home homebuyer activities. Approximately, \$146,860 in non-federal funds will be needed from the HOME Consortium for the matching funds requirement of the HOME program.
