# <u>Continuation of a Public Hearing to Consider Amendments to the Sign Section of</u> the Zoning Ordinance Originally Considered at the August 10, 1998 Meeting

An ordinance amending the sign section of the Zoning Ordinance (Section 12) was considered at a public hearing on August 10, 1998. At that meeting, the matter was delayed for technical changes. The ordinance proposal was unchanged except for wording which assures that freestanding signs are not located within the vision clearance area.

Ms. Bonnie Estes was at the meeting to present this item.

County Manager's Recommendation: Approval of the amendments.

County Attorney Chuck Kitchen suggested additional detail be included regarding the sign setback to improve clarity of the amendment.

Ms. Estes said the effective date should be December 1, 1999, not September 1, 1999.

Deputy County Attorney Lowell Siler made remarks about future amendments to the sign ordinance.

The Commissioners asked questions and made comments about the proposed amendments to which Ms. Estes responded.

Mr. Siler also assisted with the answers.

County Attorney Kitchen suggested the amendments not be approved tonight because another public hearing may be required.

Chairman Black requested no action be taken on this agenda item at this time. The proposal would be sent back to the City-County Planning Department for review.

## Public Hearing--Street Closing--SC98-3; Gorman Church Road

Gorman Baptist Church presented its request to close 72,005± square feet of Gorman Church Road, west 1,195± linear feet from Red Mill Road.

Vonda Frantz, Senior Planner, Durham City-County Planning Department, was present to answer questions of staff regarding the request.

<u>County Manager's Recommendation</u>: That the County Commissioners approve the request to permanently close 72,005± square feet of Gorman Church Road.

Chairman Black opened the public hearing that was properly advertised.

# COUNTY OF DURHAM ORDER PERMANENTLY CLOSING 72,005± SQUARE FEET OF GORMAN CHURCH ROAD

WHEREAS, the Durham Board of County Commissioners adopted a Resolution on August 10, 1998, declaring its intent to close the street or alley or portion thereof that is generally described in the caption of this order and that is more fully described in Attachment A, attached hereto and incorporated herein;

WHEREAS, the Resolution provided for the holding of a public hearing on the question of whether said street should be permanently closed; and

WHEREAS, notice of the closing of said street was sent by registered or certified mail to all owners as shown on County Tax Records of property adjoining the street to be closed; and

WHEREAS, a Notice of the closing and public hearing was prominently posted in at least two places along the street to be closed; and

WHEREAS, the notice of the closing and public hearing was published once a week for two successive calendar weeks; and

WHEREAS, this matter came on for hearing before the Board of County Commissioners of Durham County at its regular meeting on August 24, 1998; and all persons who desired to be heard were heard at that time:

NOW, THEREFORE, the Board of County Commissioners of Durham County, having carefully considered the question of permanently closing the street or alley or portion thereof as is more fully described in Attachment A, finds:

- 1. That closing of the street or alley described in Attachment A is not contrary to the public interest, and
- 2. No individual owning property in the vicinity of the street would thereby be deprived of reasonable means of ingress or egress to his or her property.

# IT IS THEREFORE ORDERED:

- 1. That the street described in Attachment A is permanently closed subject to the retention of any utility improvements and/or easements described therein.
- 2. That a certified copy of this Order shall be filed in the Office of the Register of Deeds of Durham County, North Carolina.
- 3. That property owners adjacent to the closed street shall take right, title, and interest as is provided in G.S. 160A-299 (c).

4. That this Order is effective upon and after the date of its adoption as shown by the stamp of the County Clerk below.

# <u>Public Hearing for the Consideration of Allocating Economic Development Investment Funds to Tivoli, a Subsidiary of the IBM Corporation</u>

Tivoli, a subsidiary of the IBM Corporation, designs, develops, manufactures, and sells network management software. IBM is considering significantly expanding local Tivoli operations by locating two new software manufacturing facilities in Durham County. IBM is considering constructing two 100,000-square-foot facilities on property near the intersection of Miami Boulevard and Chin Page Road. The total construction costs of these facilities are estimated to be at least \$28 million. Upon completion, the facilities will house IBM's software manufacturing and development operations for Tivoli. IBM expects to create an additional 100 to 200 new jobs in software development and customer support over the next two years.

IBM is in the process of making the final decision on where to locate the new Tivoli facilities. Other areas outside of North Carolina are being evaluated for this investment. IBM has communicated to the County Manager and staff that Durham County's financial support for this project will be a key consideration in the final decision. IBM has requested that the County participate in the costs of sanitary sewer installation for the proposed facilities.

Staff recommended that the County participate in this project by reimbursing IBM up to \$420,000 for the design and construction costs of extending sewer utilities to the proposed development and for the costs of associated sewer connection fees. The reimbursement payments would be made in equal installments over a five-year period with revenues from the County's Enterprise Fund beginning the fiscal year after construction of the new facilities has been completed.

<u>County Manager's Recommendation</u>: Approve the contract between Durham County and IBM Corporation to allow for the reimbursement of costs associated with extending sanitary sewer to the proposed Tivoli development.

David Powell, Real Estate Manager/Economic Development Manager, presented an overview of the Tivoli project to the County Commissioners.

The Commissioners asked questions and made comments about the proposed project to which Mr. Powell responded.

Commissioner Bowser stated he would support the project.

The Commissioners expressed their support for the project and praised IBM for considering Durham County and for bringing additional jobs to the County.

Chairman Black opened the public hearing that was properly advertised.

<u>Jack Steer</u>, 2416 Dawn Trail, representing The Friends of Durham, said "we have been pleased with IBM being a good neighbor and we certainly hope the Commissioners will approve the request."

<u>Ralph McKinney</u>, 500 Fairfield Road, said he was pleased with IBM developing jobs in the area.

<u>Patrick Byker</u>, 2614 Stuart Drive, representing the Chamber of Commerce, said the Tivoli project is a part of the partnership with the Durham Chamber, Durham County Government, and the N. C. Department of Commerce. This project has been a team effort and we are pleased to bring this project before the Commissioners.

<u>Tom White</u>, 2729 Sevier Street, representing the Greater Durham Chamber of Commerce, said this is a great project for the City and County. It will increase the tax base and provide good paying jobs for our citizens.

As no one else asked to speak, Chairman Black closed the public hearing and referred the matter back to the Commissioners for consideration.

Commissioner Bowser moved, seconded by Vice-Chairman Reckhow, to approve the contract between Durham County and IBM Corporation (with changes just mentioned) to allow for the reimbursement of costs associated with extending sanitary sewer to the proposed Tivoli development.

# Public Hearing on Southeast Durham Plan

Southeast Durham is one of 15 small areas that comprise Durham County. The planning area is approximately 29 square miles and is located between NC 147, NC 98 and the Durham-Wake County line, and T. W. Alexander Parkway. Southeast Durham is a mix of rural, suburban, and urban neighborhoods with a growing industrial base on the edge of the Research Triangle Park.

The Southeast Durham Plan is a detailed guide for future land use and development in the area based on the adopted *Durham 2020 Comprehensive Plan*. Outside of the Urban Growth Area, the plan recommends rural land uses. Inside the Urban Growth Area, the plan calls for new suburban housing areas, new commercial centers along major roads, and new employment centers near the Research Triangle Park. The first segment of Eno Drive scheduled to be constructed traverses the planning area and will significantly improve access to the area. Future public sewer services in the Lick Creek basin will likely stimulate demand for new housing and commercial development. The Southeast Durham Plan seeks to accommodate new development while protecting the integrity of existing neighborhoods.

Mr. Keith Luck was the principal planner for the small area plan and presented this item to the Board.

<u>County Manager's Recommendation</u>: Conduct a public hearing of the Southeast Durham Plan and solicit public comment. At the end of the public hearing, it would be appropriate to either approve the plan or to instruct staff to make additional modifications as per the Board's direction.

The Commissioners asked questions and made comments about the plan to which Mr. Luck responded.

Chairman Black opened the public hearing that was properly advertised.

<u>Dr. George Conklin</u>, 2905 Scuppernong Lane, spoke in general terms about the plan. He urged the Commissioners to delay plan approval pending the resolution of the green area on the map. The area is rural/rural district which is not realistic since Raleigh is ready to charge across the border.

Mr. Luck responded to Dr. Conklin's remarks at the request of Chairman Black. Planning Director Paul Norby also assisted with the response to Dr. Conklin's remarks.

Mr. Ralph McKinney, 500 Fairfield Road, spoke about racism, housing, protection of our citizens, and health concerns.

Ms. Virginia Bowman, 311 Watt Street, representing the Durham Coca-Cola Bottling Company, stated the company owns 178 acres in a 700-acre tract in the Southeast Durham planning area. She endorsed the plan and thanked the Commissioners for letting them participate in the process.

Ms. Charlotte Myer, 5201 Shagbark Drive, President of Stirrup Creek Homeowners Association, stated the citizens wish to keep the area single-family residence. The southeast area is very desirable to live in. Our main focus is to maintain single-family residence along Lumley Road and to maintain the property values. The plan addresses our need in reference to the Lumley Road area maintaining single-family residence.

As no one else asked to speak, Chairman Black closed the public hearing and referred the matter back to the Commissioners for consideration.

The Commissioners asked additional questions to which Mr. Luck responded.

The Commissioners concurred to defer action on the Southeast Durham Plan and to refer it back to the City-County Planning Committee for additional work before sending the plan to City and County Governments for approval.

## Senate Bill 421: Freeze Property Tax Values in 2000

Vice-Chairman Reckhow asked County Attorney Chuck Kitchen to give the Commissioners background information on Senate Bill 421.

County Attorney Kitchen explained the legislation and told of its implications for Durham County.

County Manager David F. Thompson also spoke about the legislation.

Vice-Chairman Reckhow read the Resolution Opposing Senate Bill 421 into the official record.

The resolution follows:

# **RESOLUTION OPPOSING SENATE BILL 421**

WHEREAS, a bill, S421, has been introduced in the North Carolina Senate which would restrict revaluation of real property to those times the property is purchased, newly constructed, or a change in ownership has occurred; and

WHEREAS, the inflationary rate could only be adjusted by 2 percent per year; and

WHEREAS, this bill would have the effect of shifting the property tax burden from industry to the ordinary citizen in that residential property is sold more often than industrial property; and

WHEREAS, where such proposals have been adopted, there have been large impact fees imposed on the sale of new houses to pay for services; and

WHEREAS, where such proposals have been adopted, there has been a proliferation of special tax districts to pay for services which the government cannot afford to pay for out of property taxes; and

WHEREAS, since fees for special tax districts are not deductible from Federal Income Tax as are property taxes, the Federal Income Tax burden is increased significantly:

NOW, THEREFORE, THE BOARD OF COMMISSIONERS FOR THE COUNTY OF DURHAM DOTH RESOLVE:

- 1. The legislative delegation representing the citizens of the County of Durham are called on to oppose Senate Bill 421.
- 2. The County Manager is directed to mail a copy of this Resolution to each member of the legislative delegation and to the Association of County Commissioners.

## **Durham County Railroad Crossings**

Chairman Black expressed concern about automobiles trying to outrun trains at railroad crossings. Mark Ahrendsen, Director of City Transportation, advised Chairman Black to write a letter to the railroad company, City Transportation, and to the North Carolina Department of Transportation asking them to do something about the problem by installing safety equipment to make the crossings safer.

Chairman Black asked County Manager Thompson to meet with Mr. Ahrendsen and compose a letter to send to the railroad company, city, and state.

The County Manager commented he will follow up with Mr. Ahrendsen on the letter.
