Opening of Regular Session

Chairman Reckhow welcomed everyone to the Monday, November 13, 2006 Regular Session of the Board of County Commissioners. She requested all in attendance to stand for the recitation of the Pledge of Allegiance.

Chairman Reckhow recognized and welcomed Boy Scout Troop 439 from Bahama.

Agenda Adjustments

Chairman Reckhow reported that at the October 9 BOCC meeting, the Commissioners approved a motion to excuse Commissioner Michael Page from this meeting.

Chairman Reckhow added a special recognition of the Planning Department to follow approval of the minutes.

Planning Department Recognition

Chapter of the American Planning Association Conference, the City-County Planning Department received the 2006 Marvin Collins Outstanding Planning Award, Honorable Mention. The award category was "Special Themes, Smart Growth," and was awarded to both the City and County of Durham in recognition of the new Durham Comprehensive Plan, which was adopted last year. She commended the Planning Department for its efforts and Frank Duke, Planning Director, for playing such a strong leadership role. She asked Mr. Duke to come forward for comments.

Mr. Duke stated that the work on the project was accomplished by the Comprehensive Plan Steering Committee, on which Chairman Reckhow represented the County Commissioners. The many volunteer hours dedicated by Committee members helped create a better plan. Mr. Duke also acknowledged the work of the Durham City-County Planning Commission in reviewing the plan at length, the many citizens who attended the public meetings and hearings on the issue to provide input, and the work of the Board of Commissioners and City Council to ascertain that the plan would represent a unified vision for both the City and the County.

Chairman Reckhow agreed with Mr. Duke's comments regarding the strong citizens' efforts and recognized them for taking such an important role. She then presented the award to Mr. Duke with congratulations.

November Anchor Award Winner—Nancy Mishue

Chairman Reckhow acknowledged Nancy Mishue, Department of Social Services, for being chosen as the November Anchor Award recipient due to her superior work for many years. She congratulated Ms. Mishue on behalf of the Board of Commissioners.

Sammy Haithcock, DSS Director, and Sharon Hirsch, DSS Assistant Director, Customer Access and Program Support Services, gave tribute to Ms. Mishue for 33 years of service at the Main Street DSS reception desk, and particularly for her unending dedication to the Department of Social Services' core values of respect, integrity, and partnership. Her warm smile, patient demeanor, and positive attitude have meant that hundreds of thousands of

individuals have been treated with kindness, courtesy, and respect when they have come to the agency in their time of need.

Vice-Chairman Heron expressed concern that the monies appropriated were for capital expenditures and administrative costs. She asked how the agencies that provide the transportation to the elderly and the disabled receive their money.

County Manager Mike Ruffin responded that two grants fund the Community Transportation Program. This particular grant cannot be used for services, only for administration and capital. The Rural Operating Assistance Program (ROAP) grant funds, which are approved by the Board annually, are used for the division of services for the clients.

Vice-Chairman Heron asked for information about how ROAP grant funds are distributed to the agencies.

COMMUNITY TRANSPORTATION PROGRAM RESOLUTION FY 2007-2008

Applicant Seeking Permission to Apply for CTP Funding, Enter Into Agreement with the North Carolina Department of Transportation, and to Provide the Necessary Assurances

Whereas, Article 2B of Chapter 136 of the North Carolina General Statutes and the Governor of North Carolina have designated the North Carolina Department of Transportation (NCDOT) as the agency responsible for administering federal and state public transportation funds; and

Whereas, the North Carolina Department of Transportation will apply for a grant from the US Department of Transportation, Federal Transit Administration and receives funds from

the North Carolina General Assembly to provide assistance for rural public transportation projects; and

Whereas, the purpose of these transportation funds is to provide grant monies to local agencies for the provision of rural public transportation services consistent with the policy requirements for planning, community and agency involvement, service design, service alternatives, training and conference participation, reporting and other requirements (drug and alcohol testing policy and program, disadvantaged business enterprise program, and fully allocated costs analysis);

Whereas, Durham County Government hereby assures and certifies that it will comply with the federal and state Statutes, regulations, executive orders, Section 5333 (b) Warranty, and all administrative requirements which relates to the applications made to and grants received from the Federal Transit Administration, as well as the provisions of Section 1001 of Title 18, U.S.C.

NOW, THEREFORE, BE IT RESOLVED that Chairman Ellen W. Reckhow of the Durham County Board of Commissioners is hereby authorized to submit a grant application for federal and state funding, make the necessary assurances and certifications, and be empowered to enter into an agreement with the NCDOT to provide rural public transportation services.

Public Hearing—Zoning Map Change—George King Road (Z05-23)

Frank Duke, AICP, City-County Planning Director, stated the request to approve a zoning map change for a 20.82-acre site located on the west side of George King Road, south of Ephesus Church Road and east of Kinsale Drive. PIN 0709-03-02-6187. Request: RS-20 to PDR 2.690.

Mr. Duke continued by stating that a development plan is required with this request. This indicates that the general physical layout of the property shown on the development plan is committed as part of the adopted rezoning. Any significant change in the plan will require a new zoning petition for the property. The development plan submitted with this request includes the following committed elements:

- 1. Maximum number of lots: 56 lots.
- 2. Minimum residential lot size: 6,600 square feet.
- 3. Minimum open space: 4.18 acres (20.1%).
- 4. Minimum tree coverage: 4.18 acres (20.1%).
- 5. The developer will plant a hedge row of 5-foot high minimum eastern red cedar (or similar evergreens) 8-foot on center along the George King Road frontage.
- 6. Construction of a mulch walking trail as shown on plan. Trail to be constructed prior to the issuance of the 40^{th} certificate of occupancy.
- 7. The developer will pave George King Road to meet NCDOT standards from edge of current paving terminus to the north of the site, through the southern property line of the site.

- 8. The developer will provide curb and gutter along George King Road along the frontage of the site.
- 9. Subject to approval by the City of Durham Public Works Department (Engineering and Transportation Divisions) and NCDOT, the applicant will stripe a crosswalk in George King Road at the appropriate location to provide access to the existing elementary school.
- 10. SW Durham Drive Alignment The applicant agrees to dedicate right-of-way as necessary to achieve the ultimate 110' right-of-way as illustrated in the form of both Alignment "A" and Alignment "B" of SW Durham Drive. A copy of the recorded plat illustrating both right-of-way dedications must be submitted prior to issuance of the first building permit.
- 11. At the time of building permit, the applicant will make a voluntary school contribution for Durham Public Schools in the amount of \$500 per single-family unit, with appropriate credit given against any other school impact fees that may be in place at the time.
- 12. Site grading will be performed on a lot-by-lot basis, with the exception of grading for utilities and road improvements.

Mr. Duke stated that the Planning staff recommended approval, including approval of a maximum of 16 lots within the TUA, based on consistency with the *Comprehensive Plan*. In addition, the Planning Commission found that the ordinance request is consistent with the adopted *Comprehensive Plan*, believes the request is reasonable and in the public interest, and recommends approval based on the information contained in the staff report and comments received during the public hearing.

Per a question posed by Vice-Chairman Heron, Mr. Duke responded that the applicant must provide sidewalks consistent with the provisions of the Unified Development Ordinance.

Chairman Reckhow and Vice-Chairman Heron discussed the completion deadline for the walking trail (to be completed about mid-point in the project).

Chairman Reckhow opened the public hearing that was properly advertised.

<u>Patrick Byker</u>, 2614 Stuart Drive, Durham, 27707, representing East-West Partners, presented reasons why the Board should support the zoning map change.

In response to Vice-Chairman Heron's concern regarding grading, Mr. Byker stated that the lots will be graded one lot at a time; the only grading across the lines will be for utilities and road improvements.

<u>William Dunk</u>, 325 Nantahala Drive, Durham, opposed the zoning map change. He requested that the rezoning be delayed due to documents not being available.

Chairman Reckhow closed the public hearing and referred the matter back before the Board.

Public Hearing—Zoning Map Change—Claremont Acres (Z06-53)

Planning Director Frank Duke stated the request to approve a zoning map change for a 4.94-acre site located on the north side of Scott King Road, east of Herndon Road and both sides of Clausun Drive. PINs 0727-03-14-1006, -1400, -2352, -3169, -3077, 0727-03-13-1900, -3957. Request: RR; F/J-B to RS-20; F/J-B.

Mr. Duke continued by stating that in the event that a motion to approve the item fails, the Commissioners adopt as support for their actions on the proposed zoning map change the determination that, notwithstanding its consistency with the *Comprehensive Plan*, the request is neither reasonable nor in the public interest in light of information presented in the public hearing and in the accompanying agenda materials.

Mr. Duke informed the Board that staff recommended approval based on consistency with the *Comprehensive Plan* and the information contained in the report. The Planning Commission recommended approval based on a 13-0 vote on September 12, 2006, finding that the requested revision to the zoning districts of the UDO is consistent with the adopted *Comprehensive Plan*.

Chairman Reckhow opened the public hearing that was properly advertised and called signed speakers forward for comments.

Kelvin Green, 4200 Grove Ridge Drive, Durham, responded to questions by the Board.

Chairman Reckhow closed the public hearing and referred the matter back before the Board.

Commissioner Cheek moved, seconded by Commissioner Cousin, to approve Zoning Map Change—Claremont Acres (Z06-53).

Public Hearing—Plan Amendment, 5200 Wake Forest Highway (A06-02)

Mr. Frank Duke requested that the Board conduct a public hearing on a plan amendment for 5200 Wake Forest Highway (A06-02) and to approve the requested change to the land use designation on the Future Land Use Map of the *Durham Comprehensive Plan* from Low

Density Residential (4 DU/Ac. or less) to Commercial. The Planning Department recommended approval based on the justification and meeting the criteria for plan amendments. The Planning Commission recommended denial on June 29, 2006 (9-4), based on possible commercial uses expanding to the east of the site.

Chairman Reckhow opened the public hearing that was properly advertised. The following speaker provided comments:

<u>Drew Marsh</u>, 616 Nantahala Drive, Durham, presented his remarks and responded to questions by the Board.

Ronald Horvath, 16 Consultant Place, Durham, stated that a buffer has been added along the eastern property line that would deter any inner connections.

County Attorney Chuck Kitchen provided comments related to the zoning. He stated that the Board's consideration should be solely based on the plan.

Chairman Reckhow closed the public hearing and referred the matter back before the Board.

Commissioner Cheek moved, seconded by Vice-Chairman Heron, to approve Plan Amendment, 5200 Wake Forest Highway (A06-02).
