Chairman Ellen W. Reckhow called the meeting to order and welcomed everyone to the worksession of the Board of County Commissioners, Monday, December 6, 2004. This is a special occasion.

We will proceed with Michael Ashe, Director, Board of Elections, presenting the certificates of Election to the local reelected officials.

Board of Elections Presentation of Certificates

The Board of Elections presented Certificates of Election to the candidates certified as having officially won the November 2, 2004 election.

Chairman Reckhow asked Michael Ashe to proceed.

Mr. Ashe made the following remarks:

"Good Morning Ladies and Gentlemen. Life is good and getting better. Thank you for letting me share this happy time with you.

I'm Mike Ashe, the Director of Elections. I'd like to introduce two members of the Board of Elections – Chairman Ron Gregory and Secretary Terry McCabe.

The purpose of my being here this morning is to present Certificates of Election to the winning candidates as mandated by state law. The totals are official when my Board certifies the results according to law during the CANVASS. This morning, L&G this ceremony is icing on a beautiful cake.

The beautiful cake I'm speaking about is Democracy, and I'd like to announce that Democracy is alive and well in Durham County, North Carolina. We have just successfully completed the most Extraordinary Election in our history.

Please indulge me for a short trip down memory lane!!!

Filing for office was supposed to start in February, but because the state legislature was still fighting over redistricting (for the 3rd year in a row), it was delayed until the 26th of April. The May primary was cancelled and finally rescheduled for July 20th. All of you winners survived the primary and moved to the November ballot. We then had to have a second primary for the St Superintendent of Public Inst on Aug 17. Many of my precinct judges plan their work and family plans around our scheduled elections—changing the primary from May to July resulted in approx 10% of our judges not being able to work.

Just to make the primary and 2nd primary even a little more fun, many requirements of the new federal Help America Vote Act were implemented for the first time this year---voters signatures, limited voter ID, new required signage, new provisional procedures, and high school students working at the polls.

By law, our books were closed for 55 days. (25 days before the primary and then another 30 because of the 2nd primary) We could not process the thousands of registrations and changes we were receiving. This compressed schedule set the stage for an exciting Sept and Oct.

Phone calls, emails, walk-ins, letters, and faxes. We had more business than ever before. We had more new registrations than ever before: Jan-Oct this year we had 31, 387 new registrations-over twice as many as in 2000.

One stop—in 2000, 10,000 people voted at one stop. This year, over 46,000 voted at one stop. I was amazed. I had no idea so many people wanted to vote for register of deeds!!

This election had more scrutiny than any other election. I received and answered dozens of public information requests explaining every aspect of our process. I demonstrated our voting system to several watchdog

organizations. Party activists and the media virtually lived at the BOE for three months. The political parties had observers in every one stop site. There were partisan observers inside almost every precinct on Election Day. There were multiple advertised "voter hot lines" set up for voters to call with questions. And finally, on election day, both the Democrats and Republicans had an out of town lawyer in my office from the minute the polls opened until well after they closed-every email, phone call, radio transmission and conversation were observed.

On November 9th, by law, the Board of Elections met in open session to CANVASS or officially certify the results of our election. 111,685 people voted in Durham. The previous record was 87,000-we set a new record by over 24,000 voters. We had a turnout rate of 73.14%, also a new record.

We did not receive any protests or challenges to our results or process. Let me repeat —we did not receive any protest or challenges to our results or process.

On November 15th through the 17th, we conducted a state directed recount of the Commissioner of Agriculture and Superintendent of Public Instruction races. We recounted over 111,000 ballots. The recounted results were virtually the same as on Election Day. This is huge, especially in light of multiple problems in the state and nation. Our voting system was once again completely validated.

There is a sign posted in my office that states: Democracy lives here—Citizens cast a secret ballot that is then honestly counted and honestly reported. It is an awesome system!!!

To the seven winners here--- the citizens of Durham have cast their secret ballots and believe you are the best people to serve them and our community. Your election was fair and honest. No one has nor can anyone ever question the legitimacy of your victory.

So, as we present you with your certificate of election, on behalf of my Board and 111,685 voters—congratulations, God Bless, and God Speed."

Vice-Chairman Heron thanked her husband, Duncan Heron, for his hard work during the campaign. Families do make a sacrifice. That is a part of the job. I will be here to serve the citizens over the next four years. Thank you for your support.

Chairman Reckhow recognized Commissioner Cousin.

Commissioner Cousin said he appreciated this opportunity to congratulate my returning colleagues and to congratulate and welcome two new members of the Board of County Commissioners, Lewis A. Cheek and Michael D. Page. I want to thank the citizens of Durham County for the trust that has been displayed in reelecting me to this office. She understands that this is an opportunity to serve the needs of the greatest number of people and certainly the best people in the world, the citizens of Durham County. I count it an honor and privilege not only to serve you but to live here. I promise to discharge my duty to the best of my ability for the next four years and four years only.

Chairman Reckhow recognized Commissioner Cheek.

Commissioner Cheek thanked the people of Durham again for giving him the opportunity to serve. I was fortunate to have many who were willing to provide me help, support, monetary support, encouragement, and sweat equity. He especially thanked his family and friends who provided him with strength, love, and encouragement. He thanked his campaign vice-chair Jackye Brown, who offered her advice. He thanked everyone at his office for all of their help. My goal for Durham is to achieve everything we can and make life better for everyone and to reach out to each other and show each other dignity and respect.

Commissioner Cheek talked about and made remarks about the influence his mother and father had on his life when he was a child and growing up to adulthood.

Commissioner Lewis A. Cheek—Special Presentation

Council member Diane Catotti and Jackye Brown presented Commissioner Cheek with a Ken cell phone in response to the Barbie cell phone that Councilman Lewis Cheek presented to them when he was leaving membership on City Council a year ago.

Welcome

Chairman Reckhow recognized the elected officials that were in attendance at the swearing-in ceremony.

Chairman Reckhow recognized Commissioner Michael D. Page.

Commissioner Page congratulated Chairman Reckhow and Vice-Chairman Heron. I welcome this opportunity to work with the remaining board members who are here today. Today is a special time for me because I really understand and uphold the integrity and

dignity of a County Commissioner. I want to be that elected official that our community can respect and continue to support. Today, I pledge my support to you as one who will work for this community. The last four years of my life, I have been in public service on the Durham Public Schools Board of Education. I have grown so much respect and love not only for the children of this county but for the entire county because there are lot of dedicated people here who want to make a difference here. Our community results-based accountability initiative that we are undertaking with the City has the potential to provide the strong direction in eight focus areas: economic development and workforce development, safety, housing, education, health, environment, neighborhood infrastructure, and community appearance and cultural heritage.

This Board needs to work together to provide that strong positive leadership so Durham County can move forward.
