### 7. Congratulate Miss Perla Yanez for Earning the Bronze Award from the Girl Scouts

The Board is requested to congratulate Miss Perla Yanez for earning the Girls Scouts' Bronze Award for leading other girl scouts through a project to install audibles at the

intersection of Roxboro Road and Main Street. Recently, Durham's downtown pedestrians may have noticed chips and coo-coo sounds at the intersection. The audible installation may be just another sound to some, but for pedestrians with visual impairments, the sound enhanced pedestrian crosswalk increases the safety of crossing the area of Main Street.

The mastermind behind the improvement to the downtown crosswalk is Perla Yanez, a Junior Girl Scout in Troop # 1192. Perla, an 11 year old student at Research Triangle Charter Academy, noticed the need in her community to provide safer crosswalks for all pedestrians. The future orthodontist recently earned a Bronze Award, the highest award that a Junior Girl Scout can earn, for her project now benefiting thousands of citizens and visitors that use Durham's downtown sidewalks. She is currently working to further her plan to install audibles at all intersections in the Durham Business District.

Perla and 3.2 million Girl Scouts will celebrate the 100<sup>th</sup> Anniversary of Girl Scouts on March 12. The Girl Scout Mission is: Girl Scouting builds girls of courage, confidence, and character, who make the world a better place.

## 9. Public Hearing - General Obligation Bonds Issuance

Durham Public Schools currently has under construction various projects approved under the 2007 referendum. These projects have been funded by way of a \$60 million credit facility with the Bank of America by Durham County. We expect that this facility will reach near capacity during the month of April 2012. We will need to issue up to \$60 million in GO's to pay this facility out and to continue with the remaining approved bond projects. Currently we have \$147 million in approved but unissued bonds remaining under the 2007 referendum.

We also have a refunding opportunity in the amount of \$16.5 million that we would like to take advantage of at the same time. The refunding is expected to produce savings of 8.157 % (\$1,389,591) over the remaining life of the bonds. Under North Carolina status a Public Hearing is required for the Refunding transaction. We are requesting that a Public Hearing be held at this meeting for the Refunded bonds.

County Manager's Recommendation: The County Manager recommends that the Board hold a public hearing for the Refunded bonds. Following the public hearing, the Manager recommends that the Board approve this financing under the 2007 Referendum in an amount not to exceed \$60 million and the refunding in an amount not to exceed \$16.6 million per the Resolution (attached) after holding the public hearing for the Refunded Bonds.
