4. **Presentation of Outstanding County Program Award from the North Carolina Association of County Commissioners**

Neighborhood Nurse Project," a Durham County Public Health Program, has been recognized by the North Carolina Association of County Commissioners with an Outstanding County Program" award. This program was noted for its innovation.

The intent of the Outstanding County Program awards is to recognize and share information with other counties about programs that involve a uniquely innovative process, solution, or idea to address a county or multi-jurisdictional issue and/or to prevent a future problem from developing.

Ms. Gayle Butzgy, NCACC Director of Communications, and Wake County Commissioner Betty Mangum, Board member of the NCACC, will present the awards to Director of Nursing Gayle Harris and members of the team.

County Manager's Recommendation: Congratulate Ms. Harris as her staff members for receiving the recognition for this successful program.

5. **Resolution for William Colville**

County Ranger William Colville retired on February 28, 2001 following 44 years of service with the North Carolina Division of Forest Resources and Durham County Government. A resolution has been prepared recognizing him for an outstanding career in public service.

County Manager's Recommendation: Approve the resolution and present to Mr. Colville, along with sincere congratulations from the Board of County Commissioners for his extraordinary work.

The Commissioners congratulated and thanked Mr. Colville for his service and made comments. Mr. Colville accepted the resolution and made comments.

6. **Consider Adoption of Resolution Supporting House Bill 99**

Representative Mickey Michaux introduced House Bill 99 on February 12, 2001. The bill, entitled "An Act to Authorize Counties and Cities to Levy a Menu of Local Option Taxes if Approved by the Voters," provides a number of different sources of revenue that counties and cities can ask their voters to approve. The proposed legislation has been referred to the House Committee on Rules, Calendar and Operations.

County Manager's Recommendation: The Manager recommends that the Board approve the resolution.

The Commissioners agreed, by consensus to send the resolution and letter to the Governor, the local legislative delegation, and NCACC.

Note: The purpose of a consent agenda is to handle consensus items with one motion to save time on meeting agendas. Any item a Board member pulls for discussion should be placed at the

end of the agenda so public hearings can be concluded as early as possible. This will provide for the least inconvenience to the general public attending the public hearings.

Commissioner Heron pulled 7(e), (h), (j), and (k) for questions. 7(k) should include the Clerk's phone number for more information.

Commissioner Reckhow moved, seconded by Commissioner Bowser, to initiate current advertising consistent with the policy as it is revised in tonight's agenda.

The motion carried unanimously.

After much discussion, it was decided by consensus to have staff reword the policy taking into consideration (1)not advertising if an incumbent is sure to be reappointed and (2)not re-advertising if a vacancy occurs during an unexpired term and there continues to be a pool from which to appoint.

Commissioner Bowser moved, seconded by Commissioner Reckhow, to approve the consent agenda with the exception of item 7(k).

The motion carried unanimously.

8. **Appointment of 2001 Board of Equalization and Review**

North Carolina General Statute 105-322 requires the Board of Commissioners to adopt a resolution to appoint the Board of Equalization and Review. A resolution was adopted on February 26, 2001. Each member of the Board of Commissioners should appoint one member to serve on the Board of Equalization and Review for 2001. Commissioners must also consider a compensation rate. The 2000 Board of E & R compensation rate was \$50.00 per session. A session consists of a 3-hour block of time. Due to the revaluation, the Board will be meeting more often and possibly longer than a three-hour session.

The Board of Commissioners must appoint a Chairman and a Vice-Chairman for the 2001 Board of E & R.

County Manager's Recommendation: Appoint the 2001 Board of Equalization and Review, establish compensation rate, and appoint a Chairman and a Vice-Chairman.

Commissioner Heron moved, seconded by Commissioner Reckhow, to appoint 4 of the 5 members tonight: George Scott, Call Smith, Kelly Matherly, and Ollie Cook and to appoint Call Smith as Chairman and George Scott as Vice-Chairman.

The motion carried unanimously.

Commissioner Reckhow moved, seconded by Commissioner Bowser, to increase the compensation rate from \$50 per session to \$50 per session up to three hours and \$15 per additional hour or portion thereof.

The motion carried unanimously.

8a. Purchase of Equipment Funded by Gates Foundation for the Durham County Library

Commissioner Cousin moved, seconded by Commissioner Reckhow, to approve the item.

The motion carried unanimously.
