# **Opening of Regular Session**

## Resolution for Duke University Men's Basketball Team

WHEREAS, the Clerk to the Board of County Commissioners of the County of Durham has received a petition to close 486± linear feet [.65 acre] of Alston Avenue:

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Durham that:

- 1. The Board of County Commissioners proposes to consider permanently closing 486± linear feet [.65 acre] of Alston Avenue.
- 2. A public hearing is hereby called on the question of permanently closing the street named in Paragraph 1 above. Said public hearing shall be on the 23<sup>rd</sup> day of April, 2001 in the Board of County Commissioners' Chambers, Durham, North Carolina.
- 3. The City-County Planning Department shall notify all owners of property adjoining the street named in Paragraph 1 above as their interests may appear on the County Tax Records.
- 4. Notice of the closing and public hearing shall be prominently posted in at least two places along the street named in Paragraph 1 above.
- 5. Any person may be heard at the public hearing on the question of whether or not the proposed closing would be detrimental to the public interest or to the property rights of any individual.

- 6. If it appears to the satisfaction of the Board of County Commissioners after said public hearing that the closing of all of said street is not contrary to the public interest, and that no property owner would thereby be deprived of reasonable means of ingress and egress to his property, the Board of County Commissioners may adopt an Order permanently closing the street named in Paragraph 1 above.
- 7. BE IT FURTHER RESOLVED that <u>notice</u> of such hearing shall be published in the Durham Herald once a week for two successive weeks, the first publication to be not less than ten days nor more than 25 days before the date fixed for the hearing.

# RESOLUTION FOR ESTABLISHMENT OF POLICY AND PROCEDURES FOR APPOINTMENTS TO COUNTY BOARDS, COMMISSIONS, **COMMITTEES OR AUTHORITIES**

WHEREAS, it is the statutory duty of the Durham County Board of Commissioners, as Governing Body of Durham County, to appoint persons to various boards, commissions, committees, or authorities, to assist in the operation of county government; and

WHEREAS, the Board of Commissioners is desirous of appointing qualified, knowledgeable, and dedicated people to serve on the aforesaid boards, commissions, committees, or authorities, and to that end solicits the interest and participation of the citizens of Durham County in providing information and recommendations to assist the Board of Commissioners in identifying qualified candidates for said appointments; and

WHEREAS, the Board of Commissioners recognizes the need for a policy and procedure to provide for increased public awareness of the appointments to be made from time to time by the Board, to solicit public participation in the submission of names of qualified candidates, to set forth the subsequent steps for the selections of the candidate(s) by the Board, and to insure attendance at meetings; and

WHEREAS, the Board of Commissioners recognizes the need to have a representative sample of the citizens of Durham County serving on the boards, commissions, committees, and authorities; therefore, appointment applications will solicit necessary information to achieve a representative sample of the community:

NOW, THEREFORE, BE IT RESOLVED by the Durham County Board of Commissioners that:

<u>Section 1</u>. The policy of Durham County governing appointments to the various boards, commissions, committees, or authorities made by the Board of County Commissioners is as follows:

- A) Words of the masculine gender mean and include correlative words of the feminine and neuter genders and words imparting the singular number mean and include the plural number and vice versa.
- B) Any citizen of Durham County who is eighteen (18) years of age or older is eligible to serve on the appointed boards, commissions, committees, or authorities of the County where such appointment is not prohibited by state statute.
- C) All appointments will be made according to the Appointments Statute or Ordinance that created that board, commission, committee, or authority.
- D) No citizen of Durham County may serve in more than two appointed positions of Durham County Government unless exempted by nature of the position or otherwise.
- E) Unless otherwise stated by statute, no citizen may serve more than three consecutive terms in any one position. This policy may be waived if the Board of Commissioners determines that the removal of a number of individuals made ineligible by the policy would be detrimental to the functioning of that board, commission, committee, or authority, unless such removal is prescribed by statute.
- F) If an appointee has absences (excused or unexcused) which constitute more than 50% of the meetings in any calendar year which he or she is required to attend pursuant to his or her appointment, he or she is obligated to resign.
- G) The Clerk to the Board will notify the member that he or she is obligated to resign. An unexcused absence is defined as an absence without prior notification to the chairman, secretary, or staff to the boards, commissions, committees, or authorities.
- H) Excused absences are defined as absences with proper prior notification indicating legitimate conflicts or other circumstances.

- I) For each appointee, the calendar year is counted beginning on the date of appointment.
- J) If a member's absence exceeds these percentages, the Clerk to the Board of County Commissioners should be notified immediately.
- K) The clerk to the boards, commissions, committees, or authorities shall be responsible for keeping an attendance record and notifying the Clerk to the Board, who shall in turn notify the Board of County Commissioners when the limit of absences of any appointee has been reached.
- L) Property tax listing must be current. County and City taxes must not reflect any delinquencies before an application is submitted.
- M) If a member has more than 50% absences (excused or unexcused) or, if the member is delinquent in the listing and/or payment of taxes for which an appeal has not been filed, the Clerk to the Board will notify the Chairman of the Board of County Commissioners. Upon receipt of notification from the Clerk to the Board, the Chairman will notify the member that he or she may be removed from the board, commission, committee or authority. The Commissioners shall consider the board member's status at a regularly scheduled meeting of the Board of County Commissioners.

Each County Commissioner will have available to him or her a binder containing a list of all County appointments, with the following data provided:

- 1. The name of the board, commission, committee, or authority and the composition of the board according to the statute.
- 2. A brief description of its functions.
- 3. The statute or cause creating the board, commission, committee, or authority and the composition of the board according to the statute.
- 4. The total number of members and length of terms of office.
- 5. The names of current members, the number of terms each has served, and the date of his or her original appointment.
- 6. The regular meeting day, time and location, if determined.
- 7. The date(s) on which appointments should be made.

<u>Section 2</u>. The procedures of Durham County for filling vacancies for appointed positions should be as follows:

### A) Notification of available appointments

- 1. A current list of upcoming appointments to County boards, commissions, or authorities shall be kept in the Office of the Clerk to the Board and shall be furnished to any person or group on request.
- 2. A list of available positions and the date by which names should be submitted will be published in the Herald Sun, the Carolina Times, or any other newspaper having general circulation throughout the County

that the Board may specify from time to time, once a week for two weeks beginning two weeks in advance of the deadline for submitting applications. The name, phone number, website, and address of the Clerk to the Board shall be provided in the advertisement to obtain more information.

- 3. A list of available positions stating terms of office, requirements for office, duties of positions, and the date by which names should be submitted will be placed on the Durham County Website beginning two weeks in advance of the deadline for submitting applications.
- 4. Twenty-five (25) days prior to the expiration of the terms, a notice will be mailed to each person who is eligible for reappointment requesting an indication of his or her interest in continuing to serve. If an individual is not eligible for reappointment, he or she will be notified and given the reason for being ineligible.
- 5. The Chairman of the Board of Commissioners or his designee will be responsible for carrying out the above notification procedures.
- 6. If, because of policy or otherwise, an individual is unable to be reappointed, that person will be sent a Letter of Appreciation by the Chairman of the Board of Commissioners at the expiration of his or her term, thanking the person for past services rendered.

### B). Selection Process

- 1. At least twelve (12) days prior to the appointments by the Board of County Commissioners, all applications for a particular position must be in the hands of the Clerk to the Board. The Clerk will check each applicant for eligibility and recheck any prior applicants, if any.
- 2. A copy of the applications submitted together with the prior applications, if any, shall be sent to all Commissioners at least ten (10) days prior to the meeting at which action will be taken. Those candidates who are ineligible will be noted and the reasons for ineligibility given.
- a. When the advertising or readvertising of positions for boards, commissions, committees, etc., does not produce within the time frame prescribed the necessary number of qualified persons to fill the vacancies indicated, the Board of County Commissioners on its own initiative will name the appointees.
  - b. When vacancies and positions appointed pursuant to this policy occur prior to the expiration of the term of office, the Board of County Commissioners shall appoint a person to serve the remainder of the term in accordance with the procedures outlined herein.

# C) Notification of Appointment The Chairman of the Board of County Commissioners shall prepare a letter of notification of appointment or non-appointment to the applicants and a copy to the affected board, notifying each of the appointment or nonappointment.

# D) Applications

All applications received shall be retained for at least one (1) year and considered if a vacancy occurs during that time period. Applications shall be kept on file for all active appointees. These will be treated as public records and made available upon request for the cost of copying.

As unanimously adopted the 16th day of January, 1984 and amended February 9, 1984, August 27, 1984, June 25, 1990, May 8, 1995, March 26, 2001, and April 9, 2001.

# A Public Hearing to Consider an Amendment to the Zoning Ordinance Regarding Intermittent Stream Buffer Width

The Durham Zoning Ordinance requires that an undisturbed, naturally-vegetated stream buffer be preserved along all intermittent and perennial streams. The purpose of the stream buffer is to enhance and maintain water quality, protect stream channel wetlands, minimize stormwater runoff, reduce sedimentation and erosion, conserve plant and wildlife habitat, and protect wildlife movement corridors.

Buffers of greater width are required in watershed protection areas. Required buffers are 30, 50, 100, or 150 feet wide on each side of the stream, depending on the type of stream and its location. Generally, wider buffers are required on perennial streams, in critical areas, and in more sensitive watersheds.

Water supply watershed protection requirements cover approximately three-quarters of Durham County and have minimum stream buffer widths of 50 feet. Likewise, Neuse River Basin Management Strategy requirements cover another eighth of the county and also have minimum stream buffer widths of 50 feet. Buffers as small as 30 feet apply only to the portions of Durham County outside of these areas. To offer more consistency and less confusion and to enhance water quality protection, the Joint City-County Planning Committee has recommended that the minimum stream buffer width be increased from 30 to 50 feet throughout the County.

On March 13, the Zoning Committee of the Planning Commission conducted a public hearing and considered this text amendment. The committee voted unanimously to recommend approval. The Planning Staff concurs and recommends that Durham adopt the amendment to the Durham Zoning Ordinance to change the size of intermittent stream buffers.

<u>Resource Person(s)</u>: Keith Luck, Planning Supervisor

<u>County Manager's Recommendation</u>: Conduct the public hearing and adopt the amendment to the Durham Zoning Ordinance to change the size of intermittent stream buffers outside of watershed protection areas.

Chairman Black opened the public hearing that was properly advertised.

As no one signed to speak at the public hearing, Chairman Black closed the public hearing and referred the item back to the Commissioners for consideration.

Vice-Chairman Reckhow moved, seconded by Commissioner Heron, to adopt the amendment to the Durham Zoning Ordinance to change the size of intermittent stream buffers outside of watershed protection areas.

The motion carried unanimously.

#### TC 114-01

An Ordinance to Amend the Durham Zoning Ordinance Section 11.3.3, Stream Buffer Size

Whereas, the Board of Commissioners of Durham County determines that it furthers the public health, safety, and welfare to make the change to the Zoning Ordinance described below for the reasons described in the reports and testimony considered by the Board of Commissioners:

NOW, THEREFORE, BE IT ORDAINED by the Durham County Board of Commissioners that:

Section 1. The Durham Zoning Ordinance, Chapter 24, Section 11.3.3, Stream Buffer Size is hereby amended to eliminate the words and numbers shown in strikeout format and to replace them with the words and numbers <u>underlined</u>, all as shown below.

### "11.3.3 Stream Buffer Size

Stream buffers shall apply on each side of the stream and shall be measured from the top of the stream bank perpendicularly to the direction of stream flow.

# **Update on 2001 Durham County Legislative Agenda**

Members of the Durham Delegation introduced several local bills that were included in the Durham County Legislative Agenda. Staff presented a status report on the proposed legislation. Other legislative issues highlighted by Board members were discussed as well.

Resource Person(s): Deborah Craig-Ray and Chuck Kitchen

<u>County Manager's Recommendation</u>: Receive the report and direct staff relative to further support for legislative issues.

Ms. Craig-Ray and Mr. Kitchen presented the County Commissioners and update on the 2001 Durham County Legislative Agenda.

Chairman Black directed Ms. Craig-Ray to schedule a meeting with the Durham County Legislative Delegation and the Board of County Commissioners for Friday, April 20, 2001 at 8:30 a.m. to discuss proposed legislative issues.

The Commissioners asked questions and made comments about the 2001 Legislative Agenda to which staff responded .

### **Establishing Fees for Plan Amendments and Landscape Extension Requests**

The Board was requested to approve new fees for amendments to Small Area Plans, 2020 Plan, and Corridor Plans and for extensions on landscape installation.

In keeping with the BOCC's previously-adopted policy of requiring consistency between a requested rezoning and adopted plans, the Planning staff proposed a fee of \$1,100 to

cover staff time in processing amendments to Small Area Plans, the 2020 Plan, and/or officially adopted Corridor Plans.

Planning staff also proposed a fee to process requests for extensions on the installation of street trees and other required landscaping due to hot weather and other weather-related conditions beyond the developer's control. This proposed fee is in increments of \$75, \$150, and \$300.

# Interlocal Agreement to Establish a Bicycle and Pedestrian Advisory Commission

Bicycle and pedestrian issues are gaining increasing importance in transportation and land use planning, but Durham has no channel for citizen advocacy and input into these discussions. This interlocal agreement will create a 15-member Bicycle and Pedestrian Advisory Commission (BPAC), with six members appointed by the Board of County Commissioners and six by the City Council to represent various constituencies. There will be three additional members as liaisons from the Durham Open Space and Trails Commission (DOST), the Recreation Advisory Commission (RAC), and the Planning Commission. The members appointed by the elected officials will serve three-year terms; the liaisons from the other commissions will serve one-year terms.

The proposed BPAC would have the responsibility to advise the City and County on bicycle and pedestrian issues. The BPAC would also be charged with increasing public education on these same issues and promoting intergovernmental and public/private partnerships on bicycle and pedestrian matters. Staff requested that the Board authorize the County Manager to sign the interlocal agreement to create a Bicycle and Pedestrian Advisory Commission.

<u>County Manager's Recommendation</u>: The Manager's recommendation was that the Board approve the interlocal agreement and create a Bicycle and Pedestrian Advisory Commission.

Beth Timson, Senior Planner, presented the agenda item to the Board of County Commissioners.

Vice-Chairman Reckhow moved, seconded by Commissioner Heron, to approve the interlocal agreement and the creation of a Bicycle and Pedestrian Advisory Commission.

The motion carried unanimously.
