Opening of Regular Session

Chairman Black called the Regular Session to order with the Pledge of Allegiance.

Announcements

Commissioner Bowser announced that his computer was plagued with a virus and that he could not use it to respond to his email. He said he hoped the trouble would be resolved in the near future.

Commissioner Reckhow announced that on Saturday, October 6, 2001, Durham Healthy Community Day would be held to include the Great Family Fun Walk. The event will be sponsored by the County Council on Physical Fitness and Sports, Durham City Parks and Recreation Department, and the Museum of Life and Science. It will begin at 10:00 a.m. at the Edison Johnson Recreation Center. Several activities are planned at the museum and the recreation center. The first 300 registrants will receive a free T-shirt and a pass to the museum for the day.

Minutes

Commissioner Heron moved, seconded by Vice-Chairman Reckhow, to approve the September 10, 2001 Joint BOCC/City Council/Durham Delegation meeting minutes, as submitted.

The motion carried unanimously.

Resolution Condemning Terrorist Actions on September 11, 2001

Javier Gonzales, President and Larry Naake, Executive Director of the National Association of Counties, have asked all counties in America to pass a resolution

condemning the terrorist acts on September 11, 2001. The resolution conveys support for the President of the United Sates as he works with the national security team to defend against additional attacks, and to find the perpetrators to bring them to justice. Citizens are also asked to give blood and other contributions needed to help victims as well. A proposed resolution has been prepared for the Board to adopt.

<u>County Manager's Recommendation</u>: Approve the resolution and forward a copy to the National Association of Counties.

Chairman Black read the resolution into the official record as follows:

RESOLUTION

WHEREAS, on September 11, 2001 our nation was brutally attacked by foreign terrorists; and

WHEREAS, these terrorists hijacked and destroyed four civilian aircraft, crashing two of them into the towers of the World Trade Center in New York City, and a third into the Pentagon outside Washington, DC; and

WHEREAS, thousands of innocent Americans were killed and injured as a result of these attacks, including the passengers and crew of the four aircraft, workers in the World Trade Center and in the Pentagon, along with rescue workers and bystanders; and

WHEREAS, these cowardly acts were by far the deadliest terrorist attacks ever launched against the United Sates, and by targeting symbols of American strength and success, clearly were intended to intimidate our nation and weaken its resolve; and

WHEREAS, these horrific events have affected all Americans, and it is important that we carry on with the regular activities of our lives. Terrorism cannot be allowed to break the spirit of the American people, and the best way to show these cowards that they have truly failed is for the people of the United States and the counties to stand tall and proud:

NOW, THEREFORE, BE IT RESOLVED that we, the members of the Durham County Board of Commissioners, do hereby condemn the cowardly and deadly actions of these terrorists; and

BE IT FURTHER RESOLVED that we, the members of the Durham County Board of Commissioners, support the President of the United States as he works with his national security team to defend against additional attacks and to find the perpetrators to bring them to justice; and

BE IT STILL FURTHER RESOLVED that we, the members of the Durham County Board of Commissioners, encourage Durham County citizens to support Red Cross relief efforts by calling 1-800 GIVE LIFE for blood donations, or by calling 1-800 HELP NOW to give financial contributions; or to access www.unitedwaytriangle.org or to mail

contributions to Triangle United Way September 11th Fund, PO Box 14428, RTP, NC 27709. One-hundred-percent of contributions will go to Washington and New York.

Mr. Smith concludes that Mr. Anderson is dedicated to serving the citizens of Durham County.

Mickey Tezai, Director of Emergency Medical Services, introduced Charles B. Anderson and addressed his skills and dedication to Durham County. PROCLAMATION

WHEREAS, the prevention of substance abuse among young people is, and continues to be a priority for the County of Durham; and the most effective means to prevent and combat substance abuse and addiction lies within the fold of the family; and

WHEREAS, parents who remain involved with their children's activities greatly reduce the risk of their smoking, drinking, or using drugs; and eating dinner as a family manifests familial unity and intercommunication; and

WHEREAS, communication between family members is conducive to the development and growth of children; and

WHEREAS, children from families that almost *never eat together* compared to those that do are more than 70% *more likely* to use illegal drugs, cigarettes, and alcohol; and

WHEREAS, children from families that almost *always eat together* are more than 30% *less likely* to use illegal drugs, cigarettes, and alcohol:

NOW, THEREFORE, I, MaryAnn E. Black, Chairman of the Durham County Board of Commissioners, do hereby proclaim September 24, 2001 as

Vice-Chairman Reckhow read the proclamation into the official record as follows:

WHEREAS, voting is one of the most cherished rights of citizens in a free society, and the fundamental process by which democratic institutions are shaped and preserved; and

WHEREAS, allowing children to participate with their parents in the voting process has been proven to stimulate their interest in political issues and to encourage more parents to vote themselves; and

WHEREAS, Kid Voting USA is a national program created to enable children to accompany their parents to polling places and to cast simulated ballots on candidates and issues; and

WHEREAS, this program increases participation in the democratic process by educating students about their rights, responsibilities, and privileges of voting; and

WHEREAS, Kid Voting USA motivates young people to acquire basic skills necessary for responsible citizenship; and

WHEREAS, Kid Voting has successfully operated in Durham County thanks to the assistance of many dedicated volunteers:

Ms. Lisa Kane made a presentation on this program and introduced Ms. Donna Mitchell, Executive Director. Also present to promote "Kid Voting" were Mr. Tom White and Mr. Philip Vereen for the Greater Durham Chamber of Commerce.

Mobile Dental Van Partnership

Duke's "Promising Practices" program has received funding from the Duke Endowment for a mobile dental treatment unit, which provides dental care for low-income children in Durham Public Schools. This mobile unit is a partnership program involving Duke University Health System, Durham County Health Department, and Durham Public

Schools. Duke's Division of Community Health along with the Durham County Health Department are responsible for the operation of the van service. The Dental Division at the Health Department furnishes supplies and a dentist and two dental assistants to render dental treatment. The Duke Endowment funded a grant of \$198,000 to purchase and equip the van; the Durham County Commissioners provided \$15,000 that purchased a wheelchair lift to accommodate children with physical disabilities and two dental chairs for patients. (Prior to the meeting, Board members were invited to tour the van in front of the courthouse building.)

Resource Persons: Brian Letourneau, Durham County Public Health Director, and Dr. Jean Spaulding, Duke University Health System

<u>County Manager's Recommendation</u>: Receive the presentation about the Mobile Dental Health Van. Acknowledge the \$198,000 from the Duke Endowment and \$15,000 from the Board of County Commissioners, and recognize the providers who will help make the program a success for the community.

Brian Letourneau introduced the item. Dr. Spaulding presented a plaque to Durham County in appreciation of the County's provision of \$15,000 to purchase the Wheelchair lift and two dental chairs for the "Tooth Ferry." Mr. Letourneau gave contact information for accessing the dental van.

The Commissioners made comments praising the program and the van. Commissioner Heron commented that senior citizens in the community also need access to good dental care. Poor nutrition among seniors is a direct result of poor dental care. Dr. Spaulding agreed.

<u>Consent Agenda 11(b)</u>. Amendments to Ordinance Designating Restricted Parking Lots (adopt the proposed additions and amendments to the parking ordinance in an effort to ease congestion in the parking areas).

The amended ordinance follows:

ORDINANCE TO AMEND DURHAM COUNTY PARKING ORDINANCE

WHEREAS, Durham County adopted a Parking Ordinance on August 6, 1979.

WHEREAS, since the initial adoption of the Parking Ordinance, subsequent amendments have been made in order to add additional parking areas.

WHEREAS, the purpose of the proposed amendments is to: add the Judicial Building Annex (Old First Union Building) and other parking area; number each lot 1-30 for new County parking signs; improve the current ordinance with clarity and consistency; enhance enforcement authority.

NOW, THEREFORE, THE BOARD OF COMMISSIONERS FOR THE COUNTY OF DURHAM DOTH ORDAIN:

DIVISION 2. RESTRICTED PARKING LOTS

- 1. Sec. 24-62 of the Durham County Code of Ordinances is hereby amended to read as follows:
- Sec. 24-62. Areas adjacent to and beneath the County Judicial Building, Parking Lot # 1
 - (a) The parking area adjacent to and on the East side of the Judicial Building.
 - (1) The street address is 201 E. Main St.
 - (2) Parking area adjacent to and on East side of the County Judicial building.
 - (3) The parking area immediately adjacent to and on the East side of the County Judicial building is hereby designated as a restricted parking lot.
 - (4) Parking in the parking lot immediately adjacent to and on the East side of the County Judicial building is hereby designated by the County Manger or his designee, for the use of the County Sheriff's Office, and the parking of

any other vehicle except for those vehicles belonging to the County Sheriff's Office is hereby prohibited.

- (b) Area beneath the Judicial Building.
 - (1) The parking area located beneath the County Judicial Building is hereby designated as a restricted parking lot.
 - (2) All parking spaces in the area located beneath the County Judicial Building shall be used only by those individuals who have been designated by the County Manager or his designee. Further, those individuals designated as being allowed to park in such areas shall only park in such spaces as has been assigned to them by the County Manager or his designee. Parking in the area by any other person is hereby prohibited.
 - (3) Parking in other than designated parking spaces in the parking area located beneath the County Judicial Building is hereby prohibited.
 - (4) The designation of the restricted parking area beneath the county judicial building shall not apply to or in any way affect any area designated as part of the county jail.
- 2. Sec. 24-63 of the Durham County Code of Ordinances is hereby amended to read as follows:
- Sec. 24-63. Areas adjacent to the County Courthouse Administrative Complex (old County Courthouse)-Lot # 2 and Areas adjacent to the Social Services Building Lot # 3.
 - (a) Areas adjacent to the Administrative Complex, Lot # 2.
 - (1) The street address is 200 E. Main St.
 - (2) The parking area immediately to the in the rear of the county courthouse West and adjacent to the Durham County Administrative Complex, formerly known as the Old County Courthouse, and the driveway immediately in the rear and adjacent to the County Social Services building are is hereby designated as a restricted parking lot for use by the patrons of the Administrative Complex. The parking area beneath the Administrative Complex is also hereby designated as a restricted parking lot, which is assigned parking by the County Manger or his designee.
 - (3) Parking immediately to the West, adjacent to or beneath the Administrative Complex for any other purpose is hereby prohibited.
 - (4) The area to the SouthWest of the old county courthouse and adjacent to the courthouse–Administrative Complex, which was formerly a portion of

Church Street and has been deeded to the county by the City of Durham is hereby designated as a restricted parking lot.

- (5) All parking is hereby prohibited in the areas to the rear of the County Courthouse, in the driveway to the rear of the Social Services building and the area which was formerly a portion of Church Street, except for County-owned vehicles which may park in the area to the rear of the Courthouse while such vehicles are in the process of refueling. Parking in other than designated spaces in parking Lot # 2, adjacent to or beneath the Administrative Complex is hereby prohibited.
- (b) Areas adjacent to the Social Services building, Lot # 3.
 - (1) The street address is 220 East Main Street.
 - (2) The parking area South and immediately adjacent to the Social Services building is hereby designated as restricted parking.
 - (3) The parking area South and adjacent to the Social Services building is hereby designated for the use of County employees which have been assigned parking by the County Manager or his designee.
 - (4) Parking in other than designated parking spaces in the parking adjacent to the Social Services building is hereby prohibited.
- 3. Sec. 24-64 of the Durham County Code of Ordinances is hereby amended to read as follows:

Sec. 24-64. Areas adjacent to County Libraries, Main Street Library - Lot # 4, Bragtown Branch Library - Lot # 5, SouthWest Branch Library - Lot # 6, and Stanford L. Warren Branch Library - Lot # 7.

- (a) Areas adjacent to the Main Library Lot # 4.
 - (1) The street address is 300 N. Roxboro St.
 - (2) The parking area immediately to the East, North and adjacent to the Main County Library is hereby designated as a restricted parking lot.
 - (3) The parking lot adjacent to the Main County Library is hereby designated for use by the patrons of the library, and for the use of the employees of the County, which have been assigned parking in the lot by the County Manager or his designee. Parking in the lot adjacent to the Main County Library for any other purpose is hereby prohibited.

- (4) Parking in other than designated parking spaces in the parking lot adjacent to the Main County Library is hereby prohibited.
- (b) Areas adjacent to the Bragtown Branch Library Lot # 5.
 - (1) The street address is 3200 Dearborn Drive.
 - (2) The parking area immediately North and adjacent to the Bragtown Branch Library is hereby designated as a restricted parking lot.
 - (3) The parking lot adjacent to the Bragtown Branch Library is hereby designated for use by the patrons of the library, and for the use of the employees of the County, which have been assigned parking in the lot by the County Manager or his designee. Parking in the lot adjacent to the Bragtown Branch Library for any other purpose is hereby prohibited.
 - (4) Parking in other than designated parking spaces in the parking lot adjacent to the Bragtown Branch Library is hereby prohibited.
- (c) Areas adjacent to the SouthWest Branch Library Lot # 6.
 - (1) The street address is 3605 Shannon Drive.
 - (2) The parking area immediately in front, North and adjacent to the SouthWest Branch Library is hereby designated as a restricted parking lot.
 - (3) The parking lot adjacent to the SouthWest Branch Library is hereby designated for use by the patrons of the library, and for the use of the employees of the County, which have been assigned parking in the lot by the County Manager or his designee. Parking in the lot adjacent to the SouthWest Branch Library for any other purpose is hereby prohibited.
 - (4) Parking in other than designated parking spaces in the parking lot adjacent to the SouthWest Branch Library is hereby prohibited.
- (d) Areas adjacent to the Stanford L. Warren Branch Library Lot #7.
 - (1) The street address is 1201 Fayetteville Street.
 - (2) The parking area immediately East and adjacent to the Stanford L. Warren Branch Library is hereby designated as a restricted parking lot.
 - (3) The parking lot adjacent to the Stanford L. Warren Branch Library is hereby designated for use by the patrons of the library, and for the use of the employees of the County, which have been assigned parking in the lot by the County Manager or his designee. Parking in the lot adjacent to the

- Stanford L. Warren Branch Library for any other purpose is hereby prohibited.
- (4) Parking in other than designated parking spaces in the parking lot adjacent to the Stanford L. Warren Branch Library is hereby prohibited.
- 4. Sec. 24-65 of the Durham County Code of Ordinances is hereby amended to read as follows:
- Sec. 24-65. Area adjacent to the Health Center Building Lot # 8
 - (a) The street address is 414 East Main Street.
 - (b) The parking area immediately adjacent to and surrounding the West, South, and East sides of the Health Center building is hereby designated as a restricted parking lot.
 - (c) The parking area immediately adjacent to and surrounding the West, South, and East sides of the Health Center building is hereby designated for the use of clients of the Mental Health and Public Health Departments and visitors to other County offices located in that building, and for use of the employees of the County who have been assigned parking in the lot by the County Manager or his designee. Parking in the lot adjacent to the Health Center Building for any other purpose is hereby prohibited.
 - (d) Parking in other than designated parking spaces in the parking lot immediately adjacent to and surrounding the West, South and East sides of the health center building is hereby prohibited.
- 5. The Durham County Code of Ordinances is hereby amended by adding a section, to be numbered 24-66, which section reads as follows:
- Sec. 24-66. Area adjacent to the Cooperative Extension Building Lot #9.
 - (a) The street address is 721 Foster Street.
 - (b) The parking area North, South, West and immediately adjacent to the Cooperative Extension Building is hereby designated as a restricted parking lot.
 - (c) The parking lot adjacent to the Cooperative Extension Building is hereby designated for use by the patrons of the library, and for the use of the employees of the County, State and Federal Government which have been assigned parking in the lot by the County Manager or his designee.

- (d) Parking in other than designated parking spaces in the parking lot adjacent to the Cooperative Extension Building is hereby prohibited.
- 6. Sec. 24-67 of the Durham County Code of Ordinances is hereby amended to read as follows:

Sec. 24-67. Areas formerly owned by Johnson Motor Company Areas adjacent to the Jail Annex – Lot # 10, Roxboro Street Parking Deck - Lot # 11, Main Street Parking - Lot # 12, Liberty Street Reserved - Lot # 13, and Liberty Street County Employees - Lot # 14.

- (a) Areas adjacent to the Jail Annex, Lot # 10:
 - (1) The street address is 326 East Main Street.
 - (2) The parking areas formerly owned by Johnson Motor Company and being located on East Main Street, Liberty Street and off Roxboro Street area is hereby designated as restricted parking lots.
 - (3) Parking in the areas formerly owned by Johnson Motor Company is hereby designated for use as assigned by the County Manager. Parking in these areas by persons not assigned by the County Manager is hereby prohibited. <u>Public Hearing—2000-2001 Consolidated Annual Performance and Evaluation Report (CAPER)</u>

The City of Durham Department of Housing and Community Development requested that the Board of County Commissioners hold the 2000-2001 Consolidated Annual Performance and Evaluation Report (CAPER) draft public hearing on September 24, 2001 to receive citizen comments. The CAPER provides Durham an opportunity to assess anticipated performance with actual performance in meeting the priorities and objectives of the Consolidated Action Plan. The CAPER public hearing is held annually in September by the Board of County Commissioners to receive comments on the previous year's City-County HOME Consortium Investment Partnership program performance. This performance is detailed in the CAPER that must be submitted to the U.S. Department of Housing and Urban Development (HUD) no later than September 28, 2001. The 2000-2001 CAPER was made available (in draft form) to the public for review from August 27, 2001 through September 14, 2001. Comments received at the public hearing will be placed into the CAPER before it is submitted to HUD. The City Council was scheduled to hold its CAPER public hearing on September 17, 2001.

Durham receives an annual HOME Consortium grant award from HUD. The 2000-2001 HOME entitlement allocation was \$952,000 in HOME funds. The 2000-2001 Consolidated Action Plan allocated these HOME funds primarily for housing activities in Durham with special focus in target neighborhoods. Major HOME program expenditures made (as shown in the draft CAPER) during the 2000-2001 program year included existing homeowner rehabilitation and new homebuyer rehabilitation activities.

Charlene Montford, Director of the City of Durham Department of Housing and Community Development, had reviewed this request and recommended that the Board of County Commissioners hold the 2000-2001 Consolidated Action Plan Draft public hearing. Michael Pullum, Senior Planner was to attend the meeting to answer questions.

<u>County Manager's Recommendation</u>: Hold the 2000-2001 Consolidated Annual Performance and Evaluation Report (CAPER) draft public hearing on September 24, 2001 to receive citizen comments.

Michael Pullum, Senior Planner, Department of Housing and Community Development, City of Durham, presented the County Commissioners an overview of the public hearing agenda item.

Chairman Black gave the Commissioners the opportunity to ask Mr. Pullman questions.

The Commissioners asked several questions and made comments about the CAPER to which Mr. Pullman responded. During the question and answer period, the County Commissioners expressed the following concerns on the findings:

- No expenditures of housing rehabilitation funds were made for units outside the city limits.
- Money is being taken away from the program to pay for the City to resolve complaints over the rehabilitation of a housing unit. If something is not done correctly, someone involved in the actual rehabilitation ought to correct the problem.
- The status of Durham's program is reflected in the ten unsatisfactory findings and the four areas of concern reported by HUD, as well as the lack of a detailed system ensuring compliance.
- Durham County must be represented on the Advisory Committee. If the interlocal agreement specifies that the three slots for county residents must be filled by individuals who live outside the city limits, then it must be amended with no residential specification for members other than to live within the county.
- How long is the County to be involved in this grant? How much oversight of the grant money does the County have?
- Given the need in this community, why would we be carrying a \$3-million unexpended balance instead of using it to improve housing in this community?
- The actual number results are not comforting (re: total rehab units 16, total new construction 126 units). The money should go into the hands of nonprofits and other providers to shape up this housing.

- The Lead-Based Paint Hazard Reduction Program reflects completion in only nine units. The HUD application states that the County is to "provide abatement of lead in 600 houses."
- If lead-based paint abatement program funds have not all been expended, could the moneys be used to purchase a public facility in order to move kids out of a facility that is full of lead-based paint?
- Ineffective monitoring of programs. It was requested that an executive summary be provided with a chart displaying "what we said we were going to do," and "what the actual performance was."

Chairman Black asked the County Manager to review the Home Consortium grant award from HUD to determine whether funding would be available to provide money for locating a facility for the Operation Breakthrough/Headstart program.

Chairman Black opened the public hearing that was properly advertised.

Commissioner Heron read into the record the memorandum she received from NAMI-Durham (National Alliance for the Mentally III).

RE: Consolidated Plan, City of Durham Housing Department

NAMI-Durham is very pleased with the Consolidated Plan being presented tonight. In particular, we appreciate the addition of coverage for supportive services for the disabled and emphasis upon rental housing development for the disabled. Thank you.

One issue that the report raises is the relationship with the Durham Housing Authority, which administers the Section 8 rental subsidy program. In "Actions Take to Overcome Impediments" the plan suggests "A strategy for better integrating the Durham Housing Authority public housing developments." (p.21) This is a crucial missing piece at this time. NAMI-Durham will be unable to meet the cash flow necessary to keep our renters in their apartments without Section 8 supplements. The \$160 rent we will charge will not meet the minimum \$245 or maximum \$540 cost of monthly expenses per apartment (the difference between minimum and maximum depends upon how much money we can raise by our fundraising drive.)

We have met with the Housing Authority requesting "project-based Section 8 vouchers for 10 of our 12 apartments several times. Numerous other Housing Authorities across the state have recently granted these Section 8s, which are attached to the rental units, not to the renters. Because there is such a long waiting list for Section 8s in Durham, the Housing Authority has not been willing to make the deal "you get Section 8s because you add to the supply of low-cost housing." Since that is one

of the main goals of the Department of Housing, we ask that you make our apartments economically feasible.

As there were no other speakers, Chairman Black closed the public hearing.

Chairman Black directed the staff to give a copy of the NAMI-Durham Memorandum to Michael Pullum.

Chairman Black directed the County Manager and County Attorney to amend the interlocal agreement in order to have a County staff member serve on the Citizens Advisory Committee. She requested staff to bring to the Commissioners recommendations as to how the interlocal agreement could be amended in order to achieve this.

Michael Pullum said the comments received at the City's public hearing and the County's public hearing would be included in the document that HUD would receive.

Chairman Black said the Commissioners wanted follow-up action on the Board's comment so that the Board would know where we stand and what progress is being made.

Public Hearing—Budget Ordinance Amendment No. 02BCC000017—Office of the Sheriff—2001 Local Law Enforcement Block Grant Funds

The Office of the Sheriff submitted its on-line application for Durham County's share of the 2001 Local Law Enforcement Block Grant (LLEBG) and received subsequent approval of a \$178,676.00 block grant award from the U.S. Department of Justice—Bureau of Justice Assistance. The purpose of the LLEBG Program is to reduce crime and improve public safety. The award can only be used in accordance with the seven (7) purpose areas described for this grant program.

These intergovernmental funds awarded to Durham County will be used for the purchase of equipment for the Sheriff's communications and general field deputies.

The Sheriff established an Advisory Board as specified by the grant, which met on August 20, 2001 to recommend the proposed use for these funds. The equipment to be purchased as suggested by the Advisory Board follows: Mobile command post for the Sheriff's Office (command post in use now is over 18 years old and is a converted bookmobile); communication repeaters; and emergency response radios for interoperability with schools and computer equipment for deputies. Such equipment and technology will enhance and improve the law enforcement abilities of the Sheriff's Office and the County of Durham.

One of the special conditions of this grant award program is to conduct a public hearing to receive public comment as to the use of these funds. This public hearing has been

advertised in the Durham Herald-Sun paper on September 16, 2001 and September 23, 2001 to give proper notification.

No additional County funding is required, and no subsequent year budget impact is anticipated. The Office of the Sheriff will provide the required grantee local cash match of \$19,853.00 from its current budget. The total appropriation is for \$198,529.00; the revenue recognized is \$178,676.00 from the grant award.

County Manager's Recommendation: We congratulate the Sheriff on applying for and receiving another Local Law Enforcement Block Grant to continue these traditional improvements. The Sheriff's Office has traditionally used the LLEBG funds received the last five (5) years for improving and upgrading the agency's equipment and technological infrastructure. It is recommended to conduct the public hearing to receive public comment, and then approve the Advisory Board's recommendation for the proposed use of the 2001 LLEBG award funds. Approve Budget Amendment 02BCC000017 to accept grant funding and appropriate program spending.

Nancy Dellinger, Office of the Sheriff, presented the Commissioners an overview on the 2001 Local Law Enforcement Block Grant Funds.

Chairman Black opened the public hearing, which was properly advertised.

As no one requested to speak at the public hearing, Chairman Black adjourned the public hearing and referred the item to the Commissioners for consideration.

Vice-Chairman Reckhow moved, seconded by Commissioner Heron, to approve Budget Ordinance Amendment No. 02BCC000017 to accept grant funds and appropriate program spending.

The motion carried unanimously.

Emergency Management Report

County Manager Mike Ruffin said a report would be presented to the Commissioners at the November worksession concerning the status of the planning effort that has been ongoing for two years. Security measures would also be discussed.

Commissioner Heron expressed concern regarding the Office of Sheriff losing contact with all communications at some point. The deputies need to be in communication at all times.

Workforce Development Initiative

Chairman Black asked the Board to write a letter to the U.S. Department of Labor if an application is submitted in reference to the workforce development initiative. The letter would support a request for community funding to support the workforce development being done in Durham.

Adjournment

Chairman Black adjourned the meeting at 8:50 p.m.
